

JOHN GREEN'S LAND GRANTS

1. *John Green. Land Grant, 100 acres (arrival rights) 1681- Wapoose Creek, Charleston –0002 005 0038 0049 01. ****NOTE: This is an earlier J. Green. May have been an Uncle of John Green, a brother (or cousin) of William Green(I). William Green(I) was the father of John Green. William arrived in SC in 1691, and received his first land-grant for 100 acres on Bohicket Creek. He is listed as a blacksmith.**
2. *John Green had a warrant out of Secretary's office for 300 acres of land Dated the Seventeenth Day of September, 1696., p 560, Warrants for Lands in SC, 1672-1711, USC Press, 1973, Edited by A.S. Salley. **NOTE: An earlier J. Green**

6. *John Green, warrant, 300 acres, on Pon Pon River, Colleton Co., Jan. 8, 1708/09, p.644
7. **John Green** had a warrant for 200 acres of Land in Craven County this 23rd Day of March, 1709/10, P.657. **This is the original Land Grant on Black River, adjoining John Green's Creek. It is on the both sides of Hwy 701, just before crossing John Green's Creek. The site of the house is on the east side of the highway. Most of the property on the east side of the road is now called Peru Plantation.**
8. **John Green**, 200 acres, Craven Co., 24 Sept., 1709/10, p. 228.
9. Mr. John Green had a warrant for 25 acres, Berkeley Co., Jan 26, 1710, p.663.
NOTE: This is the older J. Green
10. **Mr. John Green** had a warrant for 500 acres of Land in Craven County the 18th Day of August, 1710, p. 659.
11. **John Green**, 200 acres, Craven Co., 28 June 1711, Records of the Registry of the Province, p206.
12. John Green, 400 acres, Berkeley Co., memorial, 1713 - 00182 02 **NOTE: older J. Green.**
13. **John Green**, memorial, 500 acres, Craven Co, July 01, 1718- 00235 07.
14. John Green, memorial, 500 acres, Craven Co., July 02, 1718 -00235 06. This tract became part of Mansfield Plantation.

15. **John Green**, Land Grant, 500 acres, east side of Black River, Craven Co., May 24, 1734- 0039 00310 00. *This tract was willed to Richard in 1750. Became Greenfield or Kiethfield Plantation.*
16. **John Green**, Land Grant, 140 acres, Craven Co., July 13, 1737- 01 00612 00. *This tract joins the original 200-acre tract, adjacent to the creek. Largely marsh that was cleared for rice fields.*
17. **John Green**, Land Grant, 300 acres, Craven Co., August 12, 1737, 02 00248 00.
18. **John Green**, Land Grant, 49 acres, Craven Co., July 05, 1740 -03 00482 00. *This tract joins the original 200 acres and is mostly marshland that was converted to rice fields.*

NOTE: #s 1-6 and # 12 are to an older John Green. He may have been an uncle or cousin of his Father This John came to Carolina in 1681. The land grant records clearly show there are two different John Green's.
