Enoch Grubbs, Jr. (b. Apr 1781, d. Bet. 1844 - 1845)

Enoch Grubbs, Jr. (son of *Enoch Grubbs*, *Sr.* and *Floried K. Burton*)⁶⁶ was born Apr 1781 in Fairfield District, South Carolina⁶⁶, and died Bet. 1844 - 1845 in Will probated Jan 30, 1845 Chester District, South Carolina⁶⁶. He married **Sarah Rhoda Parnell** on Bet. 1799 - 1800⁶⁷.

Notes for Enoch Grubbs, Jr.:

Mrs. John B. WIlliams genealogical papers state that

"They lived in the Chester District, South Carolina just a few miles from the Fairfield District line and attended the Beaver Creek Baptist Church.

Enoch Jr. owned property on Martin's Branch waters of Sandy River."

Typed and Photocopied paper in Pascha Bryant Franklin's Grade school report folder:

"Enoch Grubbs, Jr. appx 1783-Jan 1845 married Sarah Rhoda Parnell appx. 1785-Nov. 1855

Enoch Grubbs, Jr. had received 50 acres of the Richardson Track of land, two slaves and other items not mentioned by name in his father's will.

Enoch was the fifth child born to Enoch Grubbs, Sr. and his first wife and was probably born about 1783. He married Sarah Rhoda Parnell about 1800. They evidently lived in Chester District, S.C. for it was mentioned in a legal document that the will was read at Beaver Creek Baptist Church 'just a few miles over the line into Fairfield District.'

Enoch and Rhoda had 10 children. The birth and marriage dates may have been a bit earlier than I have estimated for Savilla was their 8th child, and she was born in 1808--otherwise, it would seem that the children came in rapid order.

It is presumed that Enoch Grubbs, Jr. died in January 1845 as his will was read on that January 30, 1845. It is usual to read wills of the deceased within a few days after the funeral. Rhoda (his widow) was named one of the Executors of the Will, but she refused to serve. It was necessary to appoint an administrator for his estate.

Later the legatees in the will agreed to allow the will to be set aside and the estate of Enoch Grubbs, Jr. was administered as though he had died intestate.

Petition for Partition was filed November 12, 1855. Since Rhoda Grubbs was not mentioned as an heir, it is certain that she had died and now her estate was being divided among the children.

Children:

William Grubbs, do not know whether he married or not.

Lucinda Caroline Grubbs who married John Beam

John Grubbs who predeceased his parents but left wife, Sarah who married Arthur Stacks. John Grubb's daughter had died. No other children.

Toliver Grubbs (who later moved to Alabama.)

Elizabeth Grubbs who married Richard Pannel.

Enoch Grubbs, III who married Betsey and had two daugthers Regina and Nancy

Thomas Grubbs, do not know whether he married.

Savilla Grubbs married to Charner Hopkins Wallis (sometimes shown Wallace)

Jennet (Jane) Grubbs who married William Reid

Levi Grubbs predeceased his parents leaving a widow named Betsey and 3 children Sarah Frances Grubbs Dye and John and Alfred Grubbs.

It is through Enoch Grubbs and Rhoda's daughter Savilla that we descend.

Enoch Grubbs Jr. and Rhoda Parnell Grubbs were great great great great grandparents of Judy Dumas Morris"

I assume this is another report of some kind probabby done by Judy Dumas Morris.
