Hall, and the issue of her present marriage, his successors and assigns, all her interest and estate, and also all her right and claim of dower, of, in or to all and singular the premises within mentioned and released. Hall and her issue by the present marriage, also of the County and State first aforesaid, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Daniel Hall as Trustee as aforesaid, all that plantation or tract of land [end page 2]

of which the said John Turner McCrorey deceased was seized and possessed at the time of his death, containing six hundred and ten acres more or less, situate on the North Fork of Wateree Creek in the County of Fairfield and State of South Carolina, and bounded by lands of General John Bratton, William T. Thorn, John F. Yongue, A.K. Beaty, of Estate of Musco Boulware, James Beaty and James A. McCrorey; Having such particular marks and shape as will appear by reference to a plat of resurvey executed by Joseph C. Caldwell, D.L. dated thirteenth day of September A.D. 1871; Together with all and singular the rights, members, hereditaments and appurtenances & the said premises belonging or in any wise incident or appertaining; To have and to hold all and singular the premises before mentioned, unto the said Daniel Hall, Trustee as aforesaid, his successors and assigns forever, in trust nevertheless for the sole and separate use of the said Sarah J. Hall during her natural life, and at her death, in trust to convey and deliver, discharged

of all trust, the said premises, to the issue of the marriage of the said Sarah J. Hall and the said Daniel Hall, as tenants in common share and share alike. And we do hereby bind ourselves, our heirs, executors and Administrators, to warrant and forever defend, all and singular, the said premises, unto the said Daniel Hall, as Trustee as aforesaid, his successors and assigns, against us and our heirs and all persons whomsoever lawfully claiming or to claim the same or any part thereof.
