(South Carolina) Whereas George Hallset in  
Fairfield District his life time and at the  
time of his death was legally seized and  
posse of a certain plantation or tract of land  
containing two hundred and forty four acres  
more or less one hundred and thirty seven  
of which was originally granted to Thomas Wells  
and the residue to the said George Hallset  
which said plantation or tract of land is situated  
lying and being in the District of Fairfield in the  
waters of Little River and hath such shape marks and  
boundaries represented by plat annexed to the original  
grant thereof reference being thereunto had well  
more fully appear and whereas the said George Hallset  
in the nineteenth of August 1816 the year  
of our said one thousand eight hundred  
and seven departed this life intestate  
leaving at the time of his death Benjamin  
Hallset Saban Hallset George Hallset  
John Hallset Sarah Hallset who hath  
intermarried with Francis Lewis  
Andrew Hallset who hath intermarried  
with Thomas Alexander Mary Hallset  
and intermarried with Nicholas Lewis  
Alexander Hallset who hath

William Lockwood Elizabeth Haller who hath  
 intermarried with Francis Land, Darius Haller  
 who hath intermarried with Thomas ~~Williams~~<sup>Williams</sup>  
 Mary Haller who hath intermarried with  
 Thomas Lockwood Maffey Haller who hath  
 intermarried Andrew Pleasant and Rachel  
 Haller children and heirs of the said George  
 Haller deceased tenants in common of the said  
 plantation or tract of Land, and whereas  
 the said George Haller John Haller, William  
 Lockwood and Wife have by deed bearing  
 the day of December 1817 conveyed  
 their undivided shares to the said Fabian Haller  
 of the said plantation or tract of Land  
 and whereas Samuel H. Taylor of the District  
 and State aforesaid Merchant hath paid to us  
 the sum of 700 dollars for the said plantation  
 or tract of Land now known as that we the  
 said Benjamin Haller La ben Haller Francis  
 Land and wife Thomas Williams Wife Thomas  
 Lockwood and wife Andrew Pleasant and wife  
 and Rachel Haller for and in consideration  
 of the said sum of seven hundred dollars to  
 us paid by the said Samuel H. Taylor as  
 aforesaid have granted bargained sold and  
 released and by these presents do grant bargain  
 sell and release unto the said S. H. Taylor  
 the plantation or tract of Land aforesaid  
 and described according to our common rights  
 estates and interests therein. Together with  
 all, and singular the rights member here-  
 of and appurtenances to the said

premises belonging or in any wise incident  
 or appertaining. So have and to hold all  
 and singular the said premises to the said  
 Samuel H. Taylor his heirs and assigns for  
 ever. and we do hereby warrant and forever  
 defend all singular the said premises to the  
 said Samuel H. Taylor his heirs and assigns  
 against us and our heirs and against all  
 other persons whomsoever lawfully claiming  
 or to claim the same or any part thereof.

 for the uses and purposes therein mentioned and  
 that he saw George Head subscribe his name  
 as a witness with him self to the same.

Sworn to and subscribed August the 10<sup>th</sup> 1818  
 James Cannon De. Thomas Taylor  
 recorded the 10<sup>th</sup> August 1818
