with lawful interest for the same have bargained & sold & by these presents do bargain & sell in
plain & open market deliver unto the said Caroline L. the following named negroes which I have
this day purchased of her, & for which the aforesaid bond was given, that is a Negro man Abram
a Carpenter, to have & to hold the said negro slaves unto the said Caroline L. her Executors Adm-
-istrators & assigns forever, provided always nevertheless that if the said David his Executors
or administrators shall & do well & truly pay or cause to be paid unto the said Caroline L.
her certain attorney executors administrators or assigns the full & Just sum above mentioned
with interest according to the true intent & meaning of the Bond aforesaid & of these presents
then this deed of Bargain & sale, & all & every clause article & thing therein contained shall

plain & open market deliver unto the said Caroline L. the following named negroes which I have
this day purchased of her, & for which the aforesaid bond was given, that is a Negro man Abram
a Carpenter, to have & to hold the said negro slaves unto the said Caroline L. her Executors Adm-
-inistrators & assigns forever, provided always nevertheless that if the said David his Executors
or administrators shall & do well & truly pay or cause to be paid unto the said Caroline L.
his certain attorney executors administrators or assigns the full & Just sum above mentioned
with interest according to the true intent & meaning of the Bond aforesaid & of these presents
then this deed of Bargain & Sale, & all & every Clause article & thing therein contained shall
be void & of none effect, any thing herein before contained to the contrary
thereof in any wise notwithstanding - And it is hereby declared by & between the said parties
& the said David for his executors administrators & assigns does covenant promise & agree to
& with the said Caroline L. her executors administrators & assigns by these presents that if
default shall happen to be made of or in payment of the said sum above mentioned &
interest according to the true intent & meaning of the said bond that then & in such case
it shall & may be lawfull to & for the said Caroline L. her Executors administrators assigns
attornies or agents from time to time & at any times hereafter peaceably & quietly
to enter into any or all the Messuages lands or Tenements of the said David & to take

the negroes of onesaid into her custody & possession & the same to hold & to detain to her own use
& behoof (as her own proper goods & chattels) from thence forth & forever or the same to sell and
dispose of at her will & pleasure returning the overplus if any should happen to be after
paying the sum above mentioned, & interest & costs of sale unto the said David his executor
& administrators or assigns. In witness whereof I the said David have hereunto set my

hundred & thirty six & in the sixtieth year of the Independence of the United States of America
