Jesse Havis - General Winn wrote a letter to the Mount Zion Society. The following is part of the answer to General Winn's letter. "The Society cannot pursue the intention of the Institution as far as relates to the support of a College in the country..." But the Society would be glad to accept the men of Winnsboro as members. As to the request of Mr. Means that some persons might be names to take care of the College and Lands of the Society. We appoint you (General Winn) and Mr. Means to do so. Jesse Havis first appears in a list of "Country Members Accounts." On May 27, 1808, Jesse Havis' quarterly "contribution" was \$1.70. Jesse Havis' name appears in successive account lists.
