Richard Winn and was in the battle at Stono Ferry. From sometime in July 1781 until the last of December 1781, with the exception of either May or June, he served under Capt. Thomas Parrott and Col. Thomas Taylor. (Moved to Ill.)

b. 5 March 1754, County Monaghan, Ireland  
d. 7 July 1834

m. Mrs. Mary McClary, 3 June 1783  
While residing on the Broad River in South Carolina, he enlisted on 1 November 1776 to serve under Capt. Robert Hancock and Cols. Richardson and John Winn. He was in the skirmishes at Ninety Six and Lindley's Fort. In 1778, he was under Capt. John Pearson and Col. Winn and was in the battle at Stono Ferry. He lost two horses on an expedition under Gen. Henderson during 1779. On 1 May 1780, he enlisted under Capt. John Robinson and Col. Taylor and remained in service until the evacuation of Charleston. During 1781, he served under Lt. Samuel Littlejohn, a Capt. Gray and Gen. Greene and was in the battles at Congaree Fort, Orangeburg and the siege of Ninety Six. (Moved to Ga., Ky., and Ill.) A.A.3452; S251.

Hawthorn, Samuel  
He served in the militia during 1782. A.A. 3437; P395.

Hawthorne, James  
He assisted Robert Ellis in guarding Col. Reed's mill in Abbeville District. (Ellis, Robert, S26084).

Hayes, Jesse

He was in the battles at Stono, on a campaign against the Indians and at the siege of Savannah. He was in the battles at Hanging Rock Mill and Kings Mountain. He was commander after Williams's death at Kings Mountain and served in the battles at Hanging Rock and Hammond's Store. On 19 November 1781, he was with 'Bloody Bill' Cunningham at Hanging Rock. Hawthorn, James

He settled on the frontier of South Carolina  
and was captured by Indians along with his  
mother and two sisters about 1762. After  
being released, he became a blacksmith in York  
County. He was with Col. Thomas Neel, his  
father-in-law, on the Snow Campaign in 1775.  
Thereafter, he was with Williamson on the  
Cherokee Campaign in 1776. During 1777, he  
became a first lieutenant in the Sixth Regi-  
ment. On 22 February 1778, he was a captain  
and was on the Florida Expedition. He served  
as an adjutant, major and lieutenant colonel.  
From 15 September 1778 to 23 March 1779,  
he served as a trainer of the militia for Col.  
Neel in the New Acquisition District. He served  
under Sumter and was in the battles at Rocky  
Mount, Hanging Rock, Carey's Fort and  
Fishing Creek. In the battle at Kings Moun-  
tain, he was in charge of Hill's troop. He was  
in the battle at Fish Dam Ford, Blackstock's  
Plantation and was wounded at Camden on  
25 April 1781. In addition, he was wounded  
at Cowpens. (Moved to Ky.) Heitman, p. 281;

Hawthorn, John S31097  
b. January 1748, County Monaghan, Ireland  
He emigrated to America during 1767 and  
settled in Fairfield County. In June 1778, he  
served under Capt. Robert Hancock. From  
February 1779, he was under Capt. John Pear-  
son and Col. Kirkland and was in the battle at  
Stono. Beginning in April 1780, he was under  
Capt. Thomas Woodward and Colonel Wade  
Hampton and from March 1781 he was under  
Capt. John Woodward and Col. Wade Hamp-  
ton. (Moved to Ga., Tenn., and Ky.)

Hawthorn, Joseph R4774  
b. 10 July 1756, County Monaghan, Ireland

Louvina Gilstrap gdn. of D. D. Hawthorne, R. R. Smith, L. N. Hawthorne minors under 21 years. Paid on 7 Feb. 1879 for land for Bell Smith formerly Hawthorne \$75.00.

Robert Hawthorne. Estate of Robert Hawthorne. Pack 78 In Equity. Clerk of Court Office. Pickens Co., S. C. Whereas Moses Cain, William Hardin, John Baylis Myers and H. A. Cole assignee of William Hardon as follows. Robert Hawthorne on the 14 Feb. 1859 sold to the above a tract of land in Pickens Co. which formerly belonged to the estate of Josiah F. Perry decd. The tract of land lies on the branches of Snow Creek, waters of Conneross Creek, waters of Seneca River. Robert A. Hawthorne and Thomas D. Long made and executed their bond at the same date for two thousand dollars to the above named. To Moses Cain 91 acres. To John B. Myers 96 acres. To William Hardin 92 acres. Wm. Hardin sold and transferred his land to H. A. Cole of Pickens Dist. Robert A. Hawthorne soon after the execution of the bond entered the Army of Confederate of America and was killed in the battle around Richmond whilst gallantly charging at the head of the Company of infantry which he commanded. After his death E. P. Verner Esq. took out letter of admr. upon his est. Capt. R. A. Hawthorne died leaving a widow Mrs. Emma Hawthorne and one infant child Ida Hawthorne. Filed 3 May 1864.

Joseph J. and Anna Hawthorne. Estate of Joseph J. and Anna Hawthorne. Pack 178 Clerk of Court Office. Abbeville Dist., S. C. This deed of trust made 4 Sept. 1845. Between Joseph J. and Anny Hawthorne of one part and John R. Wilson and Robert Ellis trustee of the second part and Andrew Prewit and Polly his wife and Alexander A. Miller and Elizabeth his wife, and William Martin and Susan his wife, and Toliver Johnson and Jane his wife, Orpha Hawthorne, Jasper Hawthorne, Deborah Hawthorne, and Constantia Hawthorne of the third part. Anna Hawthorne had a life estate of her and her chn. from her father the late Isaac Cowan will. "I give and bequeath unto my daughter Anny Hawthorne, Franky and three chn. viz. Susan, Thomas and Bethany and to remain hers for life and at her death to be equally divided between her heirs." The slaves has been sold in the amount of \$3,695.00. and has been secured in the hands of one Alexander A. Miller. Wit: James Cowan, D. O. Hawthorne. This deed signed by Joseph J. and Anna Hawthorne, John R. Wilson, Robert Ellis, Andrew and Mary J. Prewit, A. H. and Elizabeth Miller, William Martin, Toliver and Jane S. Johnson, James F. and Amryles E. Crawford. Seals.

Anna Hawthorne. Estate of Anna Hawthorne. Plat Book C, page 2. Clerk of Court Office. Pickens, S. C. By request of Hardy Gilstrap and by consent of David Gilstrap, I have surveyed a tract of land in Pickens Co. on Rices Creek waters of 12 mile River. Containing 62 acres. Dated 20 Nov. 1873. J. B. Clayton, Surveyor. The above tract of land belongs to the estate of Anna Hawthorne never having been executed by order of C. L. Hollingworth. Dated 1 Dec. 1874.
