207-Year-Old House Has Interesting Past

Imagine if you can, the sense of history one must have living in a house that is over two hundred years old, and which has reverberated with the sound of many footsteps down through the years, including those of three year-old Alston Wilkes of Alston Wilkes Society fame.

Museum curator Bill Taylor and this reporter visited Mrs. Mildred Brown on Thursday at the historic Hawthorne-Brown house, located in the Union Community of Fairfield. The family of Mildred's late husband, Bob Brown, has owned the house since 1877, and Mildred has lived there for forty years, since she came to the house as a young bride.

The house is doubly interesting, because it combines the original log land bounty cabin with barracks from the old Furman Institute. Records reveal that the land on which it stands, in the amount of 100 acres, was deeded by land grant to James H. Adams in January of 1770, by the Governor-in-chief of this province, Greville Montague. Later, Adams deeded the land and cabin, which was built around 1771, to James Hawthorne for the princely sum of fifty dollars.

The original structure boasted of one large room with a huge fireplace and a smaller room, plus a sleeping loft overhead. In 1851, when nearby Furman Institute was moved to new quarters in Greenville, the Hawthorne family moved one of the student barracks to their property and attached it to the cabin. In intervening years, the Brown family added on two more rooms. Sometimes during the years, siding boards were put up on the outside of the house, covering the huge old logs.

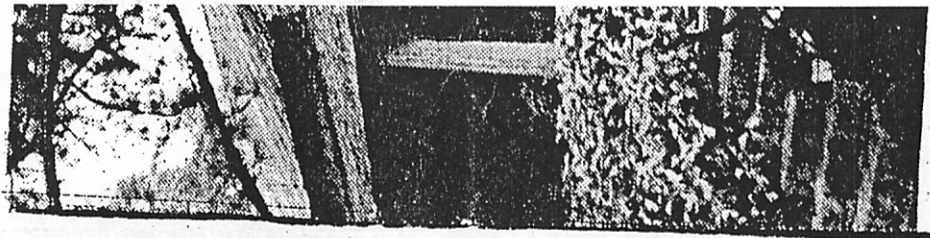
Not much is known of the history of the house prior to 1851; however, thanks to a book written by Eli Alston Wilkes in 1910, some of the trials of the Wilkes family during the Civil War are revealed. The book was printed by the R. L. Bryan Company, and the nine copies given to family members. Unfortunately,

Mildred does not own a copy of the book, which is entitled "Echoes and Etchings".

Mrs. Elizabeth Hawthorne Wilkes, daughter of the Hawthornes who inhabited the house in the mid 1800's, lost her husband in 1863, just after the battle of Gettysburg. 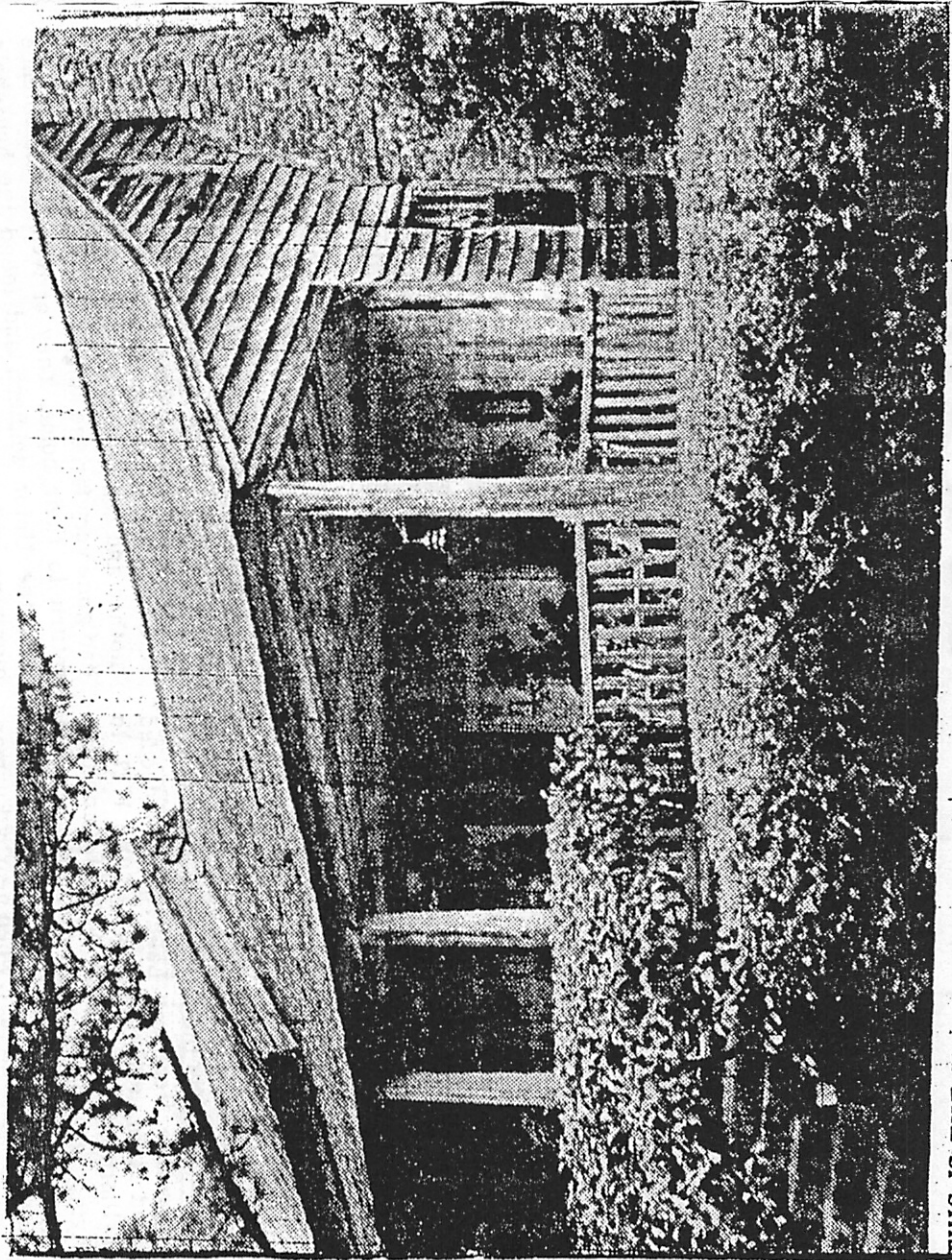

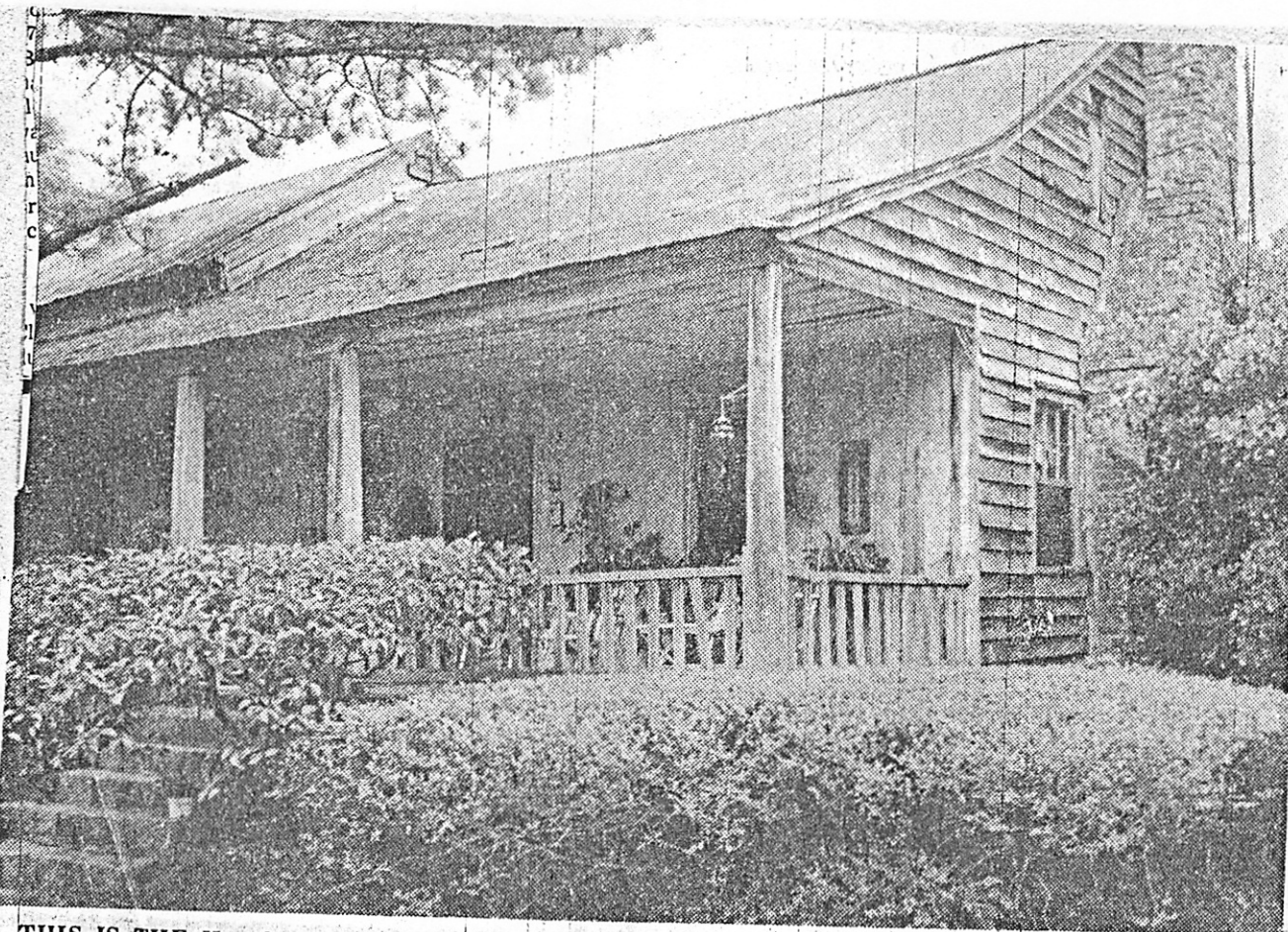

cept his father's watch. Even "Old Rob" was taken by the enemy. At one point, the house was in danger of being burned; indeed, soldiers had built a fire in the middle of what is now the living room floor Mrs. Wilkes, a faithful Masonic daughter, ran outside, where she gave the Masonic sign of distress. An officer leaped on horseback nearby recognized the sign and had the fire put out, thereby saving the house.

After their food had been eaten, or carried off by the soldiers, the Wilkes and Hawthornes were hard put to find food until crops could be harvested that summer. Alston Wilkes recalls that "coffee" was made from parched corn.

The story does have a happy ending, though. In 1866, standing before the mantel in her parents' home, Elizabeth Hawthorne Wilkes was married to Colonel Richard Wood of Chester, and although he was thirty years her senior, their marriage seems to have been a happy one.

TODAY

Today, of course, the only place one may see the logs of the original cabin is in the staircase leading to the sleeping loft, and in the loft itself. However, the ceiling still holds four large nails, put there long ago to support a spinning wheel which Mildred found in the loft. She says her husband remembered seeing his grandmother using the spinning wheel. The huge old fireplace, where James Adams no doubt prepared his meals in the 1700's, and which Mildred remembers as being in use when she first came to the house, has been boarded up, but the chimney still stands as it has for two centuries.

Mildred says she has thought of building a more modern dwelling place, but just hasn't been able to leave this comfortable old house where so many have lived their lives through two centuries. She and her son, Bobby, live there alone - except for Bobby's stuffed creatures, who are everywhere.

A talented taxidermist and an ardent hunter, Bobby has stuffed deer heads, pheasant, fish and turkeys.

A History of Fairfield

The HAWTHORNES, of Scottish parentage, came from the northern part of Ireland to South Carolina and settled in Fairfield county prior to the Revolution in which they took an active part. The records show several who were Revolutionary soldiers.

John and Adam Hawthorne settled near the "Old Brick Church" in Fairfield. Rev. C. E. McDonald, of Winnsboro, wrote an interesting and instructive piece on the centennial of this A. R. P. church. In it will be found the names of some of the first settlers of Fairfield, whose lives have been woven into the making of this county.

John and Adam Hawthorne were elders in this church prior to 1791. Adam Hawthorne (born 1739, died 1810) first married the widow McMeekin (born 1741, died 1790) before 1776. By this marriage there was one son and three daughters. The son, Adam, Junior (born 1778, died 11-5-1827) married Miss Ann Holmes, sister of Rev. Janes and William Holmes. They are buried at the old Brick Church. The three daughters married Dawkins, McMeekin and Gladney, all Fairfield names.

After the death of his first wife, the widow McMeekin, which occurred 1790, Adam married Miss Elizabeth (Betsy) Bradford (born 1756, died 1850, married 1782), daughter of Charles Daniel (Darrell) Bradford and his wife Miss Mary Lemmon (born 1735, died 1813, married 1751) of Maryland. By this second marriage there were three children: Robert married Priscella Gibson, a granddaughter of Stephen Gibson, the Huguenot preacher. The two daughters were Lucy and Mary. The latter married Yarborough,

another well known name in Fairfield county.

The son, Robert Hawthorne (born 1810, died 1874) and his wife, Priscella Gibson (born 1813, died 1893, married 1831). Both are buried at Bethel Methodist church in Fairfield county. The above named Robert Hawthorne and his wife Priscella Gibson had the following children:

James G. Hawthorne married Sue Foster, Greenville, S. C.

Robert Hawthorne married Emma Perry, Greenville, S. C.

Madison never married.

Mattie married William Turner McCrorey, Fairfield, S. C.

Nannie married Harper Carter, Chester, S. C., first, and W. G. Austin, Union, S. C., second.

Alice married Thorn Wood, first, Wade Hampton Banks, Chester, S. C., second.

Lou married first Ell Wilkes, second, Col. Richard Woods, signer of the secession convention from Chester, S. C.

Of the three above named sons, James and Robert Hawthorne were captains in the Confederate War. Madison was sergeant, leaving the South Carolina College at 17 years old to enter. Captain Robert and Sergeant Madison were both killed.

One of the family in "King's Mountain and Its Heroes" was "James Hawthorne born in Armagh County, Ireland about 1750, whose father and family early migrated to the frontiers of South Carolina where the mother, two daughters and her young son, then about twelve years of age, were captured by the Indians. The mother and girls were killed. James Hawthorne learned the blacksmith trade in York county, S. C., where he married Mary, daughter of Colonel Thomas Neel. He took an active part in the Revolution, serving in Neel's regiment on the Snow campaign in 1775, on Williamson's Indian expedition in 1776, and as captain on the Florida campaign 1778-79. He served under Sumter at Rocky Mountain, Hanging Rock, Carey's Ford and Fishing Creek. As Col.

onel Hill was unable to lead at Kings Mountain, it devolved on Lieutenant Colonel Hawthorne to do so. He was subsequently at Fish Dam ford and at Blackstock, Fairfield county and was wounded on Sumter's rounds in February, 1781, and received a second wound during the course of the war. In after years he migrated to Livingston county, Kentucky, where he lost a fine property (being on the bond of a defaulting sheriff) and where he died the latter part of 1809 about 59 years old. He left several children."

The Hawthornes lived near what was called the old Institution, Fairfield county. Their family connections were Bradfords, Winns and Gibsons, who lived near the Kincaid's bridge over Little River. Mr. McCrorey (Mattie Hawthorne) remembered hearing her grandmother, Mrs. Bradford, and Mrs. Winn tell how they would have to leave their homes at night and hide out from the Tories.

BRADFORD — Charles Daniel (Darrell) Bradford was a nephew of Charles Daniel (Darrell) Carroll of Carrollton, Maryland, who was one of the signers of the Declaration of Independence and the constitution of the United States. Charles Bradford was named for his uncle, Charles Darrell Carroll of Carrollton. He was also reared and educated by this uncle. His education stood him well when he came to Fairfield, S. C., as he was a professor in the Monticello academy. Bradford was born about 1730 and his wife, Mary Lemmon, was born 1731.

They came into South Carolina prior to the Revolution and he with three sons fought in the Revolutionary War. One of his sons, John, or Jack, as he was called, was imprisoned in Charleston. Confinement there was so irksome that Jack pinched himself so severely that the jailer mistook it for smallpox and sent him to the detention camp, from which he escaped and returned to the army. At the death of Charles Darrell Bradford's daughter (Betsy Bradford Hawthorne in 1850) the *Fairfield Herald* printed the notice of her death between heavy black lines (then a custom) and paid marked tribute to the bravery of her father, Charles Bradford, and her three brothers.

Robert Hawthorne. Estate of Robert Hawthorne. Pack 78 In Equity. Clerk of Court Office. Pickens Co., S. C. Whereas Moses Cain, William Hardin, John Baylis Myers and H. A. Cole assignee of William Hardon as follows. Robert Hawthorne on the 14 Feb. 1859 sold to the above a tract of land in Pickens Co. which formerly belonged to the estate of Josiah F. Perry decd. The tract of land lies on the branches of Snow Creek, waters of Conneross Creek, waters of Seneca River. Robert A. Hawthorne and Thomas D. Long made and executed their bond at the same date for two thousand dollars to the above named. To Moses Cain 91 acres. To John B. Myers 96 acres. To William Hardin 92 acres. Wm. Hardin sold and transferred his land to H. A. Cole of Pickens Dist. Robert A. Hawthorne soon after the execution of the bond entered the Army of Confederate of America and was killed in the battle around Richmond whilst gallantly charging at the head of the Company of infantry which he commanded. After his death E. P. Verner Esq. took out letter of admr. upon his est. Capt. R. A. Hawthorne died leaving a widow Mrs. Emma Hawthorne and one infant child Ida Hawthorne. Filed 5 May 1864.

Joseph J. and Anna Hawthorne. Estate of Joseph J. and Anna Hawthorne. Pack 178 Clerk of Court Office. Abbeville Dist., S. C. This deed of trust made 4 Sept. 1845. Between Joseph J. and Anny Hawthorne of one part and John R. Wilson and Robert Ellis trustee of the second part and Andrew Prewit and Polly his wife and Alexander A. Miller and Elizabeth his wife, and William Martin and Susan his wife, and Toliver Johnson and Jane his wife, Orpha Hawthorne, Jasper Hawthorne, Deborah Hawthorne, and Constantia Hawthorne of the third part. Anna Hawthorne had a life estate of her and her chn. from her father the late Isaac Cowan will. "I give and bequeath unto my daughter Anny Hawthorne, Franky and three chn. viz. Susan, Thomas and Bethany and to remain hers for life and at her death to be equally divided between her heirs." The slaves has been sold in the amount of \$3,695.00. and has been secured in the hands of one Alexander A. Miller. Wit: James Cowan, D. O. Hawthorne. This deed signed by Joseph J. and Anna Hawthorne, John R. Wilson, Robert Ellis, Andrew and Mary J. Prewit, A. H. and Elizabeth Miller, William Martin, Toliver and Jane S. Johnson, James F. and Amryles E. Crawford. Seals.

Anna Hawthorne. Estate of Anna Hawthorne. Plat Book C, page 2. Clerk of Court Office. Pickens, S. C. By request of Hardy Gilstrap and by consent of David Gilstrap, I have surveyed a tract of land in Pickens Co. on Rices Creek waters of 12 mile River. Containing 62 acres. Dated 20 Nov. 1873. J. B. Clayton, Surveyor. The above tract of land belongs to the estate of Anna Hawthorne never having been executed by order of C. L. Hollingworth. Dated 1 Dec. 1874.

80. Davis Plantation Home — built after the Revolution by Dr. Jonathan Davis who was responsible for Jefferson-Monticello Academy and Furman Institute being established in Fairfield. The first Brahman cattle were brought to the United States by Dr. Davis on his return from Turkey where he had served as Minister of Agriculture. Home is now owned by the Ross Robinsons.
81. White Hall African Methodist Episcopal Church — Manton Latta Martin and his two brothers, Jerry and John, started the movement in 1866 to build a church. Moses Martin donated the land and in 1867 the first Negro church in Fairfield County was built, with Rev. Manton Latta Martin as its pastor.
82. Parr Shoals — power plants run by water, coal and atomic energy have operated here at the site of the old Parr grist mill.
83. Chappell Place — built in 1795 by Daniel Ruff, the great-great grandfather of the present owner, Mrs. Douglas Chappell.
84. Mayfair — designed and built by Colonel William Alston in 1824 and presented to his daughter, Mrs. Burrell Cook, as a wedding present. Thomas Chappell purchased the house in 1883. Bought recently by S. C. McMeekin of Columbia.
85. Shiloh Methodist Church — first built before 1835. Present church built 1902.
86. Fair View — built by the Thompson family circle 1800. In 1830 Dr. John Milton Glenn became the owner. Present owner is Mrs. L. K. Martin.
87. High Point — This property was granted to William Thompson in 1773 by King George III. The house was built in 1800. The name is derived from the fact that it stands on the highest point on the ridge between Columbia and Spartanburg. The property was deeded to H. A. Glenn, a son-in-law, in 1845 and still remains in the Glenn family.
88. Little River Baptist Church — originally organized as Gibson's Meeting House in 1768 by Rev. Jacob Gibson. Later became Little River Church. Present building erected in 1845. The same builder later designed and built the Monticello Methodist Church.
89. Holley Place — owned by John C. O'Neal prior to 1860. In 1868 P. M. B. Holley acquired it. It was later bought by Robert Martin, a Fairfield Negro who ran the first dray business in Columbia. His descendents own the house now.
90. Ebenezer Associate Reformed Presbyterian Church — known as the Old Brick Church.
99. Bethel Methodist Church — In 1793 the first Methodist group ever to assemble in Fairfield met in Bethesda-Auf-der Morvan (Rev. Nicholas Martin's Meeting House on Crooked Run Creek). In 1798 they built the county's first Methodist Church on Brown's Bridge Road. This congregation merged with Horeb Methodists in 1840 to form Bethel. This is the third sanctuary.
100. Thomas C. Camak Home — Home of three distinguished writers — Thomas Charles Camak (columnist known as "Mossy Dale"), and his two sons — Marion Boyd Camak (poet and educator) and Dr. David English Camak (novelist and founder of Spartanburg Junior College.) House was built by a Hendrix in 1824.
101. Brown-Rexrode House — built c. 1840 by George Brown on property which was granted by the king in 1771 to Samuel Porcher. House now owned by descendents of George Brown.
102. Hawthorne-Brown House — Land Bounty cabin built around 1771 by Adam Hawthorne. Addition on back was made in 1851 when Furman University was moved and a building was torn down and part of it added to the log house. Sherman's soldiers started a fire in the middle of the living room in February 1865, but an officer had it extinguished when the Mason's sign of distress was given by Mrs. Elizabeth Hawthorne Wilkes. The house has been owned by the Robert Brown family since 1877.
103. Warren Castles House — Built in 1830 by George Leitner. Later owned by the Rabbs and Castles families.
104. Old Furman Building — From 1837 to 1851 Furman Institute was located here. This building was the administration building with classrooms and a chapel. Across the road is the faculty residence hall. The School of Theology flourished here. In 1851 the school was moved to Greenville.
105. Fairfield Baptist Church — organized by Rev. Jonathan Davis in 1820. Old church burned in 1865. Present church erected 1903.
106. The Oaks — Built around 1850. Home of John Montgomery Lemmon and his descendents.
107. The Bob Lemmon Place — probably built by the Owens family, early settlers of the county. R. Y. Lemmon and his family acquired the place in 1870. Now owned by the Gordon Quattlebaums. *now The Lurch*
108. Kelly Miller School — named for noted educator, Dr. Kelly Miller, Dean of Howard University, Washington, D. C.
109. Greenbrier Methodist Church —
110. William Estes Home — formerly the Thomas W. Ruff home — about 100 years old

(b. 1777 and 1787) were elders of this church and their children were baptized
by Dr. James Rogers, pastor, who died 1830. This church is in Fairfield
County, South Carolina.

Adam Hawthorn and wife, Ann Holmes are both buried in marked graves in the yard
of the Old Brick Church.
