Mrs. Eleanor Hayward, May 6, 1844, from Wake Co. N. C. declares that she is the dau. of Col. Philemon Hawkins, decd., late of Warren Co. N. C. He was a Rev. officer & served 2½ yrs. in the N. C. Militia. He was called into service while actg. as Lieut. Col. of Bute Co., winter of 1775 & '76; served & was marched to Wilmington. In spg. of 1776 he served for 3 mos. in an expedition, was actively employed as a Commissary the remainder of the yr. as his comn. as Col. of the County had expired. In 1778 he was Capt. of Inf. for 3 or 6 mos. In 1779 he served 6 mos. as Col. of Cav. & in 1780 & 1781 he similarly served as Capt. of Cav. in the Militia. Col. Philemon Hawkins d in Warren Co. N. C. Jan. 27, 1833 in his 80th yr.

Mrs. Eleanor Hayward, or Haywood, one of the heirs of Capt. Phil-

emon Hawkins, is mother-in-law of Judge Badger.

John D. Hawkins, Henderson, June 24, 1851 writes & mentions his sister Mrs. Elenor Haywood as the "oldest of the family," etc. (No further family data).

This soldier applied for pension Mch. 4, 1834, from White Co. III. & declared that he was b July 10, 1756 in Monoghan Co. Ireland; that he volunteered while a resident of Fairfield Co. S. C. & served for 3 mos. from the spring of 1779 under Capt. John Pearson, Lieut. Job Owens, Col. Wynn; was in battle of Stono Ferry.

July, 1781 he volunteered under Capt. Thomas Parrot, Lieut. Sam Proctor, Lieut. Col. Joe Kirkland, Col. Thos. Taylor's Regt.; was on fur-

lough 1 mo., May-June, 1782 & was discharged Dec. 1782.

After the Rev. War he lived in Fairfield Co. S. C. for 10 yrs., then moved to Albert Co. Ga. for 17 yrs., then moved to White Co. Ill., where he d Oct. 30, 1849.

Robert Hawthorn, Mch. 4, 1834, declares that he served for 3 mos. in 1779 with Joseph Hawthorn under Capt. John Pearson, Col. Wynn, etc.
