ABRAHAM WOODWARD was witness to the will of John Guther,
signed 4 May 1739...No other time does Abraham Woodward show
in the Index to any of the 8-Vols.

Same four children....The widow, Jane Perry was now the wife of WILLIAM WOODWARD.

NOTE BY ROBERT HILL Sr: Andrea was obviously trying to follow up on the stories that were (wrongly) circulated that Thomas Woodward (son of Abraham) and who married the widow Margaret Waters Ijams were the parents of Thomas (Regulator) Woodward...which we now know was not the case.

94 ANN ARUNDEL COUNTY MARYLAND.

JOHN WATTORS...Will signed 27 November 1703, probated 13 June 1704...Wife was Elizabeth Wattors...Children and all minors:

Some indications that the daughter, Margaret wed a Mr. Ijous.

Several of the Waters state to rear children as Catholics but James is first to disinherit them if they turn

Protestant.

101-b

I checked this to find the Margaret Waters, who was mother of Thomas Woodward, The Regulator of Fairfield County, S.C.

NOTE BY ROBERT HILL Sr: I knew in my mind that was what Andrea was searching for BUT SHE WAS NOT HIS MOTHER....The story that was widely accepted was that she was the FIRST WIFE of the Regulator's Father, THOMAS WOODWARD, who did marry Margaret (Waters) Izams (Ijams)...BUT THIS TOO IS AN ERROR...THAT THOMAS WAS BORN, MARRIED, & DIED WAY TOO LATE TO HAVE BEEN FATHER OF REGULATOR.

102 FAIRFIELD COUNTY S.C.

On the road from Ridgeway to Winnsboro, I stopped at an Old WOODWARD graveyard...It is surrounded by a large rock wall. Vandals have removed and broken many stones...I copied all that were legible except I did not copy the several GADSDEN grave stones in this cemetery.

WILLIAM WOODWARD/ 7 April 1792/ 15 Aug. 1842
HARRIET/ wife of/ William Woodward/ Died 12 May 1857/ aged 50 years...(See # 84 as nee Harriet Smart.

THOMAS WOODWARD/ THE REGULATOR/ Killed by British & Tories/
12 May 1779....This is a handsome upright marker.

JOHN WOODWARD DURHAM /Died 20 Jan. 1858/ In his 51st Year.
Two other built up rock tombs...Vandals have removed the top stones with inscriptions...Likely Osmund & wife Martha.
Next to these are five similar tombs...One of the marker has been stolen....two not legible...Two I deciphered.

JOHN OSMOND (WOODWARD)/ Son of O. & M. WOODWARD/ Died 7 Jan 1825 Aged 3 years, 6 mos. & 5 days.
WILLIAM STROTHER (WOODWARD)/ Son of O. & M. WOODWARD/ Died 16 Oct. 1825/ Aged 5 mos. & 10 days.

The other two with stones were also children of Osmond & Martha Woodward...One other in this row had stone stolen. Graves by Thomas Woodward, The Regulator, and if these ever had any stones, they have been taken or destroyed by vandals...I imagine some of these graves were wife or wives. In next row and not in line with children of Osmond & Martha are two rock tombs of grown persons...Marble tops have been turned upside down by vandals...I was unable to lift these to return and read the inscriptions. Several marked graves but all of GADSDENS...They may have been related to Woodward...Many Gadsden stones are much later.

The number at top are File Numbers if an estate or an Equity or if as B-31 indicates (DEED BOOK B, Page 31).

I went over the old MT. ZION PRESBYTERIAN CEMETERY and found no Woodward markers there in Winnsboro...I went to the old Baptist Cemetery and found one which has a Woodward in the middle name..

WILLIAM WOODWARD WILLINGHAM/ 30 Mar. 1818/20 Mar. 1874

102-b

The old Woodward Baptist Church along the Fairfield-Chester County Line had no Woodward...One grave stone had middle name as John Woodward Durham/ 20 July 1839/ 29 Sept. 1881

Mary Wagner Mobley/ 27 Aug. 1842/ 21 Jan. 1904

Elizabeth/ Wife of Jones Taylor/ Died 7 Mar. 1839/ Age 26.

At Winnsboro it began to rain and we could not visit the old Associate Reform Presbyterian...The Methodist.. or the Episcopal cemeteries to try to locate Woodward grave stones.

NOTE BY ROBERT HILL Sr: The grave of Nancy Elizabeth Barrett, who was the wife of Reverend William Woodward, son of the Regulator, is located in the ASHFORD CEMETERY near Winnsboro, in Fairfield Co., S.C. The marker reads:

"Sacred to the memory of Nancy Woodward, relict of the late Reverend William Woodward, who departed this life August 10th, 1829, Age 62 years. (born 1767). (Note by Robert Hill: This was my 4th great grandmother).

IN THE OLD WOODWARD GRAVEYARD, NEAR LITTLE RIVER (EAST FORK) in Avon Section of (today's) FAIRFIELD COUNTY....are the following graves...

"Sacred to the Memory of NANCY WOODWARD, who died August 21, 1831 in the 21st year of her age." (Broken down vault). (Her birth ca. 1810).

"Sacred to the Memory of GEORGE WOODWARD, who departed this life September 26, 1811, in the 35th year of his age." (Born 1776).

His wife Elizabeth Woodward, who died December 16, 1830, in the 53rd year of her age." (born 1777). Both of these inscription were on one slab of a vault, which was broken up.

This George Woodward may be part of the family of # 57.

103 (FAIRFIELD CO.) 35-577 (BOOK 35, PAGE 577)See # 54

JOHN WOODWARD will was proved 24 March 1824...Many of the children were minors...The Estate was appraised by James

McCravey..Silas Gladden, Elijah Gayden...In the WPA will in # 54, I left out one child: Esther or Easter WOODWARD.

There is a large sale list and many buyers by name of Woodward and of Strother and Williamson...The wife was a daughter of Roling Williamson # 83 as shown by his estate...Never in any dower did this John Woodward ever have a wife named PATSY...I think the Patesy Axham in # 4 is an error as wife of this man...Also in the Roling Williamson file, Osmond Woodward, brother of this John, wed a sister Ailey Williamson...Her name was Martha Williamson...I can examine this estate further if needed. (This was part of the Regluator's family).

104 EQUITY 1817-4 ?

BURBAGE WOODWARD (See # 18-e) VS. James Davis...Filed 20 Nov. 1807....JOHN WOODWARD died in 1797 and he is the father of your petitioner, Burbage Woodward...His father John Woodward in his life time bought a plantation of land from Edmund Watts (Once as Edward Watts) and lived there and was living there when he died in 1797, and at the death of John Woodward, the land passed to his son, Burbage Woodward. James Davis claims this land was deeded to him and therefore claims the land...Suit won by Burbage Woodward.... Now this Burbage Woodward had a son named Burbage Woodward Jr.

104-a

This JOHN WOODWARD had a wife named Patsey as shown by a deed...I was unable to find the estate of this JOHN WOODWARD (See him in # 18-e)...I will have to have a lot more time to check Fairfield and then perhaps in adjoining counties in order to unravel all these Woodward ramifications. (This was the Regulator's family)

105 WHAT DID I PROVE

Mrs. Boggles....Mrs. Johnson....Mrs. Julian....ALL descend from a common WOODWARD ancestor....So far I have not located this elusive man...Each of you can decide whether you want to spend enough money for about a week of work...It will take that long to unravel it all.

106 FAIRFIELD COUNTY S.C. FILE 33-530...(See # 52)

RICHARD WOODWARD...His estate was appraised by Edward Watts (See # 104) Stephen Nowlen & Hugh Aiken...The Estate and will was probated and executed by his friends, George & Richard Woodward...No list of heirs in file save...widow, Anne Woodward; and youngest child James Woodward.

From the file he had several children...I think that by deeds and Equity, I may be able to find all his children...I did not have time on this trip.

107 II-367 (BOOK II-PAGE 367) ...not Richard # 106

RICHARD WOODWARD...A deed for love & affection to my SONS and dated 21 March 1829:

This Richard is likely son of Richard # 106.

108 LL-3 (BOOK LL-PAGE 3)

JOHN J. WOODWARD in this deed as in scores of other deeds was COMMISSIONER OF EQUITY for Winnsboro of Fairfield District (County).

109 96-1056 (BOOK 96-PAGE 1056)

ISAAC WOODWARD....His estate was Admst. 24 Oct. 1831 by Joseph Woodward and his bond was signed by Randol Woodward Sr. and by Randol Woodward Jr....Administered by consent of the widow, Mrs. Priscilla Woodward...Estate was appraised by Jacob Feaster Jr., Randolph Woodward, James Cameron, Richard C. Woodward, Robert D.A. Thorp....Division of Estate was made 5 Jan. 1835...Widow Mrs. Priscilla Woodward...children:
Daniel Y. Woodward....minor & mother guardian
Isaac H. Woodward.....minor & mother guardian
James P. Woodward.....He was a minor and mother guardian

23 March 1839 Elijah Eubanks of Union Co., S.C. was named as the legal guardian of James P. Woodward, still a minor...The other two sons were then of age....The widow Priscilla Woodward was then wife of Elijah Eubanks, Cross Key Post Office, Union District S.C. also Elijah Eubanks and his wife Priscilla Woodward Eubanks 28th December 1842 and of Union District S.C.....Pay \$ 280 to MARY WOODWARD of Fairfield District, S.C.....a Note which May (Mary?) had incurred when she took care of the sons of Isaac Woodward, deceased.

110 HH-45 (BOOK HH, PAGE 45)

RANDOLPH WOODWARD (Often as Randol) SR.....A deed signed 18 Feb. 1830...A tract or plantation of land in Fairfield TO MY SONS

Randolph Woodward Jr. Joseph Woodward

Isaac Woodward (SEE #109)

Plantation of land which was an original grant to JOHN BELL and lying between lands of Isaac Woodward, Richard Woodward, heirs of William Woodward. /Wit....Forgot to check the names.

Definitely each of the clients is in some way closely related to this RANDOLPH WOODWARD SR. (I did not find his estate in Winnsboro)...Also to the Bell Family...also to the Aiken Family.

* ISAAC WOODWARD # 109, when he died in 1801 had an interest

in this plantation of land....The Watts Family also mix in with your set of Woodwards...See # 104 where the John Woodward died 1797 owned Edward Watts land.

Practically same file of her husband, John Woodward and same heirs as in will # 111 save some grandchildren had legacies willed to them as follows:

NOTE BY ROBERT HILL Sr: This Esther Woodward, was the wife of JOHN WOODWARD, the oldest child of Thomas (Regulator) Woodward & his 1st wife Jemima Collins.

MRS. ELIZABETH WOODWARD...Nothing in her files except the Will and no list of heirs.

112-a

More papers may show in other files...In Fairfield County many papers from other files were woefully mixed ca. 1910 by a drunken lawyer, Scion of a first family of Winnsboro...He miss laid many papers...Others he mixed hither and yon... Several years ago I worked a D.A.R. Line for a lady in Mississippi and in file of her ancestor, JOHN MURFF, I found inventory and receipts from heirs..Mention was made of the Administration but I was never able to find the bond or the sale list or other data. While at work on Woodward, I found these missing papers tucked in a file which did not remotely concern the man...I also found on this trip some other papers in a file which did not belong there...Almost every time I work in Winnsboro, I find papers tucked in wrong files...Eventually the papers on Mrs. Elizabeth Woodward may show up in some other file.

THOMAS McMILLAN...His estate...I did not take the dates of Administration..Division made 11 Aug. 1821.
Widow, Elizabeth McMillan

John McMillan, son
Mary, wife of John Cockrell, daughter

Many papers of this file were in another file for MORRIS McMILLAN, the son...He died a bachelor and his estate was divided 1 Jan. 1826...Heirs were his mother and his brother & sister above.

114 A-477 (BOOK A, PAGE 477???)

Miss ELIZABETH WOODWARD, spinster, a deed signed 22 Sept. 1780 to Thomas May...300 acres of land willed to me by deceased father, THOMAS WOODWARD and a original grant to him on Mill Creek and part of an original grant to Robert Stark, /Wit. James Nelson and John Woodward...I do not think this is the same THOMAS WOODWARD # 42...This Elizabeth signs this deed 22 Sept. 1780....Thomas # 42 signed his will 31 October 1780 HOWEVER Thomas # 42 owned a lot of land in Fairfield County.

114-a This MISS ELIZABETH WOODWARD is likely the ELIZABETH McMORRIES in Will 3 48.

NOTE BY ROBERT HILL Sr: Andrea was right...This is the family of THOMAS (REGULATOR) WOODWARD...and Elizabeth was his daughter by that name. Her mother was the 2nd wife of the Regulator, Elizabeth Stokes May. Note this woman signed spinster BUT she later married William McMorries.

114-b PROVED BY # 114

THOMAS WOODWARD, The Regulator, left a will...Question is where is the will? Since he died in 1779, the will can be in any of the old county seats of Old Craven District or else in Charleston...This will help solve some Woodward problems.

NOTE BY ROBERT HILL Sr: Andrea was right...there obviously was a will, based on the statement made by Elizabeth Woodward in Item # 114 when she says "300 acres of land WILLED to me by my deceased father, THOMAS WOODWARD" but the will has never been found.

115 A-477 (BOOK A, PAGE 477???)

THOMAS WOODWARD (His X Mark) ...A deed signed 10 Jan. 1778 to Robert Rabb...350 acres of land on Mill Creek, which was an original grant to Samuel Elliott, who sold it to Robert Stark (See # 114) who then sold it to me and adjacent to the land of Thomas Rutland, Paul Rennet, Robert Stark. /Wit. Jacob Gibson, William Robertson & John Woodward....Recorded in 1785.

116 N-8 (BOOK N, PAGE 8 ??)

THOMAS WOODWARD (His X mark) of Craven County...A deed signed 4 Aug. 1780 to Phillip Raiford...Dower by his wife, Elizabeth Woodward. /Wit. William Sanders & Thomas May...Since the Regulator was dead in 1779, this is Thomas Woodward named in # 42.

116-a

The two sets of children of Thomas, the Regulator, and of the Thomas # 42 were both in Fairfield...Likely John in # 104 is son of Thomas # 42...Also Priscilla in # 109 may be a daughter of # 42.

NOTE BY ROBERT HILL Sr: Andrea is right about the Regulator being dead BUT the name of Phillip Raiford, John May, John Woodward were also names of people connected to the Regulator's family...Was it possible that this was a transaction between the TWO different Woodward families?

117 A-453 (BOOK A, PAGE 453)

Joseph Kirkland...A deed signed 7 Jan. 1786 to HENRY WOODWARD, 300 acres of land originally granted to Joseph Kirkland. /Wit. William Roach & John James.

118 A-98 (BOOK A, PAGE 98??)

JOHN WOODWARD (See # 104) A deed signed 5 Nov. 1790 to his son, BURBAGE WOODWARD....Gift all of my cattle, Horses, Negroes, Farming Implements...etc../Wit. Usham Fair & Edward Watts Sr.

119 L-224 (BOOK L, PAGE 224??)

JOSEPH WOODWARD, Gentlemen, a deed signed 20 Dec. 1796 to William Strother, 151 acres land granted to Major Pierce Butler and adjacent to the lands of James Hendricks, John Woodward, Col. Joseph Kirkland & Samuel Gutan. /(Wit.?) John Woodward, Samuel B. Nelson & James Hendricks.

120 34-552 (FILE #34, PAGE 552)....See # 57

GEORGE WOODWARD....His estate was Admst. 19 Oct. 1814 by William Woodward & John Woodward (Seemingly his brothers) and their bond was signed by RANDOL WOODWARD (See # 110) and Richard Woodward...The widow was ELIZABETH WOODWARD and she received from the estate her DOWER of one-third the estate.

RANDOL WOODWARD (Randolph) figures heavily in this estate and he is a kinsman (likely a brother)...BUYERS at the Sale:

JAMES WOODWARD...His claim for 123 days of service at White's Bridge in 1779...This claim was sworn to in Georgetown District on 15 Dec. 1779 before Benjamin Gause, J.P.

148-a PERHAPS SAME MAN AS # 148

JAMES WOODWARD...However he signs his name as WOODWARD but claim file as WOODARD....97 days of service in Duty done at Georgetown...This claim was sworn to 14 Aug. 1783 before John Baxter, J.P.....To me it seems the same signature for # 148 and for 148-a.

BURBAGE WOODWARD....Claim for 70 days of service as a Private under Lt. John Cameron on a tour to Orangeburg in 1781...Also for a tour of duty under Lt. Kincaid in 1782 to the FOUR HOLES SWAMP...This claim was sworn to 20 Jan. 1784 in Camden District before John Winn, J.P....Claim was certified 1 March 1785.

MR. JOHN WOODWARD....For supplies furnished and in the file are receipts for the supplies furnished to the following:

William Ross James Cantey Jo. Brown
Robert Farquson Capt. James Howe Wm. Miles

Payment for these supplies were made to John Irick...Also for service as a private as a horseman under Col. Thomas Taylor

on his expedition to the Eutaws...Also for service as a wagon

master on the expedition to the FOUR HOLES SWAMP under General William Henderson...This service was certified by Captain William Roberston of Camden District on 23 June 1784 before Thomas baker, J.P.

CAPTAIN JOHN WOODWARD...Whether this is the same man above I do not know...There is no separate file for Captain John Woodward but he is referred to in the file above # 150 as Captain and John Byrd in his file states "I served under CAPTAIN JOHN WOODWARD."

NOTE BY ROBERT HILL Sr: This appears to be John Woodward (see # 28-g & # 111) who was a Captain after his father's death. He was the oldest Child of Thomas (Regulator) Woodward. His wife was Esther McDonald.

150-b FAIRFIELD COUNTY S.C.

JOHN WOODWARD as a soldier and private under Captain Gray and Col. David Hopkins from the 1st day of Feb. 1782 to the 3rd day of April 1782...Pay to and sworn to before..(not legible) This man does not seem same as John in # 150.

150-c CAMDEN DISTRICT

JOHN WOODWARD as a private and his claim sworn to 7 Feb. 1784 before John Buchannan J.P.....This service was certified by Lt. Joseph Cameron and for duty done at Orangeburg under Lt. Cameron...This may be same man as # 150...however he does not use the same script...This John Woodward made his claim payable to Charles Wheeler and witnessed by Thomas Buffington...I do know that Wheeler lived in what is now Barnwell Co., S.C.

151 FAIRFIELD COUNTY S.C.

William Cato of Fairfield County in his claim states "I served under Captain Thomas Woodward" Many cross references show for Captain Thomas Woodward.

NOTE BY ROBERT HILL Sr: Captain Thomas Woodward was the same Thomas Woodward, known as the Regulator. I think it important here to understand how the name Regulator came about...It was because Thomas Woodward was one of the founders and leaders of the "Regulator Movement" in the early 1760's in S.C.

The "Regulators" were a group of citizens in the interior sections of S.C. that tried to get law and order restored to that part of the province...and finally after the official government failed to accomplish this...took matters into their hands and with "hard, swift punishment" succeeded in restoring peace and tranquility to there areas of the province of S.C. Thomas Woodward was a leader and for that

reasons became known as Thomas "The Regulator" Woodward.

152 NOTE # 24 and # 42

THOMAS WOODWARD of Kershaw County...was a Baptist and as shown in many files of Baptist Data...However the CAPTAIN THOMAS WOODWARD of Fairfield County was a member of the Episcopal Church, as shown by a recently found journal of the Reverend Charles Woodmason.

NOTE BY ROBERT HILL Sr: The Reverend Charles Woodmason was a very loyal and sympathetic supporter of the Regulators.

A descendent of STEPHEN NOLAN also as Nowlen & Knowlen (I typed as Mowlen in # 106 so please change to Nowlen) was in Columbia recently and made a journey to Fairfield County in search of the Nolen Family Graveyard...He did not find it but told me that he ran into an old WOODWARD GRAVEYARD with many old stones...This he told me was northwest of Winnsboro and you take the road to Newberry from Winnsboro and travel out about 7 miles to "Lebanon Church" and then take a dirt road for a few miles north and then turn to a farm (Said to inquire) that has in a pine field, an old Woodward Graveyard. This is very likely the graveyard we need...However since I have no auto, I could not go to visit this old graveyard.
