NOTE OF EXPLANATION: Leonardo Andrea was a popular
genealogist in Columbia S.C., and did extensive genealogical
works on several families, including the Hill Family.

After his death, his sister Connie Andrea, made his works
available to the public for a small fee and gave rights to
copy etc... The complete ANDREA COLLECTION can be found in
the South Carolinian Library, in Columbia, S.C., located at
the UNIVERSITY OF SOUTH CAROLINA. This is a copy of what is
referred to as Hill No 1 and Hill No. 3. (Number 2 was not
obtained).

Since Mr. Andrea did his research, additional information has
been found and inserted by me. At no time have I made any
changes to Andrea's works but my insertions and comments are
in bold print. [Bold print was removed when software was
converted.]

This data on the HILL Family has been compiled from the South
Carolina State Archives in Columbia, S.C. and is to be
supplemented by other work in the various county seats. Due
to the fact that many papers of mine fall into the hands of
professional genealogist, I have not added the books nor
pages from where this data was obtained. The client will be
furnished free these books and pages on any of the names
which are in her direct line. The names is sometimes spelled
as HILLS as well as HILL.

1. MOSES HILL, the ancestor of Mrs. Nicholson, was born in
1758. He died in Fairfield County (S.C.) 7-1-1821...His wife
was SAVILLA RODEN, who was born in 1759 and died in Alabama,
23 July 1844...Their children :

NOTE BY ROBERT R. HILL Sr: Later research shows the following additional data for the above children:

a. Thomas Hill b. 1780, m. ca 1805 to Jemima Woodward, and died between January and May of 1824 in Fairfield Co., S.C. (my 3rd great grandfather).

b. James Hill b. 21 Nov 1782, m. 10th June 1806 to Susannah Glenn, d. 27 October 1854 in Union Co., S.C.

c. Sarah Hill, b. ca. 1785. m. Rev. John Pearson, they moved to Green Co., Ala ca. Apr. or May 1831. She d. ca. 1831-1835.

d. Littleton Hill, born ca. 1788-1790, never married, said to have died in late teens (after 1810?) He is named in the remains of Moses Hill's bible. Buried by side of his father in Fairfield Co., S.C. (near Buckhead in Old Yongue Cemetery in unmarked grave). Was the site of Moses Hill's home.

f. Elizabeth Harrison Hill, b. 29th January 1793, m. Stephen Terry on 4th July 1809, they moved to DeKalb Co., Ga., she died there 3rd December 1838.

g. Moses Berry Hill, b. 1795, m. Mary Bowles Glenn, d. 14th October 1824 in Chester Co., S.C. (Buried at Carlisle S.C. in the James Hill family cemetery in Union Co.)

h. Harriet Windham Hill, b. 5th March 1802, m. ca. 1818-1819 to Edward Picket Mobley, (lived life entirely in Fairfield Co.), d. on 30th April 1857.

i. George Washington Hill, b. in September 1803, m. Sarah A. Moore, moved to Green Co., Ala with widowed mother and the family of his sister Rebecca and her husband, d. there on 8th September 1857.

j. Rebecca Carlisle Hill, b. 20th December 1807. m. Dr. John Trezevant DeGraffenreid on 25th March 1828, They moved to Green Co., Ala, along with her widowed mother and brother George ca. 1831, she d. there on 11th August 1842.

This ends the notes by Robert R. Hill and the data was a result of years of investigation by Mrs. Jeannette B. Christopher, of Carlisle, S.C. (descendent of James Hill) and myself (descendent of Thomas Hill).

2. South Carolina had four colonial counties, Craven, Berkley, Colleton and Granville. These counties extended from the coast up to the N.C. line. At the end of the Revolution,

these counties disappeared and new counties were formed in their place, along with the districts of NINETY-SIX, CAMDEN, CHERAW, GEORGETOWN or WINYAH, CHARLESTON, BEAUFORT and ORANGEBURG which came into being about 1765.

3. Up to 1745 land was allotted not by the number in the family. From 1745 to 1775 the land grants were allotted by the size of the family (Save for a few years when each person got 50 acres and an additional 50 acres for each member) the land was allotted 100 acres for a single man or woman over the age of 16 or 15 if nearer to age 16. Then 50 acres additional was allotted for a wife and 50 acres more for each child under the age of 16. No married women, unless widows, were allowed land during this time. Often a man took a grant and when his family increased in size, more land was allotted. Often a man had several grants in payment for surveying.

After the Revolution, the land was not limited as between 1745-1775

Memorial tax return made 7 January & 17 January 1732 by MARY HILL, widow of JOHN HILL of the Parish of St. George in Berkley County for 100 a of land sold by James Cantey with dower by his wife, Elizabeth Cantey of the 100a grtd. to James Cantey, who sold to John Hill, who by his will, gave same to his widow, Mary Hill and said land being along the town limit of Dorchester and also for 26a of land given to Mary Hill by Daniel Stewart and his wife, Hannah Stewart in a deed settlement. MARY HILL, a plat surveyed 20 Aug. 1784 by Alexander Johnston upon an order from John Winn, dated 9 Aug. 1784 for 100a in Camden Dist., on branch waters of the Wateree River and (bounded) by lands of Abraham Gibson, Meredith Taylor, Jasper Rogers & Joseph Helms (The plat for additional 215a is not on file...granted to Mary Hill 6 June 1786.

15. LEONARD HILL, a plat surveyed by James Winn 23 Feb. 1785 upon an order from John Winn 29 Dec. 1784 for 82a of land in Camden District (Fairfield) on the Little River and by lands of William McClintock, vacant lands and lands of Leonard

Hill.* (Shows Leonard Hill already owned lands adjoining this grant made 6 June 1786.

16. MOSES HILL (See #1) a plat surveyed 16 Nov. 1785 by James Dougherty upon an order by John Winn for 315a of land on Little River in Camden Dist. (Fairfield) and by lands of George Evans, John Lee, Mr. Shaw & Sealy DeLashmith.

(NOTE BY ANDREA) It seems to me that perhaps Leonard Hill and Moses Hill may be brothers and that Mary Hill is of some relationship and perhaps their widowed mother. (Maybe a sister).

17. Some years ago in the Public Library in Jacksonville, Fla., I saw & read some pages and chapters on the S.C. Families of the HILLS OF NEW ENGLAND and perhaps published before 1900. The book has more than 700 pages. I took some notes from this book for Miss Fay Hill, The Inn, Ware Shoals, S.C. This book had the complete lineage of Miss Hill back into England. In the book, in the S.C. Chapters, was mentioned both MOSES & LEONARD HILL. Perhaps in your library, in Memphis, you may obtain a copy of this book and check to see if your MOSES HILL has his line traced. If you write to Miss Fay Hill, she may have some data and the notes I made for her several years ago.

18. The Index of names connected with the Revolution in the S.C. Historical Commission....many of these names are for several distinct persons by same name and as for William Hill, I noted at least ten by that name. Often the names are for supplies furnished or as witnesses to claims and not for service to the Revolution...HILL NAMES INDEXED.

19. SAMUEL HILL was listed on the Tory List of Col. Robert Anderson.

20. Mrs. Dorcas Hill was listed in the file of a William Hill and likely as his widow. There was so much in the file and so many different William Hills that I did not attempt to find the data on Dorcas.

21. MARY HILL and listed as MRS. MARY HILL, File # 3607 and for 2 cows furnished for the troops of Gen. Thomas Sumpter...enclosed was a receipt for these cows and signed by Capt. Samuel Watson in Camden District on 8th Sept. 1780. The

other papers in this file are missing.

22. MOSES HILL (See #1) File 3609 for 120 days service with the Militia and duty at the Congarees and at the Four Holes (Swamp)...sworn to by Moses Hill on 12 March 1784 before Thomas Baker, J.P....Richard Winn of Winnsboro, Camden District and Fairfield County, certifies as to this service...5 Mar. 1784. Moses Hill sold this indent claim to Richard Winn, who on 5th July 1785 sold the indent claim to W.J.S.S. Cooke and witnessed by John Popplewell of Darlington District and by James Falone.

23. LEONARD HILL for service at the siege of Augusta and also service at the Four Holes in Orange burg and also for service under Gen. Andrew Pickens, who with Richard Winn certifies this service of Leonard Hill...Sworn to 12 Mar. 1784 before Thomas Baker, J.P....Leonard Hill sold this indent claim to Richard Winn and sale certified by John Winn, J.P.

The Rev. Isaac Smith died 20 July 1834 at the age of 76, at the home of his son in law, the Rev. W.C. Hill in Monroe Co., Ga. The Rev. Isaac Smith served in the Revolution under Gen. Washington and had for more than 30 years been a resident of Camden District, S.C. He was a Methodist minister.
