FOLLOWING FROM CAVALIERS & PIONEERS, VOLUME 1.

Page 311, 1655...George Wall granted 1200 acres in  
Westmoreland County, Va. Southside of Potomac River for  
transportation of 14 persons (all not listed her but  
included) THOMAS BAXTER and ANN PRICE, later Ann Hallum,  
mother of Sarah Hallum Woodward, wife of Samuel Woodward Sr.,  
who was the son of Christopher Woodward, the immigrant.

FOLLOWING FROM CAVALIERS & PIONEERS, VOLUME 2.

Page 75, 25 October 1669, Mr. Will Harris, THOMAS BAXTER and  
BURR HARRYS (HARRISON) was granted (jointly) 1200 acres in  
Stafford County, West side of Potomac River, upon a main run  
of a creek of Oquaquon River-for transportation of 25  
people (not listed here).

Volume 2, Page 178, In 1677, Henry Walker was granted 2960  
acres in Stafford County, Yeosiocomis Run, adjacent to his  
own land, THOMAS BAXTER, Thomas Gregg and land of Major  
Andrew Gibson...for transportation of 29 persons: (not listed  
here).

Note: John Gregg (a later generation) went to what is today's  
Fairfield County, S.C.

Volume 2, Page 247, 30th?? November 1682, Mr. George Ball was  
granted 5000 acres in New Kent County, Southside of Pamunkey  
River, branch of Crump Creek for transportation of 100  
persons (of whom only a small part are listed here). Among  
them were: THOMAS BAXTER, JON (JOHN) BAXTER, Sarah Williams.

Note: The Woodwards of New Kent County cared for a Williams  
child. Some of the original lands of the immigrant,  
Christopher Woodward, was sold to a Williams.

Volume 2, Page 253, 6th April 1683, Mr. George Morris was  
granted 750 acres in Rappahannock County, beginning at Mr.  
Perrie's corner, nigh land of BAXTERS.

Gray's Book, Page 17,  
N.N. Grant Book 2, Page 233.  
Henry Walker in 1677 patented 2960 acres in Stafford County on Yeonssocomico River, (and on) 14 May 1678 he sold to John Wood, of Charles County, Maryland. Patented granted by Herbert Jefferys Esq., who had no power to do so. Wood's grant renewed. Adjacent Henry Walker, THOMAS BAXTER, Thomas Gregg, Major Andrew Gibson. 13 March 1695/96.

N.N. Grant Book 3, Page 6,  
THOMAS BAXTER, son of THOMAS BAXTER, deceased, of Stafford County, 14 October 1695, as heir to his father's (estate) held 2000 acres on Ockaquan in said county. Warrant for Capt. George Brent, agent. WALTER GRIFFIN, who married the mother of THOMAS (BAXTER), then in his minority, had survey made 16 October following (1695) by Theoduch Bland, Surveyor, showed only 1907 acres. Deed to THOMAS BAXTER for 1907 acres on Ockaquan in Stafford County, adjacent Dogues (Dogs) Island, Bushroad's line, Wilkeses Creek or Jonathan's Run Creek. 14th December 1703.

Note: From the above deed, it appears that when Thomas Baxter Sr. died in 1695, his son, Thomas Baxter Jr. was still under age (or a minor) and thus WALTER GRIFFIN, who was his step-father, had a survey made of the land that Thomas Baxter Jr. had inherited from his father. It was found that instead of 2000 acres, it contained only 1907 acres. On the 14th of December 1703, it appears that a deed was made out to THOMAS BAXTER JR. for the 1907 acres, indicating that he had reached the age of 21 years and now considered to be an adult. This would indicate that the birth of THOMAS BAXTER JR. was ca. 1682.

William Mansbridge of Stafford County, in 1697 died seized of 200 acres on Quanticutt Creek in said county and left to Mary, his wife, whom BURR HARRISON married. Land escheated. BURR HARRISON obtained a grant. Mansbridge received grant by Col. William Fitzhugh and Capt. George Brent, agents. 4th March 1695/96. Said 200 acres is part of patent to Thomas

Drycs (Dayos) for 500 acres. Mansbridge, Matt. Marlyn & Thomas Burton each purchased 100 acres. The 200 acres adjacent the 100 acres of Thomas Burton. February 1698,

Note by Robert Hill: Burr Harrison, Thomas Baxter were obviously close business associated and a Burr Harrison (later generation) fought in the Revolution, later moved to S.C. and was close to Moses Hill (my 4th great grandfather).

JOHN BAXTER a Garnishee, being sworn declares that he has in hands of the Defendents Estate One Hundred and Six pounds of

Tobacco and ten pence, Ordered that he pay the same to the Plaintiffs towards Satisfaction of their judgement.

Page 90 (Prince William County Book, Date ??? Page???)  
FOUSHEE TEBBS an Evidence for SARAH FARROW against Archibald Bogle having attended wenty five days Ordered she pay him for the same accordingto Law. JOHN BAXTER an Evidence for Archibald Bogle at the Suit of Sarah Farrow, having attended thirty five days Ordered the said Bogle do pay him for the same and coming and returning thirty five miles eight times from KING GEORGE COUNTY.

Page 94, (Prince William County Book, 121, 30th May 1753)

SARAH FARROW (Plaintiff vs JOHN BAXTER (defendent) In Debt  
The suit is agreed and the defendent to pay cost.

### THE BAXTER FAMILY

#### BAXTER TRANSPORTATIONS.

Page 30 in 1636, Jane Baxter, wife of William Rookins.  
Page 87 in 1638, same " " " "  
Page 139 in 1642, Elinor Baxter by William Duront, 800 acres Rappahhanock County.  
Page 228 in 1653, Francis Baxter by Arthur Lenton, 1024 acres, Northumberland County.  
Page 298 in 1654, Henry Baxter by W. Walker, 480 acres James City Co., Va.  
Page 367 in 1658, Henry Baxter by James Goodwin, Potomac River.

Was Thomas Baxter Sr. born in Virginia and if not, when did he arrive in Prince William County, Virginia? Mrs. Jean Holley Day (professional genealogist) states that she can find no record of any other Baxters in Prince William County prior to a John and James Baxter appearing in the records of the 1740s.

The fact that Thomas Baxter Sr. married Mary Simpson, who remarried Walter Griffin, is verified by the following:

(PRINCE WILLIAM COUNTY DEED BOOK ???) Page 50, The Estate of THOMAS BAXTER (SR.)...(notes payments made of certain fees and balance due the children)...The amount (12765) being costed and proved in open court by WALTER GRIFFIN at marrying the widow of the above said THOMAS BAXTER. (Note: This is Thomas Baxter Sr. His widow was Mary Simpson Baxter, who remarried Walter Griffin). (1740?).

Research on this family shows that Thomas Baxter Sr. and wife

Mary Simpson Baxter had a son named Thomas Baxter Jr. SEE FOLLOWING DEED....

PRINCE WILLIAM COUNTY, VIRGINIA DEED BOOK E, Pages 48, 49, dated 25th August 1740.

JOHN BAXTER and Margaret, his wife, to Catsby Cocke. JOHN BAXTER did by his deed of release bearing date 22 March 1737 sell to Catsby Cocke....300 acres, part of 650 acres whereon the said JOHN BAXTER now lives, which said 650 acres is part of a tract containing 2000 acres, formerly granted to one SIMON THOMAS and by him sold and conveyed to THOMAS BAXTER and descended to his son and heir THOMAS BAXTER (JR.) and descended from him after his decease to his son and heir the aforesaid JOHN BAXTER, which 300 acres is bounded as follows.....etc etc...

Note: 2 tracts of land sold in same deed ....300 acres and 56 acres, both to Catsby Cocke.

Comments by R. Hill Sr: Now this deed clearly shows Thomas Baxter Sr's wife was named Mary (Simpson). Thomas Baxter Sr. died, leaving land to his son and heir Thomas Baxter Jr. When Thomas Baxter Jr. died, the land was left to his son and heir John Baxter. Additional evidence of events is found in the next deed:

THE FOLLOWING TAKEN FROM "VIRGINIA VITAL RECORDS."

THOMAS BAXTER SR, was dead by 1695 (Stafford County). This was taken from a deed and not Va. Vital records.

1. THOMAS BAXTER (JR.) died in Stafford County in 1722, St. Paul's Parish.
2. Frances Baxter died 1725/6 Stafford County, St. Paul's Parish.
3. James Baxter, 1704 Quit Rents, New Kent County, Va.
4. John Baxter, 1704 Quit Rents, Charles City Co., Va.

Note: A John & James Baxter show up in Prince William County, Virginia in the 1740s.

BELOW). John Woodward is very strongly believed to have been  
the 1st husband of Mary Simpson, daughter of Thomas Simpson  
and Elizabeth (Libby) Baxter. John Woodward & Mary Simpson  
were the parents to Thomas Woodward (b. ca. 1729), who later  
moved to S.C. and was one of the leaders of the Regulator  
movement in the early and mid 1760s. He was a Captain in the  
Rangers during the Revolution in S.C. and was killed on 12th  
May 1779 in what is today's Fairfield County, S.C. He (Thomas  
"The Regulator" Woodward) was also my 5th great grandfather.

The condition of this obligation is such that if the above bound JOHN BAXTER shall observe and keep all covenant and agreements which ought to be observed mentioned in a certain release between JOHN BAXTER and Catesby Cocke according to the true intent of said indenture then this obligation to be void else to remain in full force and virtue.

October 1695, set forth to our office, that as heir to his

patent, lying on Ocquaquon in said county, Whereupon he  
obtained a warrant under the hand of Capt. George Brent, one  
of our Agents to survey the said Patent, according to its  
bound provided it did not entrench upon Elder patents as by  
the said warrants more fully appear, and it further appearing  
that by the procurement of WALTER GRIFFIN, who married the  
mother of the said THOMAS BAXTER, then in his minority, a  
survey accordingly, was made the 16th October following by  
THEODRICK BLAND, Surveyor, including the quantity of nineteen  
hundred and seven acres, without entrenching upon Elder  
patents, as the said Surveyor reports, and THOMAS BAXTER now  
again sets forth that he is still in the possession of the  
said 1907 acres and moving to have a deed for the same,  
according to the said survey, Know ye that therefore in  
consideration of the arrearages of rent and composition to us  
paid and the annual rent herein reserved, we have given and  
granted and do by way of these presents, give and grant unto  
THOMAS BAXTER all that parcel of land, lying on the upper  
side of Ocququan, in the county Stafford, containing 1907  
acres, bounded....beginning at the mouth of a creek which  
divided this land from the Dogs Island Patent and running  
thence up the creek, according to the meanders thereof,  
crossing a branch of the same East one degree and quarter  
North 470 poles to a Maple in the branch upon Bush Roads  
line, thence along Bushroads line North 33 degrees and one  
half West 536 poles to a white oak being the uppermost corner  
tree in the woods of Bushroads land, thence NW 214 poles to a  
white oak on a hill, between the fork of a branch that runs  
to Pohick thence W=1 degree one half N=156 poles to a hickory

and a white oak at the head of a valley that runs down towards Ocquaquam, thence SW 442 poles to a chestnut oak, upon Wilkesses Creek or Jonathans Run, thence down the said Wilkesses or Jonathans Run and Ocquaquan River according to the meanders of there to the first mentioned beginning.....this 14th day of December 1703.

Stafford Sct. At a court held for said County the 9th February 1703/04, THOMAS BAXTER moved that the above deed from the Proprietors might be recorded, therefore ordered same to be recorded.

Comments by R. Hill Sr: This deed clearly shows the fact that Mary (Simpson) Baxter was the wife of Thomas Baxter Sr., and that they had a son Thomas Baxter Jr. Mary (Simpson) Baxter remarried Walter Griffin.
