2. JOHN HILL of Dorchester, Mass, 1623 and five generations of his descendent. Also an account of the Hill family of Poundsford, Somersetshire, England. Compiled and Ed. by J. Gardner Bartlett.....Boston, Printed for private circulation by Lew C. Hill 1904.

One of the first bearing the name HILL that came to America was JOHN HILL of Plymouth, Mass., in 1830 (??). His wife was Hannah: their children were: Abigail, Samuel, John, Eliezur, Johnson?, and Ebenezer.

The brothers, William Hill and Thomas Hill emigrated from Essex County, England to Roxbury, Mass in 1632. Thomas died in 1634 without issue. William Hill removed to Hartford, Conn., and probably had no children by first wife, Phillis Lyman, whom he married in 1634. His second wife, the widow Risley, was the mother of his sons: William and John; and his third (3rd) wife, the widow Mary (Warner) Steele was the mother of Joseph, Benjamin, Susannah, Mary, Jonathan, Hannah and Sarah Hill.

One William Hill emigrated in 1633 to Dorchester, Mass., whence he later removed to Windsor, Conn. He was the father of Sarah and William, as well as possibly others.

John Hill of Dorchester, possibly brother of the preceding emigrant William, came to America about 1633 or shortly afterwards. His was was named Frances, and he was the father of John, Jonathan, Frances, Rebecca, Mary, Samuel, Hannah, Mercy?, Ruth, Ebenezer, Israel, Martha and Mehitable?

The brothers, Robert and John Hill (or Hills) are reported to have emigrated about 1635, settling in New Haven, Conn...the younger brother appears had no children, but Robert Hill was the father of Abiah, John, Hannah, Ebenezer and Nathaniel Hill.

Abraham Hill came to Charlestown, Mass., in 1636. His wife was Sarah Long and the children were: Ruth, Issac, Abraham, Zachary, Sarah (died young), Sarah?, Mary, and Jacob Hill.

The brothers, VALENTINE HILL and JOHN HILL, came from London to Boston, Mass., about 1636. Valentine and wife Frances, had the following children: Hannah, John (died young) Elizabeth, Joseph and Benjamin Hill. By his second wife, Mary Eaton, he had further issue: John and Nathaniel Hill.

The younger brother John Hill married Elizabeth Strong in 1657 and had children by her named: Joseph, Samuel, John and Benjamin Hill.

Joseph Hill, of Charleston, Mass., in 1638 came from Malden, England with his first wife Rose Dunster. They had Joseph, Rebecca, Amy, Mary, Hannah, Gershom, Mehitable and John Hill. By his second wife, Hannah Mellowes, he had: Samuel, Nathaniel, Deborah and Abigail Hill. There is some evidence that the last two children were by the third wife, Helen Atkinson. It appears that Richard Hill (or Hills) of Charlestown, Mass. (arriving in 1638) was probably the brother of the preceding emigrant Joseph Hill, who died without issue.

Ralph Hill came to Plymouth, Mass., about 1638. He married in that year to Margaret Toothacre, by whom he had Jonathan, Nathaniel, Ralph, Martha, and Rebecca, several of whom may have been born at Billerica, where he lived in the later part of his life.

John Hill, of Guilford, Conn., came from Northhamptonshire, England about 1646. His first wife was Frances and they had John, Sarah, James, Elizabeth, and possibly others. By his second wife, the widow Catherine Chalker, he may have had other children but they do not appear in the records.

Peter Hill came to Saco, Maine about 1648, bringing with him his son Roger Hill, who left numerous children at Wells.

A John Hill (Hills) of Dover, N.H. in 1649 was married to Elizabeth----?: they had a son Benjamin and possibly others.

Zebulon Hill of Gloucester, Mass., about 1650, came from Bristol, England and was father of: Joanna, Elizabeth, John, Phillip, Zebulon, Mary, Abigail and Sarah Hill.

Luke Hill married Mary Hoyt at Windsor, Conn., in 1651 and had: Lydia, Mary, Eleazer, Tahan, Luke, Abigail, Elizabeth and John Hill.

Brothers Ignatius and James Hill (Hills) came to Boston before 1658. The first married Hannah Henchman in 1662 and had: Hannah, James, Ignatius, and Elizabeth.

Jonathan Hill of Portsmouth, N.H. and Warwich, R.I., before 1661, wife Mary had the following children: Robert, Jonathan and Henry Hill.

Charles Hill in 1665 was living in New London, Conn., having previously lived in Maryland, to which place he had come from Derbyshire, England. In 1668 he married Ruth Picket and had four children: Jane, Charles, Ruth and Jonathan Hill. He married a second time to Rachel Mason but it appears they had no other children.

John Hill of Portsmouth, N.H. in 1665, wife Elizabeth, was the father of Joseph, Nathaniel and Samuel Hill.

Another John Hill was living at Boston in 1668 and his wife was Mary: children were Elizabeth and John Hill.

Still another John Hill (Hills)? lived at Saybrook, Conn., and married in 1670 to Jane Bushnell and by whom he had at least one son, Samuel, and probably others too.

Thomas Hill (Hills?) of Middletown, Conn., before 1678, wife Mary, had the following children: Susannah, Elizabeth, Thomas, John, Sarah and Mary Hill.

About 1680 a Samuel Hill lived in Portsmouth, N.H. and married that year to Elizabeth Williams. Their children were: John, Elizabeth, Mary, Hannah, Abigail, Samuel, Sarah, Benjamin and Joseph Hill. There were many others of the name HILL that came to American in the 18th century, including: DR. Richard Hill, who married Deborah Moore, of Maryland in 1720 and had issue: Richard, Hannah, Mary, Deborah, Harriet, Henry, Rachel, Margaret, Sarah, and Milcah Hill.

Reuben was a "Hatter" and also an ordained minister. They and one son, Thomas, were enumerated in Pittsylvania County Virginia in 1790 Census. In 1797 the migrated to Eastern Tennessee and settled on the French Broad River, where they lived for four years. They then moved to Berea Station, Kentucky, where they lived for two years, then two years at Somerset, Pulasli County, Kentucky. They moved again to near Creelsboro, Cumberland County, Kentucky. In 1818 they moved to Muary County, Tennessee and lived 8 miles from Columbia, on Duck River, on one of the experimental farms of James K. Polk. In 1833 Reuben died. His sons went to court for an order to care for his estate.

Hill (son in law) and Hanks N. Henry Hill m. Elender Hendrix, he was son of HENRY TRUMAN HILL AND ALICE (RIDGELY) HILL, who came to SC from Fredrick County, Md. ca. 1769.

Joseph Hill (Will Newberry Co., SC) son of HENRY TRUMAN HILL AND ALICE (RIDGELY) HILL. This Joseph Hill married Rachel Fowler, and they had a daughter named "Rachel Fowler Ridgely." Joseph Hill is known to have lived in Greenville Co., SC from 1793 to 1805, and may be brother to Henry Truman Hill.

Henry Truman Hill was son of Henry Hill, who made his will in Fredrick Co., Md. in 1773 and names both Henry Truman Hill and Joseph as son, also Phillip, Robert, Thomas, and John: daughters were Elizabeth, Rebecca, and Ann.

Henry H. Hill (1776-1850) was my great grandfather. He left Greenville County (SC?) ca. 1817 and went to Allen County, Ky. and settled in Lauderdale Co., Ala. by 1819. He died there in 1850. He named his 2nd son Green Berry Hill. Four of Henry's grandsons were also named Green Berry, one named Thomas Green Berry Hill. My grandfather's older brother was born in 1842 and named Green Berry Hill.

Rev. Henry H. Hill and Judith (Nabors) Hill had following children in order of birth: William Nabors Hill, Green Berry Hill, Lewis M. Hill (my great grandfather), James Henry Hill,

John Hill and Alston (Auston) Hill. Daughters were in order of birth: Sarah, (she was oldest child), Rebecca, Temperance and Mary Hill.
