W-10106 Clem Hill, born ca. 1757, enlisted Fairfax Va. 1779. Declaration Barren Co., Kentucky 17 Sept. 1832. Widow Mary (Douglas) Hill applied from Lawrence Co., Indiana on 8 April 1843.

W-4987 George Hill, Dragoon, Washington's Corps, Virginia Line. Married 14 Oct. 1785 in Culpeper Co., Va. Hannah Hickman, with Joseph Hill security. of Hampshire Co., Va. in 1813, made declaration in Pickaway Co., Ohio 29 Aug. 1833. He died 25 April 1838, Widow Hannah Hill (b. 31 Aug. 1763) made declaration from Pickaway Co., 7 Nov. 1839. She died last of April 1850.
