NOTE: Reference to Leonard Hill, it has been claimed that
Leonard Hill & Moses Hill were brothers by a genealogist
named DeLorme, of Columbia S.C. He also stated that Mary Hill
was their mother. Mr. DeLorme also stated that Mary Hill and
her children "probably came from Conn." but he offered no
proof or a source of where such information comes from.
Information from S.C. implies that Leonard Hill moved to
Kentucky and there is a Leonard Hill in Clark County Ky., by
1790.

IMPORTANT NOTE TO ABOVE: I talked personally with Mr.
DeLorme on June 28th 1986 in the S.C. Archives, and he
advised me that he was told the above information by Mr.
Leronardo Andrea, now deceased. Mr. Andrea refers to a book
"THE HILLS OF NEW ENGLAND" with a publishing date prior to
1900 in Jacksonville Florida Library, stating that both Moses
and Leonard Hill are mentioned.

He was son of Jonathan Hill and Miriam Hall...Jonathan and Thomas moving to Camden District...I have copy of Thomas Hill's bible record, who later moved to Kentucky. Reuben Harrison was his brother in law.

HILL OF FAIRFIELD CO., S.C. IN THE NAME OF GOD, AMEN: Know
ye that I Richard Hill of the State of S.C., Fairfield
District, being weak in body but of perfect mind and memory,
knowing that it is appointed for all men to die; and touching
such worldly property as it hath pleased good God to bless me
with, it is my will that my property be judiciously
appraised, and remain as it is to the use of my family for my
wife and children. Secondly, it is my will that my wife,
Mary Hill, deposees??, and occupy the Plantation whereon I
now live, with all the appurtenances, thereunto during her
lifetime, or widowhood. Then to be equally divided at her

decease or marriage among my five sons, (viz) William, Simeon, Richard, Scion, and John Hill. Thirdly, it is my will that until each of my daughters namely; Darcus, Susannah and Sarah Hill unto each of them be given the amount of forty dollars of my goods and chattels after they have been appraised, and the remainder if any to be equally divided among my children. (NO DATE GIVEN)

IN COURT OF ORDINARY FOR FAIRFIELD DISTRICT, 22 January 1810 personally appeared John McCullough, George S. Smith and David Mobley, who being duly sworn deposite that they were present when the within named RICHARD HILL (deceased) directed the above John McCulley to write, which was the same in substance which is contained in the above instrument of writing, called his will, but the deceased, became so weak and insensible before the will was perfected, but was truly sensible when he spoke the testamantary words, the said deponent further says that they being present were called upon to witness the above transaction and that they did in the presence of each other did subscribe their name thereto.

the deceased is entitled to an equal share of 2/3rds of said lands, it being yet undivided estate and as so hereby intended to be conveyed to my aforesaid brothers, the said William E., Richard and Sion Hill, 100 acres of the 184 above mentioned was granted to RICHARD HILL, who's eldest son, William, according to the RIGHT OF PROMOGENTURE BECAME HEIR OF ALL LANDED ESTATE OF THE SAID RICHARD HILL, FATHER TO THE SAID, Wm. E, Simeon, Richard, Sion, Darcus and Susannah Hill by deed, February 6th 1793, the other part of the 184 acres was conveyed to the said Richard Hill by Adam Efort by deed on 13th November 1792.
