1. DEED BOOK I, PAGE 102, FAIRFIELD COUNTY S.C., 26TH JULY 1774, Darcas Hill to Asaph Hill, for 80 pounds sterling, 103 acres on Beaver Creek, a branch of Broad River, bounded by Albert Beams land, Asaph Hill's land on both sides of William Hill's land, originally granted to Dorcas Hill on 26th July 1774 [(?) Index of grants shows this land granted to Dorcas Hill on 4th November 1772].

2. DEED BOOK R, PAGE 158, FAIRFIELD DEEDS, 13 MARCH 1795, I William Hill of Fairfield County, sell for 50 pounds Sterling, unto George Dye 80 acres, joining Thomas Edrington, Richard Hill and John Dye.

3. FAIRFIELD COUNTY S.C. DEED BOOK S, PAGE 116 1805-1809, Edward Mobley, of Fairfield County, sells for \$ 1200 paid by John Robinson, 200 acres on Little River, on branch of Bowers Mill Creek, 100 acres originally granted to William Hill Sr., deceased, on 19th October 1763, (granted or deeded?) to William Hill Jr., in 1771, bounded on NW by John Halsey, on the North by lands laid out to William Hill Jr., conveyed by William Hill Jr. to Samuel Mobley Sr., on 10th January 1792, conveyed to Edward Mobley in 1795.

4. DEED BOOK W, PAGE 256, 11 AUGUST 1814, FAIRFIELD CO., S.C. Know all men by these presents that I John Hill of Mississippi Territory for \$ 535.00, to me in hand and paid by Francis Edrington Jr., of Fairfield County, S.C. sold 77 acres on Beaver Creek, it being a part of Real Estate of William Hill, late of Fairfield County, deceased, being part of Real Estate laid out for said John Hill by order of Court of Common Pleas as one of the heirs of the said William Hill.

5. DEED BOOK R, PAGE 167, FAIRFIELD DISTRICT, Know all men by these presents that I Elizar Mobley of the state and district aforesaid, for and in consideration of the sum of \$ 600.00, to me in hand, paid by Richard Hill, John Hill and Elizar Mobley Hill, in state and district aforesaid, sold and released, and by these presents, do grant, bargain sell and

release unto the said Richard Hill, John Hill and Elizabeth M. (Mobley?) Hill...

100 acres of land granted to Henry Funderburg the 5th of December 1764, by his Excellency William Bull Esq., said land lying in Fairfield District, in state aforesaid, on Broad River, bounding on lands of as the plat represents, South lands laid out to Ann Lyther near the mouth of Beaver Branch which is now called Beaver Creek, said creek running thru said land and on all other sides as the plat represents vacant, and such forms, shapes, marks as a plat there of shall represent, together with all and singular, the rights, members, here determined and appurtenances, to the said premises or in anyway incident or appertaining, TO HAVE AND TO HOLD, all and singular the premises before mentioned unto the said Richard, John, and Elizabeth M. Hill, their heirs and assigns FOREVER. AND I do hereby bind myself, my heirs, executors, administrators or assigns to warrant and forever defend all and singular, the premises aforesaid unto the said Richard, John and Elizabeth M. Hill, their heirs and assigns against myself, my heirs and executors, and against every person or persons whoever lawfully claiming or to claim the same or any part thereof. WITNESS MY HAND AND SEAL this 19th day of June in the year of our lord, 1804 and the 28th year of Independence of America.

THE FOLLOWING IS SOME INFORMATION ON DIFFERENT HILLS LOCATED IN GEORGIA AND WERE REVOLUTIONARY SOLDIERS. THIS INFORMATION WAS FURNISHED BY MR. BENJAMIN DUNLAP HILL JR, OF WASHINGTON D.C. IN JULY 1941...

Wilkes County Georgia, John Hill lived in Maryland, Virginia and then Georgia. He was married to Nancy Kesterson (b. 29th May 1761) by a Catholic in Northumberland County Virginia in 1779-80. John Hill died in Hancock County Georgia on 12th November 1842. (Is this John Hill the same John Hill who was known to be the son of Clement Hill of Maryland, and who was closely related to the Mobley Family???)

Wilkes County Georgia, James H. Hill received 500 acres on 22 October 1784, by Act of the Council, indicating he was a Captain. He was with Colonel Elijah Clark, who's certificates shows also a Captain John Hill, James Hill and Abraham Hill.

Washington County Georgia lists for Revolutionary Soldiers shows the following named Hills: William, James, John,

Joshua, Moses and Edward under the date of 1784. They are also listed in the "Georgia Roster of the Revolution" by Lucian Lamar Knight.

Dawson County Georgia records the service of Reuben Hill. He and several of his married children removed from Rutherford County N.C. He was a Revolutionary Pensioner, stated he was born in York County, S.C. in 1764, wife was Margaret McBrayer (McBrier) also from York County S.C. He died in 1858.

Jasper County Georgia was erected (formed) from defunct Randolph County in 1808.

Jasper County Georgia Records...(includes Jones County) It is said that someone of these Hill removed to TROUP COUNTY Georgia.but as of this date (1941) no one has solved this.

Jasper County names several Revolutionary Soldiers. In the 1827 Land Lottery we find Mordecai Hill, Revolutionary Soldier; Benjamin Hill, Revolutionary Soldier; Sarah Hill, widow of a Revolutionary Soldier; and Catherine Hill, widow of a Revolutionary Soldier. Catherine Hill is aged 92 in 1850 Census and so was born 1758 in N.C. She was widow of James Hill, who's will is recorded in Jasper County Georgia Will Book for 1823-1833.

Jasper County Georgia, John Hill appears in the 1820 and 1830 Census for this county. According to TROUP COUNTY HISTORY, he located in TROUP COUNTY GEORGIA in 1833. He was married to Sarah Parham (b. 1790in N.C., d. 1854). Based on Troup County History, John Hill was born 30th April 1785 and died 20th July 1848 in Troup County, and is buried in Hill Cemetery. Benjamin Harvey Hill, his son, was born 14th September 1823 in Jasper County Georgia.

A peculiarity exists in the 1840 Census of Troup County Georgia in the fact that this John Hill and a James Hill of near the same age, having living with each of them an elderly female, aged 70-80. It is believed that this may be a duplication of their Hill mother. If so then James and Catherine Hill of Jasper County would not be their parents. James H. Hill bought his home in LaGrange in 1835.

In the 1827 Land Lottery, Sarah Hill, widow of DeKalb County Georgia, and James Hill of Jones County, each purchased land in Troup County but this does not necessarily mean that either removed to Troup County.

Jasper County Will Books between 1812 and 1833 lists wills for three William Hills, two Isaac Hills, and Theophilus Hill and James Hill.

Franklin County Georgia, James Hill has a certificate for Revolutionary service signed by Colonel Elijah Clarke, dated 1785; he received a bounty. In 1789 James Hill and wife Mary

made a deed, according to D.A.R. Georgia collections. After other counties were taken (formed) from Franklin, Hill families were still found in Franklin County.

According to the Census Records for 1820, both Jackson and Walton Counties in Georgia shows Hill Families but no John Hill in either county. In Walton County we find Elias and Issac Hill; in Jackson County there is a Samuel B. Hill.

In Jackson County Georgia, John Hill in 1830 is aged 60-70, wife aged 50-60, two daughters, no slaves. In 1840 John Hill is aged 70-80, wife aged 70-80, boy 10-15, girl 10-15, no slaves. In 1850, neither are to be found, so it is probable that they were dead, dying in the 1840s.

As of the date this information was compiled (July 1941) there appears to be a very big research project for someone to separate John Hill of Jackson County from John Hill of Walton County. Children of John Hill (Walton County) seems to be in both counties. It would appear (if it has not been done by now) that the best way to accomplish this is to find wills or administrations in both families, copy every single deed, including survey lines, but not extraneous phrases, so that it can be seen how the land descends and where it lies). Then it can be grouped correctly.

Now parallel to this case is JOHN HILL of Walton County Georgia. He is not in Walton County Census of 1820. In 1830 he is aged 60-70, wife aged 60-70, another female is aged 60-70, female aged 20-30, female under 5, one slave; total 7 persons in household. In 1840 John is dead, however living with a Carter Hill is a female 70-80, so this might be the widow of John Hill. In 1850, Anna Hill aged 88, born in N.C., is living with John and Lucy Franklin, so this is this the widow of John. (??)

Therefore Annie Naomi Camp Hill was born in N.C. in 1762. Since John Hill died in 1832 and Annie Naomi Camp Hill died in 1853, this would appear to agree with Census data.

John Hill was born before 1760, as it is safe to assume, was old enough to have participated in the Revolution, even as early as 1776. It might be possible to find him in either North Carolina men of OLD TYRON COUNTY, which became York County S.C. in 1785; or with S.C. men of YORK COUNTY, which was in Camden District. In other words, serving with the men of his region, his service will be in either state. The Camp family is also found in all three Counties. Records for this region are found in both Raleigh and Columbia; and in Charleston prior to 1785. Very complicated.

John Hill of RUTHERFORD COUNTY N.C. is listed in the 1800 CENSUS as aged 26-45. Abel Hill of Rutherford County N.C. is listed as 26-45 in the 1800 Census.

At this date (1800) John would have been 40 years old at least. It is my opinion (Benjamin Dunlap Hill Jr) that Abel Hill was not the father of John Hill. Certainly not the Abel Hill who removed to Henrietta in 1793, to Pendleton County, S.C. and died in 1803. George and Reuben Hill come in this age bracket. ??? (The meaning of this is unclear).

GEORGE HILL

I George Hill of Pickens District, being weak in the flesh, but of sound and disposing memory and mind. I give to LEWIS HILL, the tract of land called the Sisk Tract, which I purchased from Thomas Sisk on 26 August 1808. I give to my son LEWIS HILL the land I purchased from William Reid, originally granted to John Yargar. I give to my daughter, MELINDA HENDRIX my Negro fellow Willis. I give to my daughter all my household and kitchen furniture and my mare Pigeon and her colt to my daughter RACHEL HILL. I give the mansion house and the tract of land on which I now live, Originally granted to Dominico Holland the other half which I have deeded to Issac Williams to my daughter, RACHEL HILL. My son to be released from a debt of \$ 320 which he borrowed. The rest and residue of my estate to be sold and money divided among my children. I appoint my son LEWIS HILL and son in law MOSES HENDRIX as executors. Dated this 13 May 1834. Wit: Susan (x) Huff, Wilson Lesley, Roswell Hill, C. Packard.

Signed George Hill.

Proved this 23 July 1838, before J.H. Dendy, O.P.D. On 8th October 1838 qualified Moses Hendrix executor.

I JOHN HILL, being of sound and disposing mind and memory, but weak in body. First, I desire that as much of my property be sold to pay my just debts. I then will unto my mother, SUSANNAH HILL, my Negroes Gilbert and Gabriel during her lifetime or widowhood. After her death to be sold and the money divided between my three brothers, SAMUEL HILL, JOSEPH HILL, BLUFORD HILL and my sister REBECCA HODGES....I appoint Reuben Hodges, SAMUEL HILL and William Barmore my executors.. dated this 3 August 1824.. Wit: Richard Hodges, William Hodges, William Barmore.
