ELISHA HILL in a deed signed 30 Jan. 1826 sells to Henry Easterling 100a land on Beauty Spot Bridge Creek that Hill purchased from William Stubbs Sr...and 65a on Fairley Creek he purchased from the heirs of Joseph Speight and originally granted Henry Council.

William Stubbs in a deed signed 18 Feb. 1809, sells 100a to ELISHA HILL...these are two of the deeds and others not abstracted.

HENRY HILL....9 March 1787 Ordered that Joseph Mason be  
overseer from the place where William Jordan stops down to  
William Irby's gate, with all hands between the two places  
except those that work on the Ferry Road and the estate of  
Thomas Williams lands and Henry Hill's lands.

HENRY HILL....8 March 1787 Ordered that Drury Robertson be  
the overseer with all the hands between Mrs. Irby's down to  
Naked Creek and said places excluding the Williams Estate and  
H. Hill's and also to be clear and open the new road from  
Pledger Saw Mills to Pledger Ferry.

HENRY HILL....6 March 1787

NOTE BY ROBERT R. HILL SR.: I have been in touch with a  
descendent of this Hill Family, a Mrs. Rita Hill Pullum, of  
San Antonio, Texas. She has evidence that William Hill (wife  
Molly) originally came from Maryland, then into Virginia,  
N.C. and finally into Chester Co., S.C. This information was  
obtained from the 1880 Census, where the grandchildren of  
William Hill stated that their parents (viz children of  
William Hill) were born in those states. William Hill died in  
Chester County in 1804.a

NOTE BY ROBERT R. HILL SR.: This Micajah Hill appears likely to be the son of a Moses Hill and wife Jean. Moses Hill . died in Chowan County N.C. ca. 1750 and had the following sons: Aaron Hill & Micajah Hill.

Moses Hill (wife Jean) was the son of William Hill. William Hill died in Chowan Co., N.C. in 1750/51, and his wife was Mary Spivey.

William Hill is believed to be the brother of a Moses Hill Sr., who was born probably in Nansemond County Virginia and who came to N.C. (Chowan Co.) by 1717 with his wife Dorothy.

Moses Hill Sr. left a will in Chowan Co. in 1745 and named the following sons:, a. Moses Hill Jr., 1705/12-1762/63 of Bertie Co., N.C.;

b. Guy Hill, ca. 1710/17-1775 of Chowan Co., N.C. & who's sons were Kadar, Guy Jr., & John Hill;

c. Issac Hill, b. after 1716, left Bertie Co., N.C. in 1754;

d. Abraham Hill, b. after 1716. He died in Gates Co., N.C. in 1786 and had sons Moses, Aaron Henry & Mills Hill.

NOTE BY ROBERT R. HILL SR.: I have considerable data on this Hill Family of Roberson County, N.C. A Thomas Hill (Sr.), wife Cumfort, was originally from Halifax County, N.C. They lived in the eastern end of the county, which in 1774 became Martin County. It is believed that Thomas Hill derived from the numerous Hills in nearby Chowan & Bertie Co., N.C. and Nansemond Co., Va., in which the given name of Moses was often used.

Thomas Hill (Sr.), wife Cumfort, left a will on 14 July 1768, proven in Feb. 1769, in Roberson Co., N.C. He left bequests to wife Cumfort, son George Hill (dwelling & 150 acres at wife's death or remarriage), son SLAUGHTER HILL (150 acres up the swamp, joining Edmondson) and son James Hill (100 acres, joining John Hill). The residue of the estate left to widow for life, "then to be equally divided amongst rest of my children: Anna Hill, MOSES HILL, William Hill, Elizabeth Hill and Nanny Hill."

A deed dated 6 Jan. 1786 shows "Comfort Hill, SLAUGHTER HILL, Moses Hill, Thomas Hill & William Hill, of the County of Bladen" sold to Nehemiah Staton of Martin Co., N.C. 150 acres on Coneto Swamp, which was patented by Thomas Hill Sr. on 15 October 1761 and by him bequeathed to his son George, "the said George Hill, deceased, leaving the said land to us." (A:551), the heirs of course being his mother & brothers. (Note: Bladen County was formed from Roberson Co.). Slaughter Hill and wife Elizabeth, sold 150 acres on Little Coneto, "being the plantation where said Slaughter Hill lived," on 12 Dec. 1777 (Martin Co., A: 195). Slaughter Hill entered a claim to land on Ashpole Swamp in Bladen County in 1779.

James Hill with wife Nancy, sold his inherited land on "Concho" joining Edmondson, to George Cockburn on 19 Dec. 1776 (A:161), but was not a party to the deed of 1786.

A George Hill, possibly a brother of the father Thomas Hill Sr., lived briefly in the same part of Halifax, later Martin County. On 27th Aug. 1759, George Hill of Halifax County, sold to Augustine Vawter, 130 acres on the Marsh Swamp and George Hill's Spring Branch (7:339), witnessed by John (x) Baysford, Mark (x) Wood. Then on 22 April 1760, Joseph Edmondson & wife Mariannah and George Hill and wife Ann, released all rights in 100 acres on the Marsh Swamp to Thomas Gardner (7:94). This George Hill signed by mark and he just might be the George Hill later found in and around Camden District and Craven County S.C.

Members of this Family are found in the 1790 Census of Roberson County, N.C.

Moses Hill appears in the Roberson County deeds from 1788 on, and deeded land to Moses Hill Jr. in 1818. (This pretty much rules out the MOSES HILL (#1) in Andrea's report as being the Moses Hill in Fairfield County.

REFERENCE # 77 OF Andrea's Report, Dannel Hill, In Cumberland County Virginia, a Thomas Hill made a will on 6 Oct. 1770, named wife as Barchany and children as John, DENNETT, Mary, Thomas, William, Joseph, James & Ann. While the name Dannel is not spelled as DENNETT (in Will) it is close enough to make one wonder if the two are in fact the same person or at least related. The will was witnessed by John & Joseph STARKY & John Spearman. There is a STARKY HILL in the area of Camden District S.C. & he too may be related to this Virginia Family.
