THE STATE OF SOUTH CAROLINA: Know all men by these presents that I MOSES HILL, of Fairfield District and state aforesaid for and in consideration of the sum of One Hundred and Fifty Seven Dollars, to me in hand will and truly paid by JOSEPH CAMERON of the state and district aforesaid, have granted Bargain Sell and release unto the said JOSEPH CAMERON all that plantation or parcel of land containing 152 acres, being the East part of 401 acres of land which was granted to THOMAS SHANNON on the 2nd day of October in the year of our Lord 1797 under the hand of his Excellency CHARLES PINCKNEY ESQUIRE GOVERNOR (???????) hath a memorial thereof entered in the Secretary's Office in Grant Book R, NO.58 or 585?), page S04 ??? and conveyed from the said THOMAS SHANNON the part above, represented to the above named MOSES HILL, the 20th day of June in the year of our Lord 1798, said land situate in Fairfield District on the Branches of the North Fork of Little River, waters of Broad River, the part conveyed begins at a red Oak corner on ALEXANDER BROUGHTON'S line near a Post Oak original corner and running thence South 51 Degrees and 61 chains and 50 links to a staked corner, bounding by land granted to ALEXANDER BROUGHTON, thence South 20 degrees West, 20 chains to a staked original corner, bounding by land laid out to JOHN CAMERON, thence South 68 degrees West 51 chains and 80 links on the original line to a staked original (line?), bounding by land granted to MARGARET BIGAM, thence North 10 degrees East 38 chains and 50 links on the original line to the beginning Red Oak corner, bounding by land laid out to THOMAS SHANNON and hath such form and marks as the above plat represents, TOGETHER WITH ALL AND SINGULAR the rights members hereditements and appurtenances to the said premises belonging or in any wise incident or appertaining to, TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said JOSEPH CAMERON, his heirs and assigns forever and the said MOSES HILL does hereby bind myself my heirs Executors and Administrators to warrant and forever defend all and singular the premises before mentioned unto the said JOSEPH CAMERON, his heirs and assigns forever against myself my heirs Executors and Administrators or assigns and against the lawful claim or claims of all and every other person or persons WHOM SO EVER an fully claiming or to claim the same or any part thereof, IN WITNESS whereof I have here unto set my hand and seal the 26th day of December in the year of our Lord 1810 in the 35TH year of the Independence of the United States of America.
