NOTE OF EXPLANATION TO THE FOLLOWING LAND TRANSACTIONS: These transactions appear to be the result of a will of RICHARD HILL of Fairfield Co., S.C. (dated 22nd January 1810) and witnessed by John McCully, George S. Smith and David A.

Mobley, (dated 5th Feb. 1811).

In the will Richard Hill (Sr.) names wife Mary (administratrix), children (my five son) William, Simeon, Richard, Schen (Sion) and John and three daughters Darkus (Dorcas), Susannah and Sarah. (Reference Fairfield Co., Wills, Book 5, page 605, Package 224. Recording date not given). From various sources we have learned the following: 1. Dorcas Hill married Richard Barker.

- 2. Susannah Hill married Peyton Mobley
- 3. Elizabeth Mobley married Simeon Hill. (She dau. of Cullen Mobley).
- 4. A Richard Hill (b. 1770-died 1837) married Dorcas____? Their sons and daughters were: William Hill, Henry Hill, Asaph Hill, Elijah Hill, Matthew Hill, Rueben Hill, Mary Hill, Elizabeth Hill, Dorcus Hill (m. John Stevenson).
- 5. A Richard M. Hill (d. 1840) married Susannah Mobley.
- 6. The Richard Hill named among the sellers to John Pearson, is said to have removed to Walton County Florida.

NOTE: It is of interest to note that John Hill and Sarah Hill, who are mentioned in Richard Hill Sr.'s will, are not shown in the general statement and did not receive a part of Richard Hill Sr.'s Estate. Were they dead at date of distribution> They were not shown as heirs in a note dated December 20th 1818.
