

DATA.058 INFORMATION GATHERED AT THE SOUTH CAROLINA HISTORICAL SOCIETY IN CHARLESTON S.C., INCLUDING LAND GRANTS IN SOUTH CAROLINA BELONGING TO MEMBERS OF THE HILL FAMILY & OTHER IMPORTANT GENEALOGICAL DATA.

2. Charles Hill, Memorial for 100 acres in Craven County on Wateree Creek. November 19th 1774.

10. Jonathan Hill, Memorial for 200 acres in Craven County on Lynches Creek. May 7th, 1761.
11. Jonathan Hill, Memorial for 250 acres in Craven County on Wateree Creek. January 23rd, 1769.
12. Jonathan Hill, Memorial for 100 acres in Craven County on Lynches Creek. July 1, 1767.
13. Joseph Hill, Memorial for 100 acres in Craven County on High Hills of Santee. June 8th, 1773.
14. Nathaniel Hill, (sold?) to John Adamson in Craven County 160 acres on Wateree River. September 28th 1768.
15. Nathaniel Hill, (sold?) to John Buckhannon, Memorial for

- 400 acres in Craven County. April 22, 1769.
16. Nicholas Hill, Memorial, for 200 acres in Craven County on Rayburn's Creek. October 21, 1769.
  17. Richard Hill, Memorial for 100 acres on Beaver Branch (Craven County?) February 27th, 1765.
  18. Robert Hill, Memorial, for 200 acres on Wateree River in Craven County. July 15th, 1765.
  19. Robert Hill, Memorial for 200 acres in Craven County between Wateree & Congaree Rivers. February 25th, 1772.
  20. Robert Hill, Memorial for 200 acres in Craven County between Congaree & Wateree Rivers. November 24, 1772.
  21. Theofus Hill, Memorial for 400 acres in Craven County between Wateree & Congaree Rivers. August 30th, 1770.
  22. Thomas Hill, Memorial for 150 acres on Horse Creek Branch (later known as Hill's Creek) in Craven County. June 21, 1771.
  23. Thomas Hill, Memorial, for 150 acres in Craven County on Cedar Creek. March 17th, 1775.
  24. Thomas Hill (wife Judith) originally granted 100 acres in Camden District (Fairfield Co.) on June 2nd, 1788. He sold the land to John Wages on 19th February 1793.
    - a. Thomas Hill (wife Judith) buys 82 acres of land from Leonard Hill on January 5th, 1786.
    - b. Thomas Hill (wife Judith) sells the above 82 acres to Andrew Allen Sr. on January 5th, 1792. The land originally granted to Leonard Hill, on 5th January 1786, but then sold to Thomas Hill on 26th May 1788.
    - c. The same Thomas Hill (wife Judith) then sold 50 acres to James Knowland on February 15th 1798. This land was on Bower's Mill Creek in Craven County (Now Fairfield Co.) originally granted to William (Augusta) Hill on ( ) but transferred to son Richard Hill, who then sold to Jane Rogers, who sold to Shadrick Noland (Knowland?) on September 27th 1788, who in turn sold it to the above Thomas Hill on March 16th, 1790. (Reference Fairfield Deed Book S, pages 12-13). (Note: Father of William Augusta Hill was Charles C. Hill, who's name is mentioned in Moses Hill Bible).

NOTE: THE ABOVE WAS SAME THOMAS HILL (WIFE JUDITH)
  25. Thomas Hill (son of Jonathan Hill & Miriam Hall) and his wife Patience Harrison, sold land to his brother in law

Reuben Harrison on August 31st, 1795.

(Father of this Thomas Hill was Jonathan Hill, listed previously). Same Thomas Hill sold the following lands:

- a. 350 acres on Wateree River in Craven County, originally granted to Paul McCormick on 6th June 1766 & Recorded in BOOK SSS, page 131? (or 181). (not legible). Paul McCormick then sold to John McCormick on 8th and 9th of August 1775, then sold to James Carg on 17th & 18th of January 1777 to Joseph Kershaw (no dates or other data given.) We do not know who Thomas Hill sold the land to or when but suspect it was to Kershaw.
- b. Another tract of 100 acres on South side of Wateree River in Craven County, originally granted to John McCormick (wife Martha) on the 13th February 1768 in BOOK BBBB, page 515, then sold to Drury Hudson on 30th and 31st January 1775 then sold to Joseph Kershaw on 15th, 16th August 1776.
- c. Another 150 acres on the west side of Wateree River, originally granted to Patrick McCormick on 20th October 1763, then sold to James McCormick on 11 & 12th March 1766 in BOOK FN3, pages 535-538 dated 19th January 1767. Land was then resold to Joseph Kershaw on 21 and 22 nd January 1774, then sold to the above Thomas Hill on 7th and 8th December 1774?.

(Note: Joseph Kershaw was the administrator of Jonathan Hill's estate, who was father of the above Thomas Hill. It is not clear as to why, how or to whom or when Thomas Hill sold these lands but it is he that is listed as selling and it is suspected that they went to Joseph Kershaw on 15 & 16 of August 1776, since he was the "Great Creditor" of Jonathan Hill's Estate).

NOTE: I suspect that this is the father of Nancy Elizabeth Barret, who married Rev. William Woodward. They were parents of Jemima Woodward, who married Thomas Hill, son of Moses & Savilla N. Roden.

Thomas Hill and Jemima Woodward named a son Nathaniel Barrett Hill, and I strongly suspect it was after the above man.
