

DATA.076 GENEALOGICAL INFORMATION RELATING TO THE FAMILY OF GREEN B. MOBLEY AND SAVILLA HILL, BOTH ORIGINALLY OF FAIRFIELD COUNTY SOUTH CAROLINA, AND WHO MOVED TO GREEN COUNTY ALABAMA.

Significance to Hill Research: Savilla Hill was a daughter of Thomas Hill & Jemima Woodward, both of Fairfield County South Carolina. Thus she was the granddaughter of MOSES HILL (1758-1821), A Revolutionary Soldier in Fairfield County South Carolina and his wife, SAVILLA N. (NANCE?) RODEN.

EXPLANATION & COMMENTS:

It has been known for years that Green B. Mobley, of Fairfield County, South Carolina had married Savilla Hill, a daughter of Thomas Hill & Jemima Woodward, and they had moved to Green County Alabama. While the Mobleys were a large and well known Family in Fairfield County South Carolina, the parents of Green B. Mobley was unknown, until the BILL OF SALE (Found later on in this data) was located. It proves his parents were WILLIAM MOBLEY & NANCY COLEMAN.

It has also been known that Green B. Mobley married Heneritta Wilson on 30 August 1841 in Sumter County Alabama. (Reference "Alabama Records" by Gandrud, Volume 132, Page 6). Thus it appeared that Savilla Hill Mobley had died between the birth date of the last daughter (Caroline) and the marriage date of 30th August 1841 or the date of the 2nd marriage by Green B. Mobley.

The proof that this is the same Green B. Mobley results from the following factors..

Before Green B. Mobley moved from Fairfield County S.C., he signed as a witnesses to a couple of land deeds that involved his father in law, Thomas Hill.

Savilla Hill's maternal grandmother was Nancy Elizabeth Barrett, WHO HAD MARRIED REVEREND WILLIAM WOODWARD, of Fairfield County S.C. One of their children was Jemima Woodward, who had married Thomas Hill of Fairfield County S.C. and they were the known parents of Savilla Hill.

The name of Barrett was very commonly used by the Woodward Family, mostly as a middle name (viz: William Barrett Woodward). Savilla Hill also had a brother named NATHANIEL BARRETT HILL (my great great grandfather). Savilla also had a aunt named Sarah, and who's middle name is suspected to be Caroline, on both the Hill & Woodward side of her family and it is noted that a daughter was also given this name. It should be noted by the reader that Green B. Mobley & wife

Savilla had a son named BARRETT and a daughter named CAROLINE.

Savilla Hill Mobley also had a sister named Nancy Barrett Hill, who had married 3 times, the first being to EDWARD MABRY MOBLEY in Fairfield County S.C. Thus this seems proof enough to confirm the above family as that of Savilla Hill.

Green B. Mobley and his 2nd wife, Henrietta, are known to have had no children of their own.

THE FOLLOWING IS A BILL OF SALE FROM FAIRFIELD COUNTY S.C. (PROVIDED BY JUDGE MOBLEY OF ARKANSAS) BETWEEN THE HEIRS OF WILLIAM MOBLEY (DECEASED) AND CORNELIUS NESBITT.

THE SIGNIFICANCE TO HILL RESEARCH BEING THAT IT PROVES GREEN B. MOBLEY WAS SON OF WILLIAM MOBLEY (THE DECEASED) AND HIS WIFE NANCY COLEMAN.

SOUTH CAROLINA) Know all men by the presents that we FAIRFIELD DISTRICT) Nancy Mobley, widow of William Mobley, deceased, and Larkin Mobley, Fanny Mobley, Joab Mobley, William McGraw and wife Candace McGraw, formerly Candace Mobley, Zachariah Mobley, William C. Mobley, GREEN B. MOBLEY, and Wiley Mobley, all heirs of the aforesaid William Mobley, deceased, of Fairfield District and state aforesaid, for and in consideration of the sum of Seventeen Hundred and Fifty Dollars and Fifty Cents, to us paid by CORNELIUS NESBITT, of the same place, have bargained, sold and released and by these presents, do bargain, sell and release unto the said CORNELIUS NESBITT, all that plantation, parcel or tract of land containing Three Hundred and Fifty Acres, it being composed of several conveyances to the aforesaid deceased, situated in the state and district aforesaid, on McClures (Branch?) of Beaver Creek, Broad River, bounded (on) north by lands of Berryman Chapman and WILLIAM M. MOBLEY, (on the) west by William Chapman's land, (on the) south by lands of Hugh Stephenson and David Mobley, thence with (The line of) David Mobley's land, crossing aforesaid creek and running to a posted corner, on the east side of said creek, thence south with David Mobley's line, to a Red Oak Stump, near (said?) branch, thence east to a staked corner, on Boling Wright's line, (and said lands) hath such shape and forms and marks as

will fully appear by reference to the Plat of said lands, TO HAVE AND TO HOLD, all and singular, the presents before mentioned unto the aforesaid (contract? with?) his heirs and assigns forever, and we the aforesaid Nancy Mobley, widow, Larkin Mobley, Joab Mobley, William Myers and wife Candace Myers, late Candace Mobley, Zachariah Mobley, William P. Mobley, GREEN B. MOBLEY, and Wiley Mobley, do hereby bind ourselves and each and every one of heirs, executors, and administrators, do assign to warrant and defend all and singular, these premises before mentioned, unto the aforesaid CORNELIUS NESBITT, his heirs, executors and administrators and assigns against us, the aforesaid Nancy Mobley and Larkin Mobley, Joab Mobley, Fanny Mobley, William McGraw and wife Candace McGraw, formerly Candace Mobley, Zachariah Mobley, William C. (?) Mobley, GREEN B. MOBLEY, and Wiley Mobley, our heirs, executors, administrators and assign to warrant and forever defend unto the said CORNELIUS NESBITT, his heirs, executors and administrators and assign forever and all and every other person or persons whom so ever or lawfully claiming or to claim, the same or any part thereof,IN WITNESS we have herewit set our hands and seals the FOURTEENTH day of December, in the year of our Lord, One Thousand Eight Hundred and Twenty Six (14th December 1826) and in the Fifty First (51st) year of the Independence of the UNITED STATES of AMERICA. Signed, Sealed and Acknowledged and Delivered in presence of us, JOHN ROBINSON, JAMES WRIGHT and URIAH WRIGHT.
