TO ALL PEOPLE TO WHOM THESE PRESENTS SHALL COME, GREETINGS,
KNOW YE that I JAMES ALCORN of the County of Fairfield and
state aforesaid, Blacksmith for and in consideration of the
sum of THIRTY POUNDS STERLING, to him in hand before the
enclosing hereof, well and truly paid by ROBERT ALCORN, both
of the county aforesaid, the receipt thereof I do hereby
acknowledge myself therewith fully satisfied and contented
and thereof and of every part and parcel thereof do--quit
and discharge the said ROBERT ALCORN his heirs, executors
and--forever by these presents have given granted sold
released delivered, aliened and conveyed and conformed by
these presents, do fully and absolutely give grant bargain
sell alein convey and confirm unto him the said ROBERT ALCORN
his heirs and assigns forever a certain tract or parcel of
land containing one hundred acres (100 acres) situated lying
and being in the county aforesaid on North side of BROAD
RIVER on the waters of LITTLE RIVER, granted to the said
JAMES ALLCORN bearing date of 3rd day of MARCH Anno Domini
1788 under the hand of his Excellency THOMAS PICKERING ESQ.,
Governor by and over the state aforesaid. Bounding as follows
viz by----- ----S.W. on Francis Coleman and MOBBERLEYS and
N.W. by JAMES ALCORN and the other sides on vacant land at
the time (of) the survey. TO HAVE AND TO HOLD the said
granted bargained premises with all the privileges,
appurtenances,-----to him the same belonging or in any way
appertaining to him the said ROBERT ALCORN, his heirs and
assigns forever to his only proper use and ----forever and I
the said JAMES ALCORN for myself my heirs Executors and
Administrators covenant promise and agree to and with him
the said ROBERT ALCORN his heirs and assigns that before the
ensealing hereof I am the true sole and lawful owner of the
above bargained premises and are lawfully seized and
possessed of the same in my own power right as a just perfect
and absolute estate of inheritance in fee simple and have in
my----own self good and rightful power and lawful authority
to grant bargain sell convey and confirm the said---premises-
--- in manner aforesaid and that the said ROBERT ALCORN his
heirs and assigns shall and---from time to time-----power and

enjoy the said demised??? premises-----Executors
and encumbrances of what name or nature so ever that any
measure or degree obstruct or make void-----
