Green B. Hill married Martha Ivey 6/, (6th generation of Ivey  
family). She was born ca. 1774. She was the daughter of  
Lott Ivey 5/, born ca. 1750, he was son of Nathan Ivey 4/  
b. ca. 1730, he was son of Henry Ivey 3/, born ca. 1710,  
the son of Gilbert Ivey 2/, born ca. 1680, the son of Adam  
Ivey 1/, born ca. 1650.

Gilbert Ivey lived in Granville County, NC, just south of the  
Brunswick County, Va. state line in 1725 and after 1728.

Charles Ivey 3/, brother of Henry Ivey 3/, was listed as a  
Tax Payer in Granville County, NC in 175... He was listed as  
a private in Vapt. Benjamin Sim's Company, on the Muster Roll  
of the Regiment of Col. William Eaton in Granville County, NC  
on the 4th of October 1754. Charles Ivey 3/, a planter & the

brother of Henry Ivey 3/, purchased 400 acres of land for 35 pounds, witnessed by brother Henry Ivey 3/. On the 11th of March 1760, William Russell sold to Charles Ivey 3. for 20 pounds, 313 acres of land on Little Beaver Creek at Ivey;s corner and Fike's line."

Peter Ivey 3/, thought to be a son of Gilbert Ivey 2/, was listed in Court Minutes of Granville County, NC as being involved in a suit with Francis Parker on 7th September 1756.

Henry Ivey 3/ had a wife named Mary. He was listed on the Tax List of Granville, NC in 1775. Family records state that Henry Ivey was born in Surry (Sussex Co.) Va.

Henry Ivey 3/ was listed as a Drummer on the Muster Roll of Capt. Benjamin Sim's Company, the Regiment of Col. Wm. Eaton in Granville County, NC on 6th October 1754.

On the 4th of March 1752, Samuel Lanier of Duplin County, NC, sold to Henry Ivey 3/ of Granville County, NC, 250 acres for 15 pounds, it being part of land granted to Lanier for 500 acres on the north side of the Tarr River on Ivey;s Swamp, granted 20th June 1749. This 250 acres was between Henry Ivey 3/ & James Ross on Rocky Branch.

On the 9th of November 1761, Henry Ivey 3/ and wife Mary, sold to a GREEN HILL 440 acres for 160 pounds, in Granville County, NC on Fox Swamp, 190 acres were granted to Ivey (part of?) 300 acres granted 20th April 1745.

Many years of research have failed to give us one good clue as to the parentage of GREEN B. HILL. Tradition from Mary Hill of Waco, Texas (now deceased) states the following: (1) Green B. Hill was well educated. (2) He owned the land Atlanta was built on. (3) Green B. Hill grew cotton for Eli Whitney's first cotton gin. (4) Green B. Hill was a cousin to Benjamin Harvey Hill, the "silver tonged orator" and senator of Georgia.

Answers to above: (1) Green B. Hill always signed his name with a "X." (2) The land belonged to Hardy Ivy. Years of study could find no connection to Lott Ivy. (3) It was grown on the plantation of Major General Nathaniel Green. Years of study reveals no connection to him. (4) Ben H. Hill was the son of John Hill & Sarah Parham. John was the son of Isaac Hill.

Isaac Hill had 14 children by his first wife Lucinda Wallace. Isaac Hill was born 22 July 1748, in North Carolina and died 28 July 1825 in McMinnville, Tennessee. This information including a beautiful chart came from Mrs. John D. Meador (deceased) of 254 W. St. Flo Clair, Mobile, Ala.

Note by R. Hill: I think the above is partly wrong! Isaac Hill was born in Maryland, son of Abraham Hill 1/. He moved to Edgecombe County, NC before coming to Georgia. He was a "drummer boy" as a youth in the Revolution.

May Hill of Forsythe, Georgia claimed to be a descendent of Green B. Hill of Monroe, Georgia. She claimed that he was a son of Isaac Hill (above) but had no proof. Green B. Hill of Monroe County, Georgia moved to Houston County, Georgia. (Note: this was not the same Green Hill m. into the Ivy family).

Answer: This Green B. Hill never had a deed or any other document we have found, where a Hill, other than his own children, signed. He had many documents signed by his Father in Law, Lott Ivy, Lott's sons and sons in laws. This makes me feel that his parents were dead or far away.

Lois McCoin, 3020 E. Houston, Paris, Texas is a descendent of Elizabeth Hill and Elisha Walden. I just located her in March 1985. She has sent a copy of an old history. "My information about Elizabeth being the cousin of Senator Ben Hill. This from a family history written and researched by a Great-uncle of mine who was the grandson of Elisha Walden and Elizabeth Hill. He did not document his information and this history was completed in 1928. You will be interested in knowing that this is a treasured document. Uncle Charlie Cain sent this copy to my grandmother. I never saw it until 1943 when my father brought it to me, the only thing that was left from the fire in my grandparents house that burned and they were unable to get out of the house. You can see the burned part even in my copy." History quoted with original spelling:

HISTORY: Elisha Walden was born July 22, 1793 in Virginia. Little is known of his early boyhood days. He was in the War of 1812. and moved to the state of Georgia about 1820 and settled in the woods, about 12 miles south of where Atlanta, Georgia is now and engaged in farming until his death. There was borned (sic) to him and his wife Elizabeth Hill twelve children of which four boy's served in the Confederate Army. Two son-in-laws, three of his own sons ware killed are died in the service, and both son-in-laws were killed in action. John D. Walden was killed at the battle of Gettysburg, July 1862. John D. Walden was killed at the battle of Atlanta 1864 and Tom Johnson was killed near Chattanooga, Tennessee May 14, 1864. Lige Walden died of fever on his way home from Virginia November 4th 1861. Dan Walden was wounded at the Battle of the Wilderness in Virginia in 1863 shot in the head and has never got over it. Frank Walden was killed at the battle of Chickamauga, Georgia February 27th, 1863. Tom B. Walden was killed at the Battle of Atlanta, Georgia June 22, 1864.

Most of the Waldens are buried at the old Bethsady (sic)

Church about 12 miles south of Atlanta, Georgia. Elisha Walden was of English parents but little is known of his people. His wife was Elizabeth Hill, she was Swede decent and was a cousin to Senator from Georgia, Ben Hill. The old house is still standing where the family was all raised. It is a log house with three rooms down stairs and two on the second floor." (Quoted from History).

With this new tradition from families that have been apart for close to 100 years, I feel that we must go back and search the family of Isaac Hill, who was the grandfather of Benjamin Harvey Hill.

New Information from Ralph Willis of Cullowhee, N.C. and from Mary Teal of Union City, Georgia have proven that Isaac Hill was the son of Abraham Hill, born 1698 and died 1760 in Charles County, Maryland. His wife is unknown. His children were Henry, John, Asa, Benjamin and Isaac Hill. At least Benjamin came to Jasper County, Georgia early. I feel that these are the men we need to trace.

If our Green B. Hill was the nephew of Isaac Hill of Jasper County, Georgia, that would make them second cousin to Benjamin Harvey Hill.

Comment by Robert Hill: I question Green B. Hill's connection to the Hills of Surry Co., NC. It was not the same Green Hill. That Green Hill went to Raleigh, NC.

For many years I did not accept this as our Green B. Hill, but his next door neighbor was Littleton Meeks, a known relative of Lott Ivey. Green B. Hill had no deed here but his neighbors were living very near the land Lott Ivey got as a land grant in 1793 of 106 acres, both sides of Conross Creek of Keowee River.. I think Green and Martha married

about 1795, probably in Pendleton County, South Carolina.  
Other Hills in 1800 Pendleton County S.C. Census were:  
Henry Hill and Isaac Hill and many others.

It also says "except" one due bill on Green bearing date of 6 August 1812 for \$ 285. (This has to be our Green Hill and refers to the land be bought on that date). LVP Estate appraised 19 December 1812 by John Black, James Ponder and Green Hill.

Gallaher, Fort Hawkins.

found guilt and to pay half the costs. We have not found our Green B. Hill in the 1820 Census. He was in Jasper County, Georgia on 5th December 1819 to sign a deed. He was in Jasper County on 30th July 1822 for a deed but not in the census. There were many Green Hills in the 1820 census. We have checked out all but two: (1) Green B. Hill in Alabama Territory. (Maxine Jones thinks this is the one). (2) Green B. Hill in Maury County, Tennessee. (Gordon and I feel that this could be ours. He has a lot of boys about the age of our Green B. Hill's sons). It is possible too that the page with this family is missing. The only Hills in Jasper in 1820 besides B.B. were James A. Hill and John Hill.

(I am quite sure that the John Hill was the father of Benjamin Harvey Hill, who our people claim were relatives... no proof yet) LVP

He makes declaration for the purpose of obtaining bounty land according to act passed 23 September 1850. (Photo Copy from General Services Admr., Wash. D.C. Warrant No. 3725).

Green B. Hill was born ca. 1774 and died after 28th November  
1854 and before 24th December 1854. (Martha signed a deed  
28th November 1854. Green B. and daughter Mary left the  
Bethaida Church without Martha on 24th December 1854. They  
were going to Alabama. Bethaida Church records sent by Mary  
Teal.

Comments by Robert Hill of Brandon, Fl.: I question the  
accuracy of the above statement that Green B. Hill died  
BEFORE 24 December 1854. A copy of that deed is needed to  
see if Green B. Hill was alive or signed the deed. How could  
he have died AFTER 28th November 1854 and YET LEFT "The  
Bethaida Church without Martha on 24th December 1854," almost  
30 days AFTER he was supposed to have died. Something isn't  
right here!

Male under 10 in the 1800 census of Pendelton Co., S.C. (This  
could be Greenberry Hill of Houston Co., Georgia married 1st

William C. Hill born 22 November 1800 Surry County, N.C. He  
married 30th January 1825 to Mary Kirk in Jasper County,  
Georgia and died 11th November 1881 in Heard County, Georgia  
Comment by R. Hill: I question him as a son of Green B. Hill

Mary Hill, born ca. 1803 in Georgia, unmarried, died ? (last  
found in Winston Co., Ala. in 1870 Census).

Winifred Hill, born ca. 1805 (where ?, probably Georgia)  
married 16 August 1818 to Joseph S. Johnson, Jasper County,  
Georgia, last found in 1870 Census of Clayton County,  
Georgia.

Comment by R. Hill: If true, she married as a 13 year old daughter. Possible but questionable. I know the gals married early in life.

Elizabeth Hill, born 31 July 1808 in Georgia, married on 8th March 1829 to Elisha Walden in Jasper County, Georgia, she died 27th January 1891 at Clayton County, Georgia.

Isariah or Azeriah Hill, born ca. 1809 in Georgia, married 20th October 1830 to Mary or Polly Martin in Jasper County, Georgia, he died ?? in Mississippi.

Ivy Hill, born 6th November 1810 in Randolph County, Georgia, later Jasper County, married 27 October 1830 to Lucy Jones at Jasper County, Georgia. He died 22nd August 1886 in Cass County, Texas.

John A. Hill, born ca. 1812 in Randolph, later Jasper County, Georgia, married 14th March 1840 to Mary Howard, Fayette County, Georgia. He died 28th August 1864 at Clayton County, Georgia.

MARTIN HILL (Baptist Minister) born ca. 1815 in Jasper County, Georgia, married 1st 23rd November 1837 Ann Tomlin at Fayette County, Georgia; 2nd marriage to Sarah C. Hansen in Randolph County, Alabama in 1882. He died 1891.

Green B. Hill and Martha had two little boys who lived with them. It is very likely that they were grandsons.

HENRY HILL, born ca. 1820 married Rebecca Overton on 1st October 1841. Was in Winston Co., Alabama in 1880 Census.

Benjamin Hill, born ca. 1822, married Rebecca Overton on 18 July 1845 in Fayette County, Georgia and they too were in Winston Co., Ala. in 1880 Census.

Question by R. Hill: Was this the same Rebecca Overton and the two brothers married the same woman only 4 years apart?

One last comment by Robert Hill: I have no proof but I strongly suspect that the father of this Green Berry Hill was a Henry Hill and I suspect his (Henry's) origins were in Maryland & had moved to Virginia by time Green Berry Hill was born between 1770-1775.
