ISAAC HILL 1/.

Genealogy of the Isaac Hill Family of Monroe County, Ga. & Stewart County, Ga.

ISAAC HILL 1/ is believed to have been born ca. 1775 and his birth was in the town of Halifax, Halifax County, North Carolina. He married Courtney Mourning Braswell in 1797. She is believed to have been born in Raleigh, N.C. and had a sister named Toppin Braswell, who married a Richard Hill of Nash County, N.C, may be a brother. (Ref. Deed Book 7, Page 187). Isaac Hill & Richard Hill are thought to have been brothers.

These two sisters were the daughters of William Braswell (d. on 14 November 1803) & Milly Braswell. It is likely that Richard Hill & Isaac Hill 1/ were brothers but this has not been proved as yet. Isaac Hill 1/ & his wife Courtney later moved to near Forsyth, Georgia.

Following from Mrs. Kate Hill LaMarr:

Isaac W. Hill 1/, born in Halifax (TOWN) N.C. His father moved there from Virginia. Isaac W. Hill 1/ moved to Georgia after the Revolution, with his wife Courtney Braswell and Larry Manning of Virginia, who married Anne Penelope Braswell, for whom Anne Penelope Hill 3/ (daughter of Green Hill 2/) was named. Larry Manning was at school at Virginia College (Williamsburg) and was conscripted into the Revolution.

Isaac Hill 1/ taught school through South Carolina and in this way came to Georgia and bought land. Courtney and Penelope Braswell's mother was Milly Culpepper of Culpeper Court House, Virginia. Braswell was a Dutch name. The youngest brother of Green Hill 2/, Isaac Lewis Hill 2/, has the family bible. One of his sons, Frank Hill 3/ was an editor and lived in Americus, Georgia.

A daughter, Molly Hill 3/, lives in Georgetown, Georgia. A later letter from Molly Hill in 1922 stated she had the

Family Bible.

The known children of Isaac Hill 1/ & Courtney Mourning

ISAAC HILL 1/ (IN GEORGIA)

The first record of Isaac Hill 1/ in Monroe County, Georgia was found in Deed Book A (1822-1823), Page 219; where James W. Sikes of Gwinnett County, Georgia sells to Isaac Hill of Jones County for \$ 300.00 Lot #242 (202 1/2 acres), 6th District, Monroe County.

The 1850 Census of Monroe County, Georgia shows Isaac Hill 1/, age 75, born in N.C. living alone. Isaac L. (Lewis) Hill 2/ is shown living next to him, probably on his father's farm land, as deed records do not show Isaac Lewis Hill 2/ ever owned any property in Monroe County. It has also been shown that Isaac Lewis Hill 2/ later lived in Jones County, Georgia.

Other Land Transactions by Isaac Hill 1/ in Monroe County, Ga.

Vol. D-E Page 90, Lot # 20 in 13th District from Theophilus Williams for \$ 900.00. Recorded 3rd June 1825. This was later sold to William B. Hill for \$ 500.00, recorded 30th September 1836.

Book H. Page 176, Lot # 189 in 4th District, from Turner Hunt, Sheriff for \$ 50.00 (this only) 1/4 lot-50 Acres)- no record of sale.

Vol. I, Page 19, Lot # 52 in the 12th District (202 1/2 acres) and Lot 208 in the 6th District (30 acres) for \$ 1600.00 from D.C. Wallace, recorded 12th November 1834. These properties were given to Darden Hill, Deed Book N, Page 47, "for love & consideration of affection which I bear to my son Darden." Recorded 20th July 1852.

The son, Isaac Lewis Hill 2/, stated on his application for bounty land, that he was born in Jones County, Georgia in 1814, placing Isaac Hill 1/ & wife in that county in 1814. Isaac Hill 1/ wrote his will on 8th April 1852 and made following bequests:

To son Greene Hill, his Negro man called Sabra's George.

To son Durden (Dirdin OR DARDEN?) Hill his Negro man called Little George and George's wife Emily and her three children and also the land whereon Darden now lives and the Negro man Dan that he now has and also old Sabra..

To Ivy Brooks, daughter Eliza Ann, a Negro girl called Ag's Emily.

Land and one Negro man called Man to be sold and \$ 200 out of that to be given to sister, Nancy

Matthews. The balance after paying all debts to be equally divided between sons William B. Hill and Dirdin Hill.

At first it appears that Isaac L. Hill was not mentioned in his father's will but note the name of Lewis Hill. This was Isaac Lewis Hill.

ISAAC LEWIS HILL 2/

Isaac Lewis Hill 2/, born 24th December 1814 in Jones County, Ga. He m. 1st Emily Jane Stewart on 29th March 1819 in Monroe County, Ga.

Isaac L. Hill 2/ had recently returned from service in the Creek War, was over 21 yrs of age and was married a year and a half later. Also he was mustered out of the army at Fort Garry in Northwest Florida.

The main route home from this point was up the Chattahoochee River and then eastward from Fort Gaines on the Jackson Trail, to the stage stop, Travler's Rest, and eastward on the old National Road or Federal Road, which ran from Fort Hawkins through what is now Columbus, Georgia. This route took him through Stewart County, which caused him to later settle here.

ISAAC HILL 2/

Isaac Lewis Hill 2/, in his application for bounty land earned for service in the 1836 Creek Indian War, states he was born on the 24th December 1814 in Jones County, Georgia, thus placing his parents, Isaac Hill 1/ & wife Courtney Hill, in Jones County by 1814. Now Jones County was created from Baldwin County on 10th December 1807 and Baldwin County was created and settled by the Georgia Land Lottery of 1805 and 1807.

From the 1850 Census, Mary Hill, the third child of Isaac 1/ & Courtney Hill, was born in 1804 in North Carolina, too late to have participated in either lottery. Persons who did draw lots in these lotteries, however they were required to only pay a small fee (about \$ 20.00) and the lot of 202 and 1/2 acres was theirs to keep or dispose of as they wished.

Additional research is needed to reveal exactly when they arrived in Jones County, Georgia and where they lived before moving to Jones County.

MISCELLANEOUS NOTES: From Mrs. Florine Hill Palmer in 1922:
Isaac Hill's (1775-1852) father had important papers and information during the Revolutionary war. The Tories strung him up to a tree three times to try to make him divulge this information. He told them he was willing to die for his country. They finally turned him loose after torturing him; he was too important a person to hang. This was told to me by my grandfather, Green Hill, when he said to me, "My child, you come from an honorable parentage, notably honest people," then laughing, "not one of us has ever been hung, but my grandfather came very close."

My grandfather, Green Hill 2/, married 1st Mrs. Elizabeth Manning Smith and he told me that he met his handsome young cousin for the first time about a year after the death of her husband, Mr. Smith and that it was a case of love at first sight and they were married. For years they lived in Monroe County, Georgia, where several children were born. Elizabeth Manning (Smith) Hill owned the home at Cedar Hill (Houston County, Ga.). I do not know how much land. Green Hill added to her acres until they owned a large body of land in Houston County. He had an overseer on this place, and finding the land very productive, moved his family there, where he built

a beautiful home surrounded by wonderful native and virgin trees, shrubbery and a great variety of flowers.

Katie Smith, ward of Green Hill 2/, and his granddaughter, was a rich young woman and with her beauty and charm had many offers of marriage. After Green Hill 2/ became her guardian, she lived with him at Cedar Hill, went everywhere with him, and was a great joy to him in his declining years.

Green Hill 2/ had a sharp memory, wonderful energy and was a Presbyterian (Here the document ends abruptly).

INFORMATION ON THE CHILDREN:

1. Isaac Lewis Hill Jr. 3/ fought in the Civil War, was wounded in the ankle, captured and stayed in prison until the war ended. After the war he lived in Germantown, Georgia where he married a Miss Morris. They had one daughter, Claude Hill, who married a Mr. McKenzie. One daughter was born to them, Glaude (Claude?) McKenzie II. Isaac Hill Jr. died in 1874. Both he and his wife are buried in Georgetown, Georgia.
2. Robert Green Hill 3/ fought in the Civil War in the same regiment as his brother Isaac. He was killed at Ft. Harrison, Virginia.
3. William R. Hill 3/ fought in the Civil War. He never married. He moved to Terrell County, Georgia after the war. He died in 1918 and is buried in the Chickawawhatchee Cemetery, Terrell County, Georgia.
4. James Lewis Hill 3/ married Miss Lula Foster and moved first to Georgetown, then to Butler County, Alabama. James died in Georgiana, Alabama and is buried there. His children:

13. Andrew Jackson Hill 3/ moved to Terrell County, Georgia in 1891 and married in 1897 to Clementine Harris (b. 17 July 1870-d. 21 October 1940). No children. Andrew Hill died on 21st August 1933 and he and his wife are buried in Cedar Hill Cemetery, Dawson, Georgia.
14. Emma Hill 3/ married ca. 1894 to Judge R.A.J. Boyette of Morris Station, Georgia. They had one son, Walter Hill Boyette, b. 1897. Emma died ca. 27th November 1900.
