Theophilus Hill married Amy McLendon Wilkes. At his death, she married William Castillo. They later moved to Georgetown, Georgia and then to Eufaula, Alabama.

Amy Hill & Isaac McLendon were administrators of the estate of Theophilus Hill, January 7th, 1811.

This may have some bearing or connection to the above Theophilus Hill, perhaps his father & mother:

May 14, 1815.

HENRY HILL & SARAH , deceased, Pewtition of their children
VIZ: Sarah, Mary Josey, & Christian Pope, being children of
said Henry & Sarah Hill, deceased, and Elizabeth, Nancy,
GREWENVERRY,, Polly, & Harriett Hill, children of Theophilus
Hill, deceased, and grandchildren of said Henry & Sarah
Hill, deceased, by their next friend, William Johnson,

Previous to March 25, 1805, said Henry Hill died, soon after,
the children above named and Theoiphilus Hill, Henry Hill
Jr., Joh & Abraham Hill , also children of said deceased,
entered into an agreement that the property left in
possession of the widow Sarah for life, that Henry Hill Jr.
should pay to the other heirs a certain sum, which he failed
to do. Said Sarah died (on) November 12, 1812, leaving a
will which made no provision for above payment etc.. said
property should be equally divided and not according to the
will.

Following may possibly relate to the above..

March 15, 1804.

Henry Hill, deceased, Theophilus Hill, administrator.

This Henry Hill Coudl be father of Theophilus Hill

IN WILL BOOK A, (PAGE 61) A Green Hill and Green Hill Jr.
Executors of Moses Parks of Franklin County, North Carolina.
Will wrote January 17th, 1797, probated October 25th 1797.

Following found in Persons County, N.C. Deed Book B, Page
126, dated 3rd March 1796:

Power of Attorney- Zachariah Hill to John McMurray Jr. to
transact all business concerning land in Wilkes County on
Clouds Creek in Oglethorpe County, Georgia, which Hill
purchased of Obediah Bosworth- 275 acres and to receive deed
to sell land.
