From Court Records

Application having been made to this Court by Henry Peddy,  
administrator on the Estate of Isaac Hill, in right of his  
wife, Penny Peddy, at May term 1818, for letters to  
dismissal from said Estate, and that having been published,  
according to law, it is ordered that said letters be  
accordingly issued to the aforesaid Henry Peddy.

An application ordered that Henry Peddy be appointed Guardian  
of the person & property of Susannah Hill, Polly Hill,  
Lucinda Hill, Patsy Hill, Isaac Hill. (No date given).

John Hill was appointed guardian of Isaac Hill, son of Isaac  
Hill, deceased. 1825.

Comments: Think this relates to death of Isaac Hill Sr 2/ who  
had m. Lydia Jones & moved top TN.

HILL RECORDS OF MONTICELLO, GEORGIA (JASPER CO.)

JASPER COUNTY

Whitmel Hill & Elizabeth Hill of Jasper County, Georgia made a deed of gift to beloved son, James Harrison Hill, minor, born 25th September 1813, a Negro girl, age about 14 years old, named Cleo.

#### HILL (Jasper County)

John & Isaac Hill appointed guardians for the person and property of Eliza & Lovice Hill, orphans of William Hill. March 4, 1816.

Comments: These orphans were two daughters of a William Hill & his 2nd wife, Lydia White Jones, who married the 3rd time to Isaac Hill Sr 2/ (not related) and who moved to TN.

Sale of Estate of Isaac Hill (deceased) on September 29, 1809.

Penny Hill appointed administratrix of estate of Isaac Hill, deceased, with Wright Hill & Richard Head, surety. August 7, 1809.

#### Court Records of Jasper County

Comments: Relates to a death of a member of the Isaac Hill Sr 2/.family.

Application having been made to this court by Henry Peddy, administrator on the estate of Isaac Hill, in right of his wife, Penny Peddy at May term 1815, for letters of dismissal from Estate and that having been published according to law, it is ordered that said letters be accordingly issued to the aforesaid Henry Peddy. (Note: Penny Peddy was widow of Isaac Hill and had remarried Henry Peddy).

An Application ordered that Henry Peddy be appointed Guardian of the person and property of Susannah Hill, Polly Hill, Lucinda Hill, Patsy Hill, Isaac Hill (Jr.)  
Was not dated.

John Hill appointed guardian of Isaac Hill (Jr.?) son of Isaac Hill, deceased. 1826.

Yearly return on the estate of Isaac Hill, deceased, for 1817. Same for Polly, Lucinda, Martha & Isaac Hill. Henry Peddy guardian. (Martha Ann Hill b. 1807 married Seth Cobb in 1823).

Yearly return on estate of William Hill, deceased, made 1st January 1816. Paid Cheadle Cochran by the sheriff according

to the decree of court \$ 138.72

Paid Benjamin Lassiter by the sheriff according to the decree of court \$ 207.60.

Cost of the suits, \$ 3.00

Allowance made by the court to me for trouble in settling the estate, \$ 100.00.... For schooling Eliza & Lovice, orphans of William Hill, deceased, \$ 3.75.

Isaac Hill in right of his wife, Lydia Hill, Admr. of estate of William Hill, deceased.

Comment: This was Isaac Hill Sr 2/ who had married Lydia White Jones Hill (his 2nd, her 3rd). The orphans were daughters of Lydia White Jones and 2nd husband, Wm. Hill (unrelated to Isaac).

#### FROM COURT RECORDS OF JASPER COUNTY, GEORGIA

(Note: I have been able to determine that this James Hill married Elizabeth Cleckler in Putnam County, Georgia in September of 1808. It is the ancestor of Marialis Hamlett, for whom I did research for).

Robert R. Hill of Brandon, Fl.

ORDERED that letters of administration on the estate of James Hill, late of said County, deceased, be granted to Cheadle Cochran and Benjamin Lassiter, and Martin Cochran became their security in the sum of \$ 3000 and Cheadle Cochran was granted in terms of the law, whereon a warrant of appraisement was issued to Thomas Pennington, Lawson S. Holland, William Tucker, Jeremiah Lumsden and Samuel Thompson, to appraise said estate.

Monday January 7, 1823.

Minutes of the Court of Ordinary, Jasper County, Ga. BOOK C, January 11, 1823.

Children of James Hill, deceased, Polly and Betsy Hill, orphans of James Hill, of bountiful age, to choose their own guardian, came into court and made choice of Elijah Cleckler for their guardian and it is ordered that he be appointed their guardian and also guardian of Louisa, Matilda, and Ellington, other orphans of the said James Hill, deceased.

Eliza Hill, b. 4th Feb. 1800 in Jasper Co., Ga., dau. of Wm.

Hill & Lydia White Jones, married Isaac Hill, no date or location of marriage was given but they moved to Warren Co., Tenn.

Lovice (Louvisia) Hill, b. in 1802 in Jasper County, Ga. dau. of Wm. Hill & Lydia White Jones married Asa Hill and they too moved to Warren Co., Tennessee.

Comments: The two brides above were daughters of William Hill & 2nd wife, Lydia White Jones, originally of Green Co., GA. .

### ISAAC RHAEL HILL

Isaac Rhael Hill was born in 1803 and died in 1881. He married in Jasper County, Georgia to Cornelia Smart.

FOLLOWING IS A DEED BY MORDICA HILL OF JASPER COUNTY, GEORGIA.

DEED BOOK A, PAGE 60

State of Georgia)

Jasper County ) Know all men by these presents that I MORDICA HILL of the county and state aforesaid, being of sound mind and memory and in perfect sense, and having lost my eye sight and not able to take care of myself nor my property of any kind, and being deposed to live with my son in law, Lems (sic) Peacock and he having agreed to take care of me during life, and I feel it my duty to give him all that I possess, both real & personal, now know ye that I the said MORDICA HILL as aforesaid do hereby give, grant and bequeath unto the said LEMS (sic) PEACOCK, to him and assigns all the real & personal property that I possess, that is to say, all that tract or parcel of land situated lying and being in the 7th District of original BALDWIN COUNTY but now in JASPER COUNTY and known by part of Lot 27 in the district aforesaid and containing Sixty Acres (60 acres) of land, more or less, together with one Negro woman named PRISS about 50 years old, one cow and calf and all my hogs, one bed and

furniture and all my working tools of all kinds, together with all papers, debts, dues and demands, due one from all persons WHATSOEVER..

In Witness whereof I have hereunto set my hand and affixed my seal by making my mark in the presence of the under named persons, this Third day of September 1822. (3 Sept. 1822).

#### INFORMATION ON IVY HILL AND WIFE, LUCY JONES

Ivy Hill, son of Green Berry Hill and Martha Ivie Hill, was born on the 6th of November 1810, in Randolph County, Georgia (now Jasper County). Ivy Hill grew up in Jasper County and later married Miss Lucy Jones on the 27th of October 1830 in Jasper County, Georgia. .

It is said that their romance was difficult because the Jones were of the Methodist religion and had large slave holdings. The Hills were of the Baptist faith and did not believe in slavery.

Lucy Jones was the daughter of William Jones and Emelia Hurd Patterson. Lucy slipped away from home and joined the Baptist church, because she wanted to marry Ivy Hill. She was almost disinherited for this act against her family, however a forgiving father and mother finally accepted it. They were married on the 27th of October 1830 by the Justice of Peace named Elisha G. Crawford.

Ivy & Lucy Jones Hill moved from Jasper County, Georgia in January of 1835 and moved about 30 miles southeast of Atlanta, into Fayette County, Ga. They remained there until 1848 they moved to Randolph County, Alabama then later to Clebourne (sic) County, Alabama.

In the fall of 1870, a group of families led by an able

leader named IVY HILL, left Claiborne County, Alabama, crossed Alabama, Mississippi, Louisiana and arrived in Cass County, Texas on the 1st of December 1870.

They purchased land that was thick with pine trees that had to be first cleared before crops could be planted. Several saw mills in the area were beneficial to them. Lucy Jones Hill seems to be remembered as the community doctor. She went about on an old mule with a medicine bag to aid others.

Ivy Hill died in Cass County, Texas on the 22nd of August 1886, just 76 days shy of his 76th birthday.

Lucy Jones Hill was born in Jasper County, Ga. on the 3rd of June 1813 and died on the 16th of June 1900 in Cass County, Texas at the age of 87 years. Both are buried in Watson Cemetery, located near the place they settled in Cass County, Texas, now the Huffines Community. They had eighteen (18) children.

1. Martha Emily Hill, born 10 December 1831, died 26 February 1904, married Daniel F. Hyatt on 6 February 1847.
2. William Green Hill, born 9th October 1835, died 14th August 1917, married Savillia Bale.
3. Mary J. Hill, born 23rd July 1837, died 6th November 1837.
4. Amelia Permelia Hill, born 1st October 1838, died 29th September 1900, married Josiah Hollingsworth Waites.
5. Seaborn Jones Hill, born 11th January 1840, died 1908, married Martha Jane Clark in 1861.
6. Maranda E. Hill, (a twin) born 10th September 1841, died 15th March 1919, unmarried.
7. Amanda M. Hill, (a twin) born 10th September 1841, died 28th November 1841.
8. John Simon Hill, born 14th June 1843, died 15th December 1913, married Charity Daniel.
9. J. K. P. Hill, born 9th November 1844, died 18th July 1845.
10. Francis Patterson Hill, born 18th November 1845? (1847?), died 22nd August 1913, married Martha Ann Rachael Witt in November of 1865.
11. Abner Madison Hill, born 20th December 1846, died 27th February 1928, married Margaret L. Putman. He fought in

the civil war (CSA). Went to Texas with parents and his wife and five children.

12. Nancy Emaline Hill, born 30th March ???, died 6th January 1924, married Cage (Page?) Harris Daniel on 22nd December 1862.

13. Lucindie Hill, born 11th May 1849.

14. ? M. Hill, born 18th September 1850, died 20th November 1850.

15. Queen Victoria Hill, born 2nd March 1852, died 21st May 1883, married ? F. Daniel on 18th August 1872.

16. Jasper Hill, born 19th June 1853, died 19th July 1853.

17. Lettie A. Hill, born 30th April 1854/55?, died 21st November 1855.

18. J. C. Hill, born 8th June 1857, married Mollie Morgan.

### WILLIAM N. HILL

Elisha Hill, born in 1780 in SC was father of William N. Hill. Elisha Hill died in Fayette Co., Ga in 185? He was listed in the 1830 census on page 191 as being 50 years old (b. ca 1780) with seven children. No wife was listed. In the 1840 census, he was listed as 60 years old (b. 1780) with four children and a wife 50-60 years old. In the 1850 census, Elisah Hill and his wife Elizabeth, appear to be living with their daughter, Sarah A.H. Hightowerm age 28 and her adopted daughter, Amanda, 11 years old. They are listed on the same page as a Lucy Hill was, age 46 and (possibly) a daughter, Mary E. Hill, age 11.

Elisha Hill is known to have had a son, John W. Hill, who was born on 15 January 1812 in SC & died in Cobb Co., Ga in 1884.

William N. Hill (son) was born in 1818 in SC & died in Fayette Co., Ga. His will was probated on 1st March 1858 in Fayette Co., Ga.

Fayette Co., Georgia records shows William N. Hill married Sophronia Milner on 22nd September 1846. Another marriage for him was listed on 18th March 1849 to Mary Ann Kelly. The dates of these two marriages shows that the first wife, Sopjronia Milner died sometime prior to 18th March 1849.

The 1850 census of Fayette Co., Ga. shows William N. Hill

was 34 years old (b. ca. 1816) in SC with a wife Mary A. Hill, age 18 (born ca. 1832) Children were listed as Martha Hill, age 8 (b. ca. 1842) & Mary Hill age 1 & 1/2 (meaning 1 year 6 months so birth was about middle 1848).

Records shows that the daughter Martha Hill was adopted. To me, I think she was perhaps a daughter of Sophrina (maybe by a previous marriage). I think the daughter Mary Hill also was Sophrina's, who probably died as a result of child birth (but not proved).

William N. Hill's name appears on numerous records, indicating he was a financially active citizen.

The records clearly shows that William N. Hill was boarded in the State "Lunatic Asylum" from 27th September 1857 until the 4th of December 1857. it is thought that he died on this last are.

His will was probated in Fayette Co., Ga. on 1st of March 1858, so death probably took place on 4th December 1857. Named in the will was a son John Calvin Hill, two daughters, Martha Ann (adopted) & Mary Elizabeth Hill, his brother John W. Hill & a brother in law, Elias W. Story (of Alabama).
