ISAAC W. HILL 4/.

The father of Isaac W. Hill was originally from Chowan County, N.C. but moved to Wake County, N.C. when Isaac Hill was about 6 years old or about 1767. Who was his father? Lets look into this matter.

Based on North Carolina records, it appears that Isaac W. Hill's paternal grandfather was Henry Hill 1/ (1670-1719) originally of Nansemond County, Va., but who died in Chowan Co., N.C. His paternal grandmother was Mary (Hinton?). One of the children of Henry Hill 1/ was a son named Abraham Hill 2/ (ca. 1697-ca. 1760). He married Judith Hunter (b. 1708 in Chowan Co., N.C.)..

Records show that it was Abraham Hill 2/ that was originally of Chowan County, N.C. and who later moved his family to Wake County, N.C. First thought was the he was the father of Isaac W. Hill, but not so.

Abraham Hill 2/ and his wife Judith had six known children:

- Henry Hill 3/, b. 1730, m. 1756 to Sarah Cotten, d. in Ga. in 1804, had 8 children but no son named Isaac Hill. 3/.
- Abraham Hill 3/, b. 23 Apr. 1732, m. 1756 Christian Walton, d. in 1792 in Ga. They had eleven children, but no son named Isaac Hill 3/.
- 3. Isaac Hill 3/, b. 1734, m. Nancy Evans. No listing of children has been located.
- 4. Theophilus Hill 3/, b. 1737, m. Teresa Thomas in 1762.
- 5. Sarah Hill 3/, b. 1739, m. Jacob Hunter.
- 6. Mary Hill 3/, b. 1741, m. to a Mr. Easton.

With this listing it proves that Abraham Hill 2/ was not the father of this Isaac W. Hill, and reviewing the children of

Henry Hill 3/ and Abraham Hill 3/ shows they too were not the father of this Isaac W. Hill 4/.

Therefore the suspicion is that it was either Isaac Hill 3/ and wife Nancy Evans or his brother Theophilus Hill 3/ and his wife, Terese Thomas, that were the parents of this Isaac W. Hill 4/. This has yet to be confirmed.

Isaac Hill 4/ was a Revolutionary Soldier, enlisting in 1780/81 at age 16 from Wake County, N.C.. He filed an application for a pension (W-3812) for his service and stated in his application that he was born on 10th February 1761 in Chowan County, N.C. but moved to Wake County at age of 6. He moved to Clark County, Georgia and married Nancy Crane in Wilkes County, Georgia in March of 1784. The widow, Nancy Crane, was alive and living in Clarke County on 14th October 1844. Isaac W. Hill 4/ died on the 15th August 1833. His will was dated 9th November 1829 and probated on 7th October 1833.

Abstract of Will of Isaac W. Hill 4/, of Clarke County, dated November 9, 1829 Georgia: Named, Wife was Nancy Crain (Crane?) Hill. He left bequests to son Middleton Hill 5/: grand daughter Almeda (Hill) 6/, the daughter of his son Isaac Hill 5/; to his son Roderick Hill 5/, daughter Ellender (Hill) Hopkins 5/; daughter Charlotte (Hill) Burney 5/; daughter Olivia (Hill) Harve 5/; wife Nancy (Crain); to Elizabeth Lane, Sallie Hill, Catherine Olwe, Nancy Beavers, the children of his daughter Eleanor Hopkins, to the children of Charlotte Burnery, and daughter Olivia Harve etc..., daughter Eudocia W. Anderson. Part of the will reads: "Be it remembered that I have drawn a tract of land in the County of Muscogee when drawn, which I drew as a Revolutionary soldier and not intended to be included in the foregoing request. It is my will that the said tract of land be sold after my death."
