Executive Department Monday 20th March 1809 ORDERED That passports through the Creek Nation be prepared for Moses Hill and his son, Sterling (Hill), which was presented and signed (384).

Executive Department Saturday 14th April 1810

On application ORDERED

That passports be prepared for the following persons to travel through the Creek nation of Indians, to wit-one for Anthony V. Carr from the County of Laurens-One for James Daffin with his wife & two children and two children from the county of Wilkinson- One for MOSES HILL from the County of Jones, with his wife and two children, which were presented and signed (543).

## ISAAC LEWIS HILL

Isaac Lewis Hill, in his application for bounty land earned for service in the 1836 Creek Indian War, states that he was born on 24th December 1814 in Jones County, Georgia.

He was the son of Isaac Hill Sr. & Courtney Braswell Hill, thus placing them in Jones County in 1814. Now Jones County was created from Baldwin County on 10th December 1807 and Baldwin County was created and settled by the Georgia Land Lottery of 1805 and 1807.

From the 1850 Census, Mary Hill, third child of Isaac Hill & wife Courtney, is listed as having been born in 1804 in North Carolina. Now allowing some time in South Carolina, they probably did not arrived in Georgia before 1807, too late to have participated in either land lottery.

The 1820 Census of Jones County lists Isaac Hill, over 45 yrs; and the following number residing in his house: 2 males 18-26 yrs., 1 male 16-18 yrs., 2 males 10-16 yrs., 1 male 0-10 yrs., 1 female 18-26, 1 female 16-18. 1 female 10-16, 1 female 0-10 and another entry no readable.

In 1808, according to the Deed Books of Jones County, Ga., we find the names of John Hill listed and of Craven County, Ga., & a Thomas Hill.
