INFORMATION ON A MAN NAMED (JOHN?-JAMES?) MOUNTAIN HILL

Source of this Information: My very brief research & data from Mrs. Sue Kitchens of Fort Myers, Florida in June of 1992.

Comments from Robert Hill: My suspicions are that this

family probably had its origins from the Adam Hill-Isaac Hill family of N.C.

Mrs. Kitchen states that the information provided on Adam Hill Sr. 1/ & Jr. 2/ (below) came from Mrs. Huntsinger (now deceased) of Logan, Utah.

Mrs. Kitchen's information states that there was a man named Adam Hill Sr. 1/ who died in Warren County, Georgia on the 3rd of October 1794. She states that Adam Hill Sr. 1/ had two known children, Mountain Hill Sr. 2/, born ca. 1755-1760 in Warren County, Georgia and Adam Hill Jr. 2/ born ca. 1794 (was 56 in 1850) and who died at Cassville, Bartow County, Georgia on 30th November 1860.

Mrs Kitchens stated that Mrs. Huntsinger also stated that Hill families were found in both Cass & Bartow Counties of Georgia. She states that two Hills found on Confederate Rosters were Mountain T. Hill & Henry Hill, both sons of a Mark Hill & Mary Sheffield Hill.

There is some sketchy information that Mountain Hill Sr. 2/ was actually named either John or James Mountain Hill 2/, but this needs to be confirmed.

Mountain Hill 2/ was born ca. 1755-1760 and his first wife was named Elizabeth--? however another source, Mrs. Charlotte S. Winsness of Doraville, Georgia states that this Mountain Hill was born ca. 1775 in Warren County, Georgia, married ca. 1800 and he died in 1827 in Warren County, Georgia.

Mrs. Kitchens states that they may have married ca. 1776-1782. She also states that they were members of the Baptist Church. Mountain Hill & wife Elizabeth are said to have had ten (10) children. (Listed below).

Fielding Hill 7/ was son of Thomas G. Hill 6/ & Phebe Brantley, and Thomas 6/ was son of Richard Hill 5/ & wife Frances, originally from Johnson Co., NC. Richard 5/ was a son of Thomas Hill 4/ & Sarah Etheridge, of Halifax Co., NC, who was son of Robert Hill 3/ & wife Tabitha of Halifax Co., NC.

I strongly suspect that the Robert Hill, of Warren Co., Ga., was a grandson to this Robert Hill 3/ of Halifax Co., NC, possibly being a son of Abner Hill 4/, Green Hill 4/ or a Sion Hill 4/, ALL sons of Robert Hill 3/ of NC.

POSSIBLY LINKING HILL-CHAPMAN FAMILY OF WARREN COUNTY, GEORGIA TO THE ROBERT HILL 3/ FAMILY OF HALIFAX COUNTY, NORTH CAROLINA.

Source of following: My research & comments are based upon data that was sent to me by Mrs. Wilson Hamlett of Albany, Georgia.

Comments by Robert R. Hill of Brandon, Fl.: Robert Hill 3/ of Halifax County, N.C. had a daughter named Tabitha Hill 4/ that married David Chapman and one of their children was a son named Abner Chapman 5/ (5th generation of Hill lineage) who is said to have been in Warren County, Georgia in 1801. I think that the Abner Chapman in Warren County, was a son of John Chapman 5/, brother to the above Abner Chapman 5/. I admit the possibility of being wrong on this theory.

This Asa & Tabitha Chapman are thought to connect into this Chapman family of Chatham & Halifax Counties of North Carolina and into the Robert Hill 3/ family, also of Halifax County, N.C., possibly through Robert Hill 5/, a son of either Sion Hill 4/, Green Hill 4/ or Abner Hill 4/, ALL were sons of Robert Hill 3/.

I am inclined to lean towards Abner Hill 4/, as being the connecting factor, because he is known to have been in Chatham County, N.C. in 1771 when Chatham County was formed, which is where his sister Tabitha Hill 4/ & husband David Chapman lived; his sister Ann Hill 4/ m. John Steed, sister Agnes Hill 4/ m. Charles Harrington lived, sister Larana Hill 4/ m. Drury Harrington lived, brother William Hill Sr. 4/ and wife Charity Lewis ALL lived. Not only that, members of the Brantley and Lassiter families also lived.

A Henry Hill of Warren County, Georgia named Asa Chapman, Tabitha Chapman and friend Abner Chapman in his will, dated 8th August 1801, showing some type of relationship with the Chapman family. Who were the parents of this Henry Hill?

Asa Chapman & Cynthia Lockett married on 4th July 1807 in Warren County, Georgia. Asa Chapman had a son named Henry Hill Chapman. Henry Hill Chapman's grandfather was named Alford. (Ref: Asa's Will dated 7th November 1825 in Warren County, Ga.). It is assumed that the grandfather was Alford Chapman as the maternal grandfather had to have been a Lockett because the mother of Henry Hill Chapman was Cynthia Lockett, daughter of Solomon Lockett.

WILL OF HENRY HILL (of Warren County, Ga.)

In the name of God, Amen, I HENRY HILL being weak in body but of sound memory, blessed be God, do this Eight day of August in the year of our Lord, One Thousand Eight Hundred and One (8th August 1801) make and publish this my last will and testament in manner following:

Also I give and bequeath to TABITHA CHAPMAN my house and bed and all the money that I am possessed of by Book Accounts or any otherwise, and I make and ordain my Trusty and beloved friend ABNER CHAPMAN the Executor of this my last will & testament and I do hereby utterly revoke disannul all and every other former testaments, wills and legacies by me in any ways named, ratifying and confirming this and no other to be my last will and testament.

Comments on the above will by R. Hill: The naming of Benjamin Williams as brother is puzzling and is thought to have been referring to his "Brother in Law" who was in these times often called "brother." I would suspect that if Henry Hill was ever married it was to a Williams. It is possible that Henry Hill & Benjamin Williams were just very close friends.

Note: Benjamin Williams married Elizabeth Ivy on the 13th of June 1816 in Warren County, Ga. Martha Williams married Winfield Cosby on 28th September 1815 in Warren Co., Ga.

In N.C. David Chapman married Tabitha Hill 4/, daughter of Robert Hill 3/ & wife Tabitha. I don't think that there is any doubt that these Hills and Chapmans will eventually connect into the Robert Hill 3/ family of Halifax County, N.C., who's daughter was Tabitha Hill 4/.

The Benjamin Williams mentioned in the above will married Elizabeth Ivy on the 13th of June 1816 in Warren County, Georgia.

Another family that had connections to the Hill family in both Virginia and N.C. was the Parham Family.

Warren County, Georgia: Deed date 13th November 1814 shows Lewis Parham (& others) including Phillip Brantley, sold land adjacent to J. Bonner, to a Francis Hill & Sally Parham.

A John N. Parham, died on 12th September 1850 in Warren County, Georgia of epilepsy.

Warren County Deeds dated 26th February 1817 shows Lewis Parham selling land, also a Mountain Hill, Henry Hight, Nicholas Jones and Robert Bonner.

Note by Robert Hill of Brandon, Fla.: I do not know just how but I am very confident that this Robert Hill connects into the family of Robert Hill 3/ & wife Tabitha of Halifax County, N.C. I suspect he was a son of Abner Hill 4/, a son of Robert Hill 3/, who lived in Chatham County, NC in the 1770's and 1780's. as did the Chapmans, Brantleys and the Lassiters.

The names of his children compare very much to those of Robert Hill's 3/ children. It is possible that this Robert Hill is a son or grandson of Thomas Hill 4/, of Halifax County, N.C., son of Robert Hill 3/ & wife Tabitha of Halifax County, N.C. I have doubts of this.

I also give to my son SEABORN HILL two Negroes, one by the name of Jude, a girl and one by the name of London, a boy, one bed & furniture also the tract of land whereon I now live, containing two hundred & ninety acres, more or less, also one sorrel horse called (LAM??), the household & kitchen furniture.

Further, I do give & bequeath to my three sons, BENJAMIN HILL, ROBERT HILL JR. and ABNER HILL one tract of land lying in the County of Gwinneth and state aforesaid (Georgia), containing two hundred & fifty acres in the Seventh District, known by (N (sic) might be Number??) A HILL-BRANTLEY CONNECTION IN WARREN COUNTY, GA.

From the court records it is obvious that Phebe Brantley was first married to a Thomas Hill and had a son named Fielding Hill. She was the daughter of Philip Brantley (Ref: His 1819 Will naming her as a daughter).

Thomas Hill (Thomas G. Hill estate, dated 1st May 1794, wife Phebe (Brantley) Hill named administratrix. Surety: Richard Hill.

Note: Thomas G. Hill was Thomas G. Hill 6/, a son of Richard Hill 5/ & wife Frances, both originally of Johnson Co., NC who came to Grotgia after 1782. Richard Hill 5/ was a son of Thomas Hill 4/ & Sarah Etheridge of Halifax Co., NC, son of Robert Hill 3/ & wife Tabitha of Halifax Co., NC, son of Sion Hill Sr, 2/ & Elizabeth Spiltimber of Surry Co., Va, son of the two immigrants Robert Hill 1/ & wife Mary (Webb?), who came into Va. in 1642.

Thomas 4/ son of Robert Hill 3/ & wife Tabitha of Halifax Co., NC, son of Sion Hill Sr. 2/ & Elizabeth Spiltimber of Surry Co., Va, son of the 1642 immigrants, Robert Hill 1/ & wife Mary (Webb?).
