

GA.033 HILL INFORMATION FROM JACKSON COUNTY, GEORGIA.

Entered in January of 1994 by Robert R. Hill Sr. of Brandon, Fla.

Source of Information: Several different sources that I have collected over the past five years.

Note: This information was found under Jackson County, Georgia files but I have noticed that many pertain to other locations. The reason for this was not explained.

Miscellaneous Records of Jackson County, Georgia:

Hezekiah Terrell, Sheriff of Franklin County, to Thomas Hill of Jackson County, certain tract originally granted Josiah Woods, sold as property of Enoch Hodges, late of said county, deceased.

1798 Tax Digest:

Isaac Hill, John Hill & Nathaniel Hill, were in Capt. Samuel Kilough's Co. District (Sandy, N. Ocnee, Culeb, Middle Fork).

Jas. (James?) Hill- Capt. Wm. Hopkins Co. District
Thomas Hill -defaulter (same as above) Middle River, N. Fork etc).

Isaac Hill & Thomas Hill - Capt. Wm. Hopkins Co. District
(N. Ocnee, Middle Fork, Middle River etc).

Jackson County, Ga.?

February 1799: John Hill, commissioned to lay out road on Big Pond Fork. (what county?)

10th October 1796: Josiah Woods & wife Sally of Franklin County to ISAAC HILL of Wilkes County, Georgia, 460 acres, part of a tract of 690 acres granted said Woods in 1791. Wm. Johnson.

17 November 1797: Josiah Woods of Franklin County to Thomas Hill of Oglethorpe County, land on Barber's Creek.
Witnesses: Theophilus Hill, Abraham Hill, William Johnson.

August Court 1798: James Hill on jury.

April 1799: Thomas Hill ordered to be commissioned to keep Oconee River clear in County. (What county)?

August 1799 Court: Executor of Anthony Ollive VS Robert Campbell: Parties mutually agree to submit all matters to Jas. Pittman; ISAAC HILL; John Hampton; Thomas Johnson & Samuel Gardner.

1802: Thomas Hill rendered account to Court as overseer of the poor.

Ordinary Court, July 1802:
Isaac Hill asks to be & is released as Executor of Will of Isaac Hill, deceased, having found that the said deceased was under age at time of his death, and that he never had his property in his own hands.

4th August 1802 Swan Harden ordered to turn over the property of Austin N. & William Blackburn to Isaac Hill.
Recorded November Court 1802.

August 1802: Petition of Isaac Hill, security for Swan Harden, guardian to Austine & William Blackburn, heirs of Augustine Blackburn, deceased, believing Swan Harden to be wasting said estate, it to be taken out of his possession.
All property turned over to Isaac Hill.
