Wiley Hill of Oglethorpe County, Ga. married Patsy Pope in 1799, d/o Burwell & Priscilla Wooten Pope, his 2nd wife. He

was son of Abraham Hill & Christian Walton.

William Hill Esquire of Greene County, Ga. died in 1813, wife was named Lydia. (She was Lydia White Jones, a widow).

William Hill of Scriven County, Ga. died in 1850.

# THE FOLLOWING INMFORMATION RELATES TO ENOCH HILL 5/, SON OF WILLIAM HILL SR. 4/ & WIFE CHARITY LEWIS OF N.C.

Note: This data was sent to me by Mr. Byron Hill of Nashville, Tn. in December of 1995. He descends from Encoh Hill 5/. He and other researchers are undecided if James Harvey Hill 7/ (their ancestor) was a son of George W. Hill 6/, (b. ca. 1803 in N.C.) or his brother, William HIll 6/, (b. ca. 1816).

Comments by Robert Hill of Brandon, Fla.: Now in the 1850 census, notice that William Hill (age 49) says he was born in South Carolina. I believe this to be wrong! What bothers me is that in the 1880 census he says his (said to be father Enoch Hill 5/) was born in Virginia and his mother was born in North Carolina. Something is very wrong here! IS THIS WILLIAM HILL A SON OF ENCOH HILL 5/??

Encoh Hill 5/ is very strongly implied to have been born in Chatham County, N.C.. Enoch's 5/ father (William Hill Sr.

4/) was also born in N.C. His mother (Charity Lewis) is suspected to have been born in NC but this is not proved.
Now as I understand the Information on son James Harvey Hill, he was born ca. 1832/33, died of disease on Lookout Mountain, TN. in July 1862. (Census of 1850-60 list him as James H., age 18 in 1850; p 74 of above book- Hill, James H., K-56, Private 12 May 1862, Died of Disease at Lookout Mountain, Tenn. July 1862)
The wife of James H. Hill was Athey/Atha A? born ca. 1835/36. The 1880 census shows her age as 45, born in GA., Her Father born in Ga., mother, born in Galiving in Rockalo. She married 2nd time Jesse Jackson (b. ca. 1837). children:
