SR. 4/ & WIFE CHARITY LEWIS OF N.C.

ENOCH HILL 5/, SON OF WILLIAM HILL SR. 4/ & CHARITY LEWIS

Enoch Hill 5/, is listed in the 1800 Census of Chatham  
County, N.C., Page 154 as follows:

Comments: I do not believe these ages are correct. It appears  
that it was only he and his first wife, no children. I have  
Enoch Hill 5/ listed as born ca. 1769/1771 in Chatham County,  
N.C. This birth may have to be adjusted IF more evidence is  
found.

Georgia Census Records indicate a birth of about 1774-1776.  
If he was born ca. 1774-1776 it would still be listed wrong!  
I think he should have been listed as between 26 to 45. In  
any case, Charity Lewis, suspected mother, was living as late  
as 1779 when she was named in her mother's (Ann Richard  
Williams) 1779 Will. Mother Ann Lewis, widow of Richard  
Lewis, had remarried Wilson Williams in N.C.

Enoch Hill 5/ is said to have had at least two sons, William  
Hill, b. 22nd November ca. 1800 in N.C.; George W. Hill 6/,  
b. ca. 1803 in N.C. and a daughter, Amanda Hill 6/, b.??.

Enoch Hill married first time to Martha Brantley; 2nd time to  
her sister, Sarah Brantley.

In the 1850 Georgia Census, Enoch Hill 5/ and his second  
wife, Sarah Brantley, was listed in the house of his son,  
William Hill 6/ (age 34, born ca. 1813).

Enoch Hill was 74 years old (b. ca. 1776) and his wife, Sarah  
Brantley was age 64 (b. ca. 1786).

The 1850 listing of Enoch's 5/ birth of ca. 1776 is about six  
years later than what I have listed & estimated for him (ca.

1769/71).

Amanda Hill (dau. of Enoch Hill?) married John Childs on  
October 20th, 1836.

George W. Hill (son of Enoch Hill?) married Margaret Moore on  
December 31, 1826.

Elizabeth Ann Hill married Allen W. Thomas on June 4th, 1837.

Sarah A. M. Hill married Willis H. Miles on January 30th,  
1845.

Tabitha Hill married Robert Fenly? on July 6th 1837.

Allen C. Hill married Catherine J. Cookssy? on October 13, 1850.

John Hill married Jane Kitchens on December 20th, 1829.

#### Other miscellaneous Hill Data of Henry County, Georgia

Source: Henry County History:

George W. Hill & William B. Hill were Privates in Captain Thomas W. Harris' Henry County Volunteers in 1823 (The Conflict with the Florida Seminole Indians).

1870 Census Index shows a George W. Hill listed in Troup County, Ga., was born in 1803 in N.C. I suspect it was the son of Enoch Hill 5/.

Note: The following data was sent to me by Mr. Byron Hill of Nashville, Tn. in December of 1995. He descends from Enoch Hill 5/. He and other researchers are undecided if their ancestor, James Harvey Hill 7/, was a son of William Hill 6/ (b. ca. 1800 in N.C.) or his brother George W. Hill 6/, (b. ca. 1803 in N.C.).

Source of following data (copied just as sent to me)

Heard County, Georgia "A History of Its People," by Lynda S. Eller (1980), Page 199:

"William Hill, (22 November 1800/11 November 1881) buried near Glenn, GA. in Old Western Cemetery, Western Church.

1850 Census Shows:

William Hill, Age 49, farmer, born in S.C., list children below (except Wilson).

1880 Census Shows:

William Hill, age 79, farmer, born N.C., father born in Va., mother born in N.C. liv. Houston. wife Mary, (1807-27 March 1888).

Comments by Robert Hill of Brandon, Fla.: Now in the 1850 census, notice that William Hill (age 49) says he was born in South Carolina. I believe this to be wrong! What bothers me is that in the 1880 census he says his (said to be father Enoch Hill 5/) was born in Virginia and his mother was born in North Carolina. Something is very wrong here! IS THIS WILLIAM HILL A SON OF ENOCH HILL 5/?? If he was a son of Enoch Hill 5/ he was born in NORTH CAROLINA and so was his father, Enoch Hill!

Enoch Hill 5/ was born in Chatham County, N.C.. Enoch's 5/ father (William Hill Sr. 4/) was also born in N.C. His mother (Charity Lewis) appears to be listed correctly as born

in N.C.

William Hill and his wife Mary (1807/27 March 1888 are listed as having had the following children:

1. James Harvey Hill, born ca. 1832/33, died of disease on Lookout Mountain, TN. (in?) July 1862. On Page 74 of the above book is found: "Hill, James H., K-56, Private, 12th May 1862, Died of disease at Lookout Mountain, Tenn. July 1862."

Wife of James Harvey Hill was Athey/Atha A. \_\_\_\_\_ ? born ca. 1835/36. The 1880 Census says she was age 45 (born ca. 1835), father was born in Ga., mother was born in Ga., living at Rockalo. She had remarried the 2nd time to Jesse Jackson, who was not listed in the 1880 census.
