#### WILLIAM HILL

The earliest known Hill to be in Kentucky was a William Hill.

"LIFE AMONG THE HILLS AND MOUNTAINS" by William R. Thomas mentions a William Hill on page 111: "While Washington was actively engaged in the lower part of the Big Sandy Valley, it has recently been shown that Daniel Boone, the popular hero of Kentucky discovery and settlement, in company with WILLIAM HILL, was hunting and camping on the upper waters of the Big Sandy. Boone, who was in search of the rich land reported to be located in Kentucky, had crossed over the headwaters of the Big sandy, and, somewhat discouraged by the rough nature of the county which he encountered in what is now Pike and Floyd Counties, went into camp at a salt lick located about ten miles west of Prestonburg on Middle Creek. Game was plentiful, and all Boone and his companion, HILL, had to do was to await at their little shack the coming of the deer and buffalo to lick the salt. Their discovery of this salt lick was an inestimable value to Boone and HILL, for with the scant supply of ammunition, which was at their disposal, they were thus able to husband their stores and tide themselves over the hard months of the enforced winter encampment. It is not at all improbable that this salt lick played an important part in the saving of the lives of both of these two hardy woodsmen, and enabled Boone to return to the Yadkin, and later to take part in the well known explorations led by Findlay through Cumberland Gap into the Bluegrass region in 1769."

"DANIEL BOONE FAMILY7" by George & Mary Boone mentions a WILLIAM HILL on page 73: "It is thought Squire Boone accompanied his brother Daniel Boone and WILLIAM HILL to Kentucky in the fall of 1767. They crossed the Blue Ridge and Allegheny Mountains, the Holston & Clinch Rivers near their sources, and finally reached the head waters of the West Fork of the Big Sandy. Going on westward from here about 100 miles, they went into what is now Floyd County Kentucky. After spending the winter here in trapping and hunting they returned in the spring to the Yadkin."

2. WILLIAM HILL was witness to marriage on 20th April 1795 in this county of Daniel Burch and Rebekah Hunter, widow. Surety was LEONARD HILL.

#### LEONARD HILL

There is proof that Leonard Hill resided in S.C. until ca. 1788-89 (Camden District, today's Fairfield County). He fought in the American Revolution and served as a Constable in S.C. In 1788, he sold 82 acres of his land to a Thomas Hill, who is believed to be a brother, as was Moses Hill of same District and County of S.C. At the time of the sale, Leonard's wife, Elizabeth Hill also signed the deed. Later when the above Thomas Hill sold the land, his wife Judith signed with him.

In 1987, regarding my query to both the DAR and the SAR, the records showed that no one had ever filed application for

membership to either society as a descendent to Leonard Hill, thus he is a Revolutionary Soldier, that should be among their files, despite the fact no one has ever requested membership as his descendents.

LEONARD HILL Born: ?? (I suspected between 1759-1761in Md. or Va. but not proved).Died: Ca. October 1825 in Clark County, Kentucky. (Note: Death may have been in August of 1825).Married: Elizabeth ??? (She signed a deed in 1788 in S.C.).

He names mother of his children as: Susannah Dunford & Rachel Dunford. While not proven, the records suggest or indicate the children were born out of wedlock. Wife Elizabeth was never mentioned again in any records, not was any of their children. Leonard Hill never does acknowledge either Susannah Dunford or Rachel Dunford as his wives but does acknowledge that they were the mothers of his children. A land deed made in S.C. was by Leonard Hill was witnessed b y Susannah Dunford.

- 1. MARY (POLLY) HILL married 1st James Gibson on 9th August 1804. 2nd marriage to Nathan Williford before July 1825.
- 2. ELIZABETH HILL married John Foster on 27th March 1809.

- 4. JOHN HILL married Polly Ecton on 6th June 1812.

Polly Hill married 1st James Gibson and from the wording of Leonard Hill's will, it is assumed that Polly is the same person as MARY, who married 2nd to Nathan Williford.

The first land transaction in Clark County by Leonard Hill reads as follows:

THIS INDENTURE made the 7th day of September in the year of our Lord One Thousand Seven Hundred & Ninety Six (1796) Between John Holder & Fanny his wife of the county of Clarke and the Commonwealth of Kentucky of the one part and LEONARD HILL of the county aforesaid and Commonwealth aforesaid of the other part WITNESSETH that the said John Holder & Fanny his wife for and in consideration of the sum of One Hundred Pounds current money of Kentucky, to him in hand paid, the receipt whereof---do hereby acknowledge and forever----and discharge the said LEONARD HILL and his heirs, Executors and Administrators, have granted bargained sold aliened and confirm and by these presents do grant bargain sell alein and confirm unto the said LEONARD HILL his heirs and assigns forever all that tract or parcel of land, lying and being in the County of Clarke on the Kentucky River, beginning at MIKOL (MICHAEL?) DUMPORTS (DUNFORD?) upper corner of his four hundred acre survey where the corners on the Kentucky River on a Maple Tree thence North, 100 and 50 poles to John Heronimous' corner of 100 acres to two sugar trees, thence west 160 poles to an Elum in the line of Rebeckay (Rebecca?) Huntur (Hunter) 100 acre survey, thence south 150 poles to the Kentucky River, thence up the meanders of said river 160 poles to the beginning to contain 150 acres more or less, Together with all improvements, water courses, profits & Appurtenances whatsoever to the said premises belonging or in any wise appertaining and the revisions, remainders & profits thereof and all the estate right title interest property claim and demand of them the said John Holder and Fanny his wife, of in and to the same. TO HAVE AND TO HOLD the lands hereby conveyed with all and singular the premises and every part and parcel thereof with every of the appurtenances unto the said LEONARD HILL his heirs and assigns forever to the only proper use and behoof of his, the said LEONARD HILL his heirs and assigns forever, And the said John Holder and Fanny his wife for themselves their heirs Executors and Administrators do covenant promise and agree to and with the said LEONARD HILL his heirs and assigns by these presents that the premises before mentioned now are and forever here after shall remain free of and from all former and other gifts, grants, bargains, sales, dower rights and title of dower, judgements, executions, title troubles, charges & incumbencies what so ever done or suffered to be done by them the said John Holder and Fanny his wife and the said John Holder & Fanny his wife and their heirs all and singular the premises hereby bargained and sold with the appurtenances unto the said LEONARD HILL his heirs and every other person or persons whatsoever And we the said John Holder & Fanny his wife doth and will warrant and forever defend by these presents IN WITNESS whereof them the said John Holder & Fanny his wife have HEREUNTO set their hands and seals the day and year first above written (7 September 1795). (Signed) John Holder (Seal) Fanny Holder (Seal)

Notes by Mrs. Summers: Polly Hill married 1st James Gibson and from the wording of Leonard Hill's will it is assumed that Polly is the same person as Mary, who married 2nd time to Nathan Williford. Both Polly (Mary) and John Hill are were children of Leonard Hill.

It is believed that Leonard Hill, John Hill & William Hill, early settlers of Clark County, Kentucky are related.

Note: I am convinced that Leonard is also related as either a brother or cousin to my fourth great grandfather, Moses Hill & a Thomas Hill of Camden District, S.C. (today's Fairfield County).

#### LEONARD HILL, WHO ORIGINALLY LIVED IN FAIRFIELD COUNTY, S.C., MOVED TO CLARK COUNTY KENTUCKY CA. 1788. THIS WILL WAS DATED 4TH JULY 1825 IN CLARK COUNTY KENTUCKY, AND PROVEN IN AUGUST 1825.

#### WILL OF LEONARD HILL OF CLARK COUNTY KENTUCKY.

In the name of God (Amen), I LEONARD HILL, of the county of Clark and State of Kentucky, being weak in body but sound mind and perfect memory (Blessed be the Almighty God for the same) do make, ordain and publish this Instrument of Writing, to be my last will and testament, in manner and form following ..?..

1st... I will and desire that my body be buried in a decent and certainable (sic) like manner and that all my debts be paid.

2nd...After the debts are paid, I will and desire and bequeath unto my daughter MARY WILLIFORD, who is the daughter of SUSANNAH DUNFORD, a Negro woman named "Jinny," a Negro woman named Hillis, a Negro man named Isaac, a Negro man named Lewis and a Negro girl named Lucy, with the increase of the female (females) of them, to the said MARY WILLIFORD, during her natural life and after her death, to her children and heirs at law, equally, to be divided between (them?) forever.

3rd...I also will and bequeath to said MARY WILLIFORD, the plantation on which she now lives, say one hundred acres (100 acres), fifty acres of which I left to her and the other fifty acres thereof I sold to JAMES GIBSON in his lifetime, to her and heir children and heirs at law (that?) are near to claim or ....?...any of the residue of my Estate herein after mentioned.

4th... I will and bequeath to RACHEL DUNFORD, during her lifetime, one equal third part (one third) of all my Estate, both real and personal, except what I have herein before devised to MARY WILLIFORD and her children and my son MOSES HILL, who is also son of said RACHEL DUNFORD, (who) has the privilege of living with said RACHEL DUNFORD in the house I now live in, as long as said RACHEL DUNFORD lives and the third part of my land, which I bequeath to said RACHEL DUNFORD, is to include the house which I now live in.

6th...(5TH item NOT LISTED...PERHAPS IT WAS INTENDED TO START at the underlined part above?) After the death of said RACHEL DUNFORD, I will and bequeath that the third part of my Estate, which is given to ..(paper cuts off here)(her????) in this will, I give and bequeath to JOHN HILL, my said son of RACHEL DUNFORD, MOSES HILL my son and son of RACHEL DUNFORD and SARAH LILLIAND, my daughter and daughter of SUSANNAH DUNFORD, to them and their heirs FOREVER and equally to be divided between them.

7th...As to the other two thirds parts of my Estate BOTH real and personal, not herein before disposed of, I will and bequeath the same to said JOHN HILL, my son and son of RACHEL DUNFORD, MOSES HILL, my son and son of RACHEL DUNFORD and SARAH LILLIAND, my daughter and daughter of RACHEL DUNFORD and ELIZABETH (FOSTER?), my daughter and daughter of SUSANNAH DUNFORD, to them their heirs and assigns FOREVER (Paper cuts off here) and equally to be divided between them, I DO HEREBY REVOKE (DISANNUL) and make void all other wills and testaments by me here after at anytime made and do declare this to be my only true and last will and testimony WHEREOF I have here unto set my hand and affixed my seal, this 4th day of JULY 1825.

NOTES RELATING TO WILL...Leonard Hill had a wife named Elizabeth in Fairfield County..she signed his deed when selling to Thomas Hill (wife Judith) a suspected brother.

The wording of the will indicates that Leonard's S.C. wife (Elizabeth) was now deceased as was Susannah Dunford, the mother named of his first 2 daughters. Neither Elizabeth Hill (his S.C. wife) nor any children by her are mentioned and Susannah Dunford is mentioned only as mother of his two daughters.

Since Rachel Dunford is named and given a one third share (equal to what a widow normally received) it seems Susannah Dunford was dead. Neither Susannah Dunford nor Rachel Dunford are mentioned as being his wives. They are suspected to be sisters, and I am of the opinion that Leonard Hill was never legally married to either of the Dunford women. Robert R. Hill Sr.

This Indenture made and entered into this 7th June 1828 between JOHN HILL of Madison County and State of Kentucky of one part and MOSES HILL of Clarke County Kentucky of the other part, WITNESSETH that JOHN HILL doth for and in consideration of five thousand dollars in hand paid, grant bargain and sell unto said MOSES HILL the following property, to wit: Two Hundred and Sixteen Acres of land lying in Madison County on the Kentucky River about three miles below Boonsborough, it being the same on which he the said JOHN HILL now lives, also five slaves, namely Nat, Anny, Betsey, Will and Cloe, all now in the possession of said JOHN HILL, four head of horses, one cart and a voke of oxen, four beds, bedsteads and furniture and fifty head of hogs. TO HAVE AND TO HOLD unto said MOSES HILL said property to him and his heirs forever. The above conveyance is liable to the following conditions to wit that where as the said MOSES HILL is security for the said JOHN HILL to Thomas C. Green and Tandy Quishinberry for the sum of Two Thousand Three Hundred and Sixty Nine Dollars and Thirteen Cents, and is security to sundry persons in sundry small---- bond for about One Hundred Dollars and whereas the said JOHN (HILL?) is indebted to said MOSES in the sum of One Hundred and Sixty Dollars and Twenty Five Cents bearing interest from the 9th August last (1827), and for Five Hundred Dollars due 15th March 1828 and One Hundred advanced to him by said MOSES in small sums at Sundry times and the further sum of Nine Hundred Dollars this day loaned by said MOSES to said JOHN. Now should said JOHN save the said MOSES harmless from each and every said securityships (sic) and pay him all the debts aforesaid with interest which has or may accrue there on and all costs and expense in collecting the same thru this conveyance to be void otherwise to remain in full force and virtue in law.

RACHEL DUMFORD (DUNFORD) and Jesse Hodges married 27 April 1826; surety MOSES HILL (her son by Leonard Hill. Ref. Clark County Will of Leonard Hill).

The 1850 Census of Clark County, Kentucky on Page 8, dwelling # 108, RACHEL ROGERS (HODGES?) Age 75 years, born NC is living with the George W. Hill Family (son of Moses). This indicates that Rachel Dumford (Dunford) was living with a grandson at this time. In dwelling # 102 was MOSES HILL age 56 years, born in KY. and a son named Grandison Hill, age 26, Moses Hill Jr., age 21 years and John Day age 35.

NOTE BY R. Hill:

The above indicates the following:

- 1. Rachel Dunford was born in North Carolina ca. 1775.
- 2. Her son Moses Hill was born in Kentucky ca. 1796. (The father was Leonard Hill and from wording of his will and the fact that her name was given as Dumford (Dunford) when she married Jesse Hodges on 27 April 1826, indicates she and Leonard were not married. Leonard Hill died in Clark County ca. August 1825.
- 3. Grandson Hill (son of Moses & grandson of Leonard Hill and Rachel Dunford) was born in KY. ca. 1824.
- 4. Moses Hill Jr. (son of Moses Hill Sr. and grandson of Leonard Hill & Rachel Dunford) was born in KY ca. 1829.

First I direct that my just debts be paid out of my estate by

my executors.

Secondly, I will and bequeath to my wife Elizabeth Hill all my estate both real and personal save what I dispose of otherwise in this will, during her natural life or widowhood and in case of either of these it is to revert back to my children in the manner which in this will will be here after described.

Thirdly, my will is that my son JOHN HILL is to have no more than what I have already given him until my wife's death or marriage. Also my son in law Richard Empson and my son in law Nathan Martin are to have no more than what they have already got until my wife's death or marriage.

Fourthly, I will and bequeath to my son in law Josiah Ashley one Sorrel mare that came of my old riding mare, a new woman's saddle and bridle, one bed and furniture and such other little necessaries as make him equal to that which I give my other daughters when they went to house keeping.

Fifthly, I will and bequeath to my son WILLIAM HILL my Thunderbolt mare also a saddle and bridle, my watch, my gun and ammunition.

Sixthly, I will and bequeath to my daughter LUCY one last springs horse, Cow, a new saddle and bridle, one bed and furniture and such other things as will make her equal to her sisters when they were set to house keeping.

Seventhly, my will is that my wife have all the residue of my estate during her natural life or widowhood (as above mentioned) and when either of these takes place the the whole to return cash to my children in the following order (to wit.) my son GARLAND HILL is to have Six Shillings and the balance is to be equally divided between my other six children before mentioned and Lastly I do hereby ordain and appoint my wife ELIZABETH HILL and my son JOHN HILL to my just and lawful executors...IN WITNESS whereof I have hereunto set my hand and seal this 21st day of August and in the year of our lord, One Thousand Eight Hundred and Four (1804).
