

KY.009 THE WILL OF ISAAC HILL

ISAAC HILL

I, ISAAC HILL of Hill's Run, State of Kentucky, being past the allotted years and infirm in body deem this to be my last testament.i

Having four sons and two daughters, and all but ELLEN being in other states and territories, let the lands be sold and the moneys be divided equal between the four sons and daughter MARY, excepting these...

My abode and it's bottom lands be given to ELLEN, wife of James Garrett.

The Sevier lands, which MARY came by from her father, be given to Pierce Sevier, let the two Negroes, Casey and Cade, who were John Seiver's, be given one furlong square with the old house.

The Tennessee lands which I bought, be sold and the money's be divided equal among the four sons and two daughters.

The Roundtree lands in Carolina, which MARTHA came by, be given to MARTHA'S son, HIRAM.

The Hill lands in Carolina, from my father, be given to brothers HENRY and JOHN, if dead to their sons.

Of the lands here in the west hollow, give each 2 mated Negroes one furlong square, the spring and the trace be common to all, Mitty, and Bo., Tizzy and Ely, Viny and Joe, the loom to be common to all. Give each two mated Negroes one kettle, two bed covers. All Negroes given land to be freed by law. The Three old Negroes to be freed by law. To my black sons be given the mill and bridge with two furlongs betwixt the trace and run. All full and strong mouthed Negroes to be sold except four, James Garret's choice. Horses, cows, oxen to be sold, except four, James Garrett's choice. Moneys from stock to be divided the same as land money. House fittings ELLEN doesn't want be given to mated Negroes.

The clock, given to me by JEFFERSON, be given to Harvey Singleton.

It was MARTHA'S wish to be buried in the Roundtree graveyard in Carolina. If this be possible, let my ELIJAH and MARTHA'S HIRAM take our bodies there.

The settlement of my early affairs I leave to Harvey Singleton and James Garrett.

Attested by Abel Prayer & Elias Whitten, March 1842.

Died June 1846, decreed and settled by the Commonwealth of Kentucky, April 1848.

Elijah, son of (Isaac), Fayette County, Illinois.

Samuel, son of (Isaac), Menardco, Illinois or New York state.

Henry, son of (Isaac) died, widow is wife of Lewis Scribner, two heirs.

Isaac, son of (Isaac) Miller County, Missouri,

Mary, wife of Samuel Watson, Clay County, Illinois.

Henry, brother of (Isaac) died, his sons: John, Henry, Braxel, Thomas, Montgomery County, Illinois.

John, brother of (Isaac), died, his sons: Isaac, Bond County, Illinois. Elijah, Creek lands, Alabama; Ambrose, unknown.
