I feel Isaac kind of took advantage of the situation with Lydia and tried to get all he could out of William's estate. He is still claiming guardianship of the two girls when they are in their 20s.

I do not know a birth date for James Hill. I sent you a list of what legal papers I have on his estate and the guardianship of his children. Would you like a complete copy of any of them? He (or a James) m. Christian Lassiter September 15, 1806, Greene Co., GA. Also, a James Hill m. Elizabeth Cleckler, April 3, 1808, Putnam Co., GA. Both a Lassiter and Cleckler are involved with my James. There is only a couple of years between the marriages, so I don't really feel both are the same James.

I agree with you completely and have said so all along that Mary and Elizabeth are Jones children (but they did seem to take the Hill name when they married, etc.).

Something I have said Sarahs(w/o Thos.) last name was Ethridge. Will have to look up where it came from.

I don't believe Lydia would have married William if he had leprosy, so must have been Enoch, or not the William who m. Lydia.

I am still trying to absorb all the information and will write again when ${\bf I}$ am able to make a little order out of it. Sure wish we lived close enough together to sit and talk it out.

County "to rent Hendrick place".

The 1813 return shows that Atkinson was riding from Clarke County twice in Feb. in October, and in December. Publication of the sale of land of the Pinson estate was made in the paper of ALEXANDER McDONEL, at Athens, Clark County, "for Gazetting of said Land according to Law for the term of nine months." This was in Dec. 1813. [Newspaper would be THE GEORGIA EXPRESS]

Page 165. A town lot in Monticello, Jasper County was sold 25 Oct. 1814, belonging to the estate of JAMES PINSON, dec'd. Purchaser was LEWIS DEWPREE for \$300. Sold at the "request of HENRY KOON one of the lawful heirs, his portion have been shown to said Court and granted by their honors."

The 1814 return shows that the land was rented, after obtaining an order of ejectment of MICAJAH HENDRICK who was first in possession of lands by said Pinson in his lifetime, and by him ejected before his death. Notes due in 1812 of JAMES ARNOLD ACKISON and ELISHA GIBSON for \$20, from EPHRAIM and THOMAS PENNING-TON for \$17, due 25 Dec. 1812, and from the Penningtons for \$40 due 25 Dec. 1813, and \$3 from Ephraim Pennington which were due the estate but were yet unpaid. Atkinson was prevented from collecting because of "the Aleveating Law," he swore in his 10 Jan. 1815 return.

The 1815 yearly return shows that only MARY PINSON, daughter of James Pinson, is in the guardianship of Atkinson that year. JACOB BRYAN was paid for giving her schooling, and paid JEREMIAH PEARSON for spelling book and papers.





Upon his retirement Walter and Grace returned to Union to do extensive renovations to the old home where Mrs. Smith is presently living.

Mamie Smith married Sidney Crosby of Union County. Their children were Fred and Frances, twins, Leone, and Walter.

Susan Emah Hawkins married Ira Tinsley of Union. Their children were Lols, Susia and Annie. Lols married Fred Whitney and their family consisted of Fred Jr., James (killed in World War II), Sue Frances who married Furman Fendley and William who married Dorothy Setzler. Their two sons are William Jr. (Billy) and James (Jimbo). Billy married Martha Barnes and their daughters are Emily and Louisa.

VIRGIL RANDOLPH HAWKINS FAMILY

268

Virgil Randolph Hawkins (1883-1940) left the farm on Tinker Creek in Union County when cotton was selling for 4 cents a pound. He worked for a while at various jobs in Mississippi and Alabama; and, then, as a telegrapher at night in Atlanta, he put himself through Dental College. He graduated in 1908 from the Southern Dental College (now Emory University). After a year's practice in Charleston, he returned to his home town of Union. In 1917 he married Virginia Sperry, daughter of Abram Rhodes Sperry and Fannie Shipley. The Sperry antecedents were among the original settlers of Winchester, Virginia.

Dr. Hawkins reared his family and practiced his profession in Union until his death in 1940 at the age of 57. He was much loved and respected in his community due in large part to his unobtrusive but sincere concern for others. An old Union resident once told me that she remembered her mother saying that she had never heard a Hawkins say an unkind word about another person. I would hope that

this was still true; it certainly had perfect application in Virgil Hawkins. He was a tolerant person with a keen wit and a sparkling dry humor.

He was held in highest regard by fellow dentists all over the state as evidenced by his selection by his peers as "Dentist of the First Half Century for South Carolina". This citation was announced in a special mid-century issue of the Journal of the American Dental Association and was awarded posthumously in 1950 in Atlanta. The following is quoted from an article in The State newspaper dated June 1, 1950:

"Dr. Hawkins was singled out for (his expertise in) the manipulation of gold and sliver alloy in dental practice. He gave a number of clinical demonstrations before dental societies throughout the country, and served for five years on the South Carolina State Board of Dental Examiners. The present high professional standards of the state are attributable in large part to his efforts".

The Hawkins family came as Quakers to Union County in the early eighteenth century, probably from Pennsylvania. The earliest ancestor I have been able to identify is James Hawkins whose probable date of birth was about 1716 to 1720. He married Martha Holloway about 1743. His will, recorded in 1793 showed the names of the following children; Isaac, Nathan, John (Sr.), Benjamin, Amos, William, James and Martha Cook.

I have no record of Nathan, Benjamin, or James. It is reasonable to assume they left the area. John Sr., born about 1744 married Mary Moore "in Cane Creek Meeting". His son, John Jr. (1777-1859) married Lydia Comer in South Carolina and then, with his family, migrated to Richmond County, Indiana. Amos also moved his family to Indiana (Dearborn County). Martha Cook appears to have married Seth Wilson. A tax receipt from 1807 shows taxes paid by Isaac for himself and his brothers on well in excess of 4000 "acors of land of last quality" on Cane Creek, Tyger River and Tinker Creek.

Isaac, born before 1746, married to Margaret, appears to be the patriarch of the family remaining in Union County. I have no clear record of Isaac's family except for his son Jonathan (9/25/1786 — 12/9/1857) who married Letty (1792 — 9/23/1839). One of my great aunts said that her grandpa Jonathan and her great-grandpa Isaac were both Quakers but all Jonathan's sons were Baptists, and Jonathan had seven sons and a daughter. I have no record of Sarah, Isaac, John or Thomas. Some evidence suggests that Joseph may have owned lands later known as the Barfield, O'Shields, and Royster farms south of Union and west of highway 176, these being his daughters' lands.

James Andrew Jackson Hawkins (5/2/1827 — 5/4/1860) married Mary Pollle Little (1828-1921), granddaughter of Jonas Little, Revolutionary War hero of Union County. His son James Amos moved his family to Arkansas.

Nathan and Benjamin who remained in Union County near Tinker Creek are my greatgrandfathers (Nathan, on my paternal grandfather's side and Benjamin on my paternal grandmother's side).

THE GEORGE W. HILL FAMILY 269

George Washington Hill was born May 5, 1822, in Fishdam, Union County, and was the son of James and Susannah (Glenn) Hill. He was a graduate of South Carolina College (now the University of South Carolina) and was a Latin and Greek scholar, as well as a very able historian. He was greatly interested in genealogy, and it was he who preserved much of the history of his family by making note of the family relationships. He was offered a position teaching at the South Carolina College after he graduated, but turned it down to come home and help his elderly father with the extensive farming operations.

In his will James Hill specified that George was to receive the homeplace which included 2250 acres of land and the house "Hillside." George was a Confederate veteran and was serving in the office of the quartermaster in Columbia when the city was burned by Sherman's troops toward the end of the war. The burning of the city made a great impression on him, and as he long as he lived he entertained his family and friends with tales of the things that he saw during that catastrophe.

When the war was over he returned to "Hillside" and farmed until his death on May 3, 1909. He was twice married and is buried in Fishdam Cemetery with both of his wives and most of his children and grandchildren.

George W. Hill married first on October 15, 1851 Sarah Young, born August 2, 1832, died March 12, 1862. She was the daughter of Dr. C.C. Young of Union County. Notice of their marriage appeared in the October 28, 1851 issue of the *Unionville Journal:* "Married on the 15th instant by Rev. Thos. Young, Mr. George W. Hill to Miss Sallie Young, daughter of the late Dr. C.C. Young." Dr. Young died in 1850 while his daughter Sallie was a student at Salem Academy, a well-known school for girls operated by the Moravians of Winston-Salem, North Carolina. George W. and Sallie (Young) Hill had three children:

Margaret Hill (1852-1921) married William Kelly Thomas of the Fishdam area of Union County and had five children.

Sarah Glenn Hill married James Willard of Union County and had four children.

Martha Elizabeth (Mattle) Hill (1858-1924) married Reuben Sims Thomas of the Fishdam area and had two sons. (See the articles on the Thomas Family elswhere in this book.)

George W. Hill married second on November 15, 1866, by the Rev. O.A. Darby at the Methodist parsonage in Union, Sarah Jane Graham who was born in York County, South Carolina on February 8, 1837. She was the daughter of Emmor Graham, a Pennsylvanian who came south around 1825 and lived in York County where he was interested in the mining business that flourished in the area at that period. He married Teresa Eusebia Richards of York County, and they later moved to Char-

lotte. Mecklenburg County, North Carolina, where he was chief coiner of the mint that was in operation there until about the time of the Civil War.

Sarah Jane (Sallie) Graham was a graduate of Greensboro Female College, Greensboro, North Carolina, and taught at several schools for girls in both North and South Cambina She finally came to Union where she was teaching at the Female Academy when she met and married George W. Hill. Sallie (Graham) Hill died at "Hillside" on October 23, 1883, She and George W. Hill were the parents of six children:

Guy Graham Hill, died in infancy.

Robert Graham Hill, born December 2 1869. died July 17, 1893, unmarried.

Ruth Worth Hill, born July 4, 1871, died March 4, 1948, married George C. Wood of Titemixes County. They had only one daughter who died young.

Rowland Glenn Hill, born January 1, 1874, died July 19, 1907, married first Nettie Jeter (1875-1899) and had twin sons, Rowland Glenn Hill, Jr. and Graham Hamilton Hill. Rowland Glenn Hill married second Edith Isabelle Lyles (died 1953) of Chester County and had one son, Coleman Lyles Hill.

Daisy Hill. born March 20, 1876, died September 6, 1900, unmarried.

Jeannette Hill, born August 21, 1879, died April 1, 1961, married Wilkes Booth May, (See The W.B. May Family.)

THE JAMES HILL FAMILY

James Hill was born in Fairfield County, South

Carolina, on November 21,11782. He was the son of Moses Hill who died in Fairfield County in 1821, aged 63, and Savilla (Roden) Hill who died in Greene County, Alabama, in 1844, to which place she had moved with her son

George W. Hill and several other members of her family. She was born in 1759 and was the daughter of Thomas and Mary Roden of Chester County, South Carolina.

On June 10, 1806 James Hill married Susannah Glenn, the daughter of James and Figabeth (Bowles) Glenn of Chester County. (See the articles on James Glenn II and James Glenn of Hanover County, Virginia.) James and Susannah Hill moved to Fishdam in Union County where they lived for the rest of their lives. They built a too barn, which is still standing, and a big log house in which they lived for several years. Eventually they built their permanent home, a large two-story white house on top of a high hill just north of the present town of Cartisle. Construction of the house required several years and it was completed during the 1820's. Named "Hillside" for the family, and also because of its site, the house is listed on the National Register of Historic Places and is presently owned and occupied by Jeannette May Christopher, great-granddaughter of James and Susannah Hill. Mrs. Christopher's children are the fifth generation of the same family to occupy the

James Hill bought many tracts of land. farmed extensively, and supported the Methodist Church both financially and spiritually. At one time he and his son-in-law Charner T. Scalle, owned a store in the Fishdam area which was known as the firm of Hill & Scalle. He shipped his cotton by boat down Broad River to Columbia and Charleston where it was exported to England and New England by the cotton factor who handled it for him. Once or twice a year he would make trips "down-country" to settle up with the firm that represented him and to buy supplies for the coming year. The only foods purchased were items that could not be raised on the farm coffee, tea, sugar, salt. Cotton and woolen materials were woven at home, but he always brought back fancy materials and trimmings for his wife and daughters - velvel, silk,

satin, ribbons, tace, tancy buttons, and an occasional piece of jewelry. And needles many needles! Items for use on the farm included coils of rope, balls of twine, bars of iron, and barrels of tar. He subscribed to newspapers and bought books - he had a sizeable library. He meticulously saved receipts of bills paid and the statements that he received from his cotton factors, which give interesting sidelights on the time period in which he lived.

Near his home he built the Fishdam Academy, a school for the education of his and his neighbors' children. In 1968 a pentleman then living in Houston, Texas, wrote that he owned a set of schoolbooks used by his greatgrandiather as a student at the Academy. The books were inscribed "Fishdam Academy" on the inside cover, and consisted of texts on Latin. Greek. mathematics, English grammar and spelling. The gentleman remarked in his letter that the Academy students received a good, solid education considering the ground covered in the text books.

James and Susannah Hill were the parents of seven children of whom only three lived to maturity. Between 1823 and 1827 the four oldest children died as teen-agers, traditionally the victims of some type of fever that was prevalent in those years. James died on October 27, 1854, and Susannah lived less than a vear after his death. She died on June 9, 1855. and she and James and all of their children. except their son John Thompson Hill, are buried in Fishdam Cemetery. Their children

James Glenn Hill, born March 4, 1807, died December 27, 1823.

Moses Green Berry Hill, born December 9. 1808, died August 17, 1827.

Sarah Anderson Glenn Hill, born January 21, 1811, died December 12, 1827.

William Henry Harrison Hill, born August 27. 1813, died December 25, 1824.

John Thompson Hill, born February 13. 1815, died 1887, married first on July 5, 1842 his first cousin Elizabeth Pickett Mobley, the daughter of Edward P. and Harriett (Hill) Mobiley of Fairfield County, Euzabeth (Mobiley) Hill was born March 1, 1824, died May 8, 1854, and is buried in Fishdam Cemetery. They had five children.

John Thompson Hill married second on July 29, 1862 Mrs. Ann E. (Meng) Wallace (1828-1914), the daughter of C.S. and Mary Meng of Union County. She had several children by her first marriage, and she and John Thompson Hill had three more children. Following his second marriage, John Thompson Hill moved to Union where he operated a store and real estate firm known as J.T. Hill & Co. John Thompson and Ann Hill are buried in Grace Methodist Church Cemetery in Union

Susannah Elizabeth Hill, born May 14, 1817, died July 28, 1838, married Charner T. Scalle of Chester County. They made their home in Fishdam and had three sons, one of whom died in intancy. After Susannah Elizabeth's death her husband married again and moved back to Chester County. Their two surviving sons, James Hill Scaile and Moses Green Berry Scaile, made their home with their

orandparents. James and Susannah Hill, for many years. (For interesting information on the Scatte tamily see The Family Scatte by William R. Scalle of Atlanta, published 1980.)

George Washington Hill, born May 5, 1822. died May 3, 1909. (See The George W. Hill Family.)

LEONARD HILL AND FAMILY

This is only a small part of the history and geneology of the Hill family from Harriet Lapham and Leonard Hill through their daughter, Lucena Hill Kingsmore and Lucena's son. Edward Leonard Kingsmore to James Monroe Kingsmore, (See Edward Harvey Kingsmore and James Monroe Kingsmore). Many descendants live in Union County; they are of English descent.

In the years of 1815 and 1816, there were great colonies emigrating from the New Engtand States into the Southern States, principally cotton manufacturers. With this colony came Leonard Hill and relatives. They came by boat down the coast from Providence, Rhode Island, to Charleston, S.C. They hired conveyances and started to explore what was then a wild and romantic country. They journayed in covered wagons through the lower and middle belt on into the Piedmont Section. They settled on the banks of the Tyger River, with her rapid flowing stream and magnificent shoals. They put down stakes and started one of the first cotton milis in the South. At that time very little cotton was grown in the up country. Soon that changed and plenty was prown as cotton became King.

Leonard Hill. George Hill. William B. Sheldon and John Clark formed this plant, with Leonard Hill as Business Manager. This was in 1816 or 1817. People from far and near came to see this first factory.

In 1820 William Sheldon retired, selling his interest in the Company, In 1825 George Hill sold his interest in the company and returned to Rhode Island. In 1830 John Clark sold his interest to Leonard Hill, who became the sole owner and conducted the business until his death in 1840. They also operated a big general store near Hill's Bridge on Tyger River in Spartanburg County, S.C.

On a hill near where the plant was is the Hill Cemetery. Their home was nearby also. Leonard Hill and other members of the family are buried in the Hill Cemetery, it is enclosed with a high rock wall. The tombs are intact.

Leonard Hill was born September 6, 1791. and died September 19, 1840. He is buried at Hill's Cemetery.

Harriet Lapham Hill, wife of Leonard Hill and daughter of James and Jamima Lapham, was born July 21, 1794 and died December 27, 1873. She is buried at Hill's Cemetery.

Lucena Hill Kingsmore, wife of Edward Harvey Kingsmore, and daughter of Leonard and Harriet Lapham Hill, was born May 20, 1829, and died October 7, 1853. She is buried at Hill's Cemetery.

There is no record of the birth or death of Edward Harvey Kingsmore, husband of Luce-

na Hill Kinosmore. He was married twice after the death of his first wife, Lucena Hill, Lucena and Edward had three children: Henry, Agnes, and Edward Leonard Kingsmore. He is buried in Newberry, S.C.

James and Jamima Lapham, parents of Harriett Lapham Hill, are also buried at the Hill Cemetery. After the death of Leonard Hill, the mill was operated by his sons, James, Albert, Whipple, and Leonard until 1866. They then sold the machinery to Nesbitt & Wright.

THE HODGE AND SAYE **FAMILIES**

The Sayes and Hodges visited America on a prospecting trip. Neither was acquainted with the other. During the exploratory trip James William Save and Nancy Hodge became engaged and after returning to England were married. Shortly after their marriage, James William Saye and Nancy Hodge came to America to live settling near Reading, Pennsylvania. Some of the members of the Hodge and Save families came along with this couple and settled nearby.

William Hodge, Sr., possible brother of Nancy Hodge Save, died in Lancaster County, Pennsylvania, in 1767. William Hodge, Sr., and Margaret Hodge, his wife, had a daughter. Mary Hodge, who married Richard Saye, son of James William Save and Nancy Hodge Saye. Margaret Hodge, wife of William Hodge, Sr., was born in 1704, and died 5-10-1789, in Union County, S.C. Margaret Hodge is buried in the old Fairforest Presbyterian Cemetery in Union County, S.C.

Richard Saye and his wife, Mary, moved from Pennsylvania to Burke County, North Carolina, and lived for awhile on the banks of the Catawba River. Later, Richard and Mary Hodge Save moved to South Carolina, and settled on the banks of Mitchell's Creek in Union County, S.C. Richard Save was a patriot and a soldier in the Revolutionary War, tosing his life at the Battle of Savanhah on October 9. 1779, while assisting a neighbor by the name of Jackson who, too, had received a wound Mary Hodge Saye moved to Madison County. Georgia, circa 1793, and died there in June, 1830. Mary Hodge Saye lived near the South Broad River two miles from Danielsville, Ga.

Richard Saye and Mary Hodge Saye had the following children: (1) Sarah Save married James Thompson. This couple resided in Madison County, Georgia. William Hodge, Jr., and his wife, Elizat Cook Hodge, lived for awhile in York Cour Pennsylvania, where most or all of their c dren were born. Following his father's dea William Hooge, Jr., removed with his family Union County, S.C., where he eventually owseveral hundred acres of land. Sometibetween 1810 and 1820, William Hodge, J. and his wife. Elizabeth, moved to Madis. County, Georgia, where they lived with the son, William Hodge, III, in 1820 and 182 William Hodge, Jr., divided his Union Count S.C., property between his children.

James Hodge Save, in his Memoirs McJunkin, describes William Hodge, Jr., being "a peaceable citizen". Wm. THE HILL FAMILY OF BEERSHEBA SPRINGS, TENNESSEE

Prepared by Ralph H. Willis and Mrs. Delbert (Kaye) Denton

The Ben Hill family that has lived in Beersheba since the early 1900s can trace and document its ancestry for six generations to the elder Hill who was one of the earlier settlers of this part of Tennessee. Prior to this, the roots of the Hill family can be traced back to Hancock and Jasper counties in Georgia; thence to Edgecombe County (formerly part of Martin County), North Carolina, thence to St. Mary's, Charles County, Maryland, thence to Charlestown, Massachusetts, thence to England.

In attempting to summarize the history of this family, we list first the direct line of descent. Secondly, we detail the families of those in the direct line. This is followed by brief descriptions of the women and that of their families who married into the direct line. We conclude with biographical information which will show something more about some of those in the direct line of descent.

Our clearly documented history begins with Isaac Hill, Sr., who was born and raised in St. Mary's, Charles County, Maryland. He was born 22 July 1748 and married Lucinda Wallace who was also born and raised in St. Mary's; her date of birth being 1746. Isaac and Lucinda were married in 1773 and their first child was born 7 February 1774. Here follows the direct line:






According to the will of John Swales, he and his wife, Elenor, had the following children in addition to Susannah: Sons Francis Swales, Robert Swales, John Swales and Joseph Swales and daughters Ann Swales, who married Rueben Smith, and Mary Swales, who married a Greenwelk. Susannah was born 31 December 1767.

Susannah Swales was married first to Sterling Savage, Sr. They had one daughter, Brittania Savage, born 20 June 1793, prior to Sterling, Sr.'s death in 1794. Prior to his marriage to Susannah, Sterling, Sr. had been married previously and had four children by his first wife. These children were as follows: Sterling Savage, Jr., Jesse Savage, Loveless Savage and Elizabeth Savage. Only Brittania, Sterling, Jr., and Jesse lived to adulthood and had families of their own.

Henry John Alexander and Susannah's son, Ervin Hill, married his first cousin, Eleanor Hymen Morgan, daughter of David Morgan and Martha Hill (sister of Henry John Alexander Hill). No investigation has been made thus far into the ancestry of David Morgan. The ancestry of Martha Hill (Morgan) is that of Henry John Alexander Hill, her brother.

Ervin and Eleanor's son, Ervin Lafayette Hill, married Susannah Brock. All attempts made thus far in trying to determine the ancestry of Susannah Brock have not been successful.





Nothing further is known of these lines.

James Jr. and Clarissa Clendenon were the parents of five children as follows: Sarah Jane Clendenon, born 30 July 1833; Francis Marion Clendenon, born 1 November 1835; Charles W. Clendenon (18 April 1838 - 18 April 1900); James Newton Clendenon, born 5 November 1840; and Sallie Clendenon.

James, Jr. and Clarissa's son, Charles W. Clendenon, married Elizabeth Barnes, daughter of Charles and Susannah (Smith) Barnes. Charles Barnes was the son of William B. Barnes born 1780, in North Carolina, died 1819 in Warren County, and Charity (Phillips) Barnes, born 24 August 1783 in Georgia and died 8 May 1871. Nothing further is known of either of these lines. William B. and Charity (Phillips) Barnes were the parents of eight children as follows: Thomas Barnes, born 3 May 1800; Mary Barnes, born 5 April 1805; Sarah Barnes, born 1807; Charles Barnes (1 April 1809-4 January 1864); William B. Barnes, Jr., born 23 January 1812; Jesse Barnes, born 1813; Millery (Mildred) Barnes, born 3 August 1816; and Eliza Barnes, born 1819.

William B. and Charity's son, Charles Barnes, married Susannah Smith, born 22 October 1812 and died 8 May 1843. Susannah Smith was the daughter of Isaac Smith (2 February 1788 - 19 December 1811) who married Brittania Savage, born 20 June 1793. Nothing further is known of the ancestry of Isaac Smith. However, it will be recalled from the earlier discussion of Susannah Swales (Savage), widow of Sterling Savage, who married Henry John Alexander Hill, that Brittania Savage was the daughter of Sterling and Susannah Swales Savage. The ancestry of Susannah Swales (Savage) Hill was presented earlier. The ancestry of Sterling Savage, Sr., is outlined as follows:



Robert and Elizabeth Bell Savage were the parents of seven children as follows: Warren Savage; Britton Savage; Sterling Savage, Sr.; Robert Savage; Nannah Savage; Lucy Savage; and Betsy Savage. Sterling Savage, Sr.'s first wife is unknown with that union resulting in four children as follows: Jesse Savage; Sterling King Savage, Jr.; Loveless Savage; and Elizabeth Savage. Both Loveless and Elizabeth died young.

Following his first wife's death, Sterling Savage, Sr., married Susannah Swales and they had only one child, Brittania Savage, born 20 June 1793. Brittania married Isaac Smith and they had four children as follows: Susannah Smith (22 October 1812 - 8 May 1893); Andrew Jackson Percy McDonough Smith, born 1 January 1815; Isaac Smith, Jr., born 27 May 1817; and Caroline Smith.



It was Minnie Belle Clendenon who became the second wife of Benjamin Jefferson Hill which completes our summary of the women (and their families) who married into the Hill family.

We conclude this sketch with some biographical and anecdotal facts regarding some of those individuals in the direct line. In any Hill family history, Isaac Hill, Sr., must be placed at the center of the stage. Isaac Hill, Sr., married his first wife, Lucinda Wallace, Between 1772 and 1798, a span of twenty-six years, they had fourteen children. He served in the Revolutionary War from 1 August 1780 until 15 November 1783. He served in the capacity of drummer; and his unit was 3rd Company, 3rd Regiment of the Maryland Troops. Following his Revolutionary War service, Isaac and Lucinda and their children moved to Martin County, North Carolina, and settled near Tarboro on the Tar River. Isaac and his growing family operated a farm and, in addition, ran turpentine and tar. The tar was used in the manufacture of sails for boats. Following Lucinda's death of 23 September 1798, Isaac was elected Sheriff of Edgecombe County serving from 1798 to 1800. By this time, the southern portion of Martin County had been split off and named Edgecomb County. Around 1800, Isaac, his fourteen children and the families of those who were married by this time, migrated with other families to the northeastern portion of Georgia. There, they settled in Hancock and Jasper counties.

The town of Hillsboro in Jasper County is named for Isaac Hill. About 1810 or so, Isaac married for his second wife Lydia White (Jones) (Hill), widow of Hugh Jones and William Hill, respectively. Lydia and Hugh Jones had seven children prior to his death in 1798. Having been left with a sizeable estate and some young children and with one of the estate's appraisers being the recently widowed William Hill who had nine children by his wife Elizabeth Clanton Hill, Elizabeth having died giving birth to their ninth child, William and Lydia were soon married to mutual benefit. William and Lydia had two children: Eliza Hill, born 4 February 1801, and Louvisa Hill, born 1802. William Hill died in 1809. Sometime thereafter, around 1810 or 1811, Lydia White (Jones) (Hill) married for her third husband Isaac Hill, Sr. According to a statement by a grandson of Isaac Hill, Sr., there was no relation between William Hill, Lydia's second husband, and Isaac Hill, Sr., Lydia's third husband. This is shown to be in error by examining the following ancestry of William Hill:

It will be recalled that Isaac Hill, Sr., is of the "Sir John Hill" line. At the tenth generation in this line, there was a Samuel Hill who had sons, Ralph, Sr., and Robert. It was this Samuel Hill that was the common ancestor to Isaac Hill, Sr., and William Hill, as shown by the following diagram:



Samuel Hill, born ca 1590, Northumberland Co., England, became treasurer of Birmingham, England, wife's name unknown, had son's Ralph, born 1608, and Robert.

Sometime around 1812, Isaac and Lydia with her two young daughters, Eliza and Louvisa, by William Hill, moved to Warren County, Tennessee, to join his oldest son, Henry John Alexander Hill. They moved into the house with H.J.A. Hill and wife, Susannah, which was situated adjacent to the Indian Mound on the banks of Collins River just out from what was then known as Morrison's Crossroads, now known as Irving College. After living with H.J.A. and wife for about two years, both families, over a period of time moved on--H.J.A. and Susannah on up the valley now known as Hill's Creek where H.J.A. built the house that came to be known as the H.L.W. Hill homeplace, and Isaac and Lydia out on Cumberland Mountain where he operated a small farm and a stage coach way station known as Hill's Tavern. He died 28 July 1825 at age 77 and was buried, at his request, in the orchard adjacent to his home there on Cumberland Mountain. The grave is well preserved until this day being marked with a beautiful head and foot stone. He was buried among some of his slaves, having owned approximately 35 to 40, and perhaps other travelers whose lives expired as they traveled along this route in their migration to the western lands. Sometime after Isaac, Sr.'s death. Lydia returned to Georgia where she died 12 June 1838.

The lives of Isaac, Sr., and his oldest son, Henry John Alexander (H.J.A.) Hill, were intertwined to a very large degree. H.J.A. grew up in Martin County (later Edgecombe County), North Carolina, where he assisted his father with the farm and the distillation of tar and turpentine. One day H.J.A. was making repairs to one of the kilns and fell through the earthen structure with one of his legs going into a vat of tar. This left him a cripple for life with that leg being somewhat crooked and drawn. However, as will be seen, he led a very active life in spite of his teenage injury.

H.J.A. married the widow Susannah Swales (Savage) while still living in Edgecombe County, North Carolina, inheriting Susannah's step children and the one child, Brittania, that Susannah had by Sterling Savage, Sr. As recounted earlier, H.J.A., Susannah and family migrated to Georgia with Isaac and family around 1800. By this time, two of Susannah's step children, Loveless Savage and Elizabeth Savage, had died leaving only two of Sterling Sr.'s children by his first wife, namely Jesse and Sterling, Jr. After staying in Georgia for only a year or so, H.J.A. led a party of some thirty men, Jesse Savage being among this group, into the Tennessee wilderness to reconnoiter land on which to settle, farm and build homes. Some of this land, if not all, was obtained through land grants, military and otherwise, from the state of North Carolina since what came to be called the State of Tennessee was at one time part of North Carolina.

During this survey or reconnaissance, each man selected a parcel of land with the group then returning to Georgia for their families. It was about 1802 when the men and their families located in the area that came to be known as Hill's Creek (named for H.J.A. Hill) and Morrison's Crossroads.

H.J.A. was a natural leader and, as a result, came to be elected in 1807 to three consecutive terms to the Tennessee House of Representatives. During his tenure as a representative, he became friends with Hugh Lawson White, a member of the House of Representatives from Knoxville. H.J.A. named his seventh (legitimate) child Hugh Lawson White Hill in honor of this friend.

During this same period, he was also friends with another member of the House of Representatives, Joseph McMinn. After H.J.A. introduced the bill to split off the southern portion of White County to form Warren County, he was also responsible for naming the town of McMinnville. He chose this name in honor of his friend, Joseph McMinn, who would later become governor of the State of Tennessee.

Around 1812-1815, H.J.A. served as the first minister of the Shiloh Church. However, it would be later that Shiloh Church became affiliated with the Methodist denomination or faith. Paradoxically, it was also at this time that H.J.A. began to have children by his consort, Polly Johnson, born 19 January 1787, thus making her thirteen years younger than himself and twenty years younger than Susannah, his wife. Nonetheless, the story told is that Polly was a friend of Susannah's who was persuaded to accompany her as the family moved from Georgia into the Tennessee wilderness. Evidently, Susannah acquiesced to this arrangement in her later years as seen by the order of birth of the children. First, there were six legitimate children, then the child Harriett by Polly, then the legitimate child H.L.W., followed by five more illegitimate children. The family Bible of H.J.A. Hill records all these births and of which mother. Both families or sets of children also grew up together although in later years they tended to go separate ways.

During H.J.A.'s prime, he owned some 50,000 acres of land, most of which he had relinquished by the time of his death in 1825. Although it is told that his son, H.L.W. Hill, famous and affluent in his own time, donated the land for Center Hill Cemetery where H.J.A. and Susannah are buried; this land most certainly belonged to H.J.A. at one time and the writers suspect that it was in fact H.J.A. Hill who donated the land for this cemetery. Research will have to be done to reconcile this issue.

It was noted earlier that H.J.A. was crippled during his teenage years when he fell into the vat of tar. This leg continued to bother him throughout his adult life. Given that he was so active in spite of this injury, the leg became infected when he reached the age of 50. The infection progressed to the extent as to require amputation. It was Dr. Wallace Estill of Winchester who performed this operation. He was assisted by H.J.A.'s son, Melchesedek Hill, who practiced medicine in McMinnville. However, the operation did not stem the infection as H.J.A. died nine days after the operation at age 51 on 1 August 1825, four days following his father's death of 28 July 1825.


During H.J.A.'s life, he had moved from the Indian Mound area near Irving College on up the valley and built a home along the main tributary of a creek which came to be called Hill's Creek, named after H.J.A. Hill. H.J.A. built a grist mill on this creek, such building still standing until the early 1950's. The house he built across from where he came to be buried stood until the middle part of the 1900's, his son H.L.W. Hill having raised his family there.

H.J.A. Hill and his stepson, Jesse Savage, also operated a toll road which became known as Hill's Trace. Following a dispute over the management of this road, Jesse Savage struck out on his own and obtained the necessary legislative approval to establish and operate what came to be called the Savage Road.

When Jesse's younger brother, Sterling Savage, Jr., moved his family to the Tennessee area in 1807, Sterling, Jr. moved on up the valley into a gulf to settle and build a house. This region came to take the name Savage Gulf in honor of its first settler, step-son of H.J.A. Hill.

As H.J.A.'s children grew to adulthood, his second son, Isaac Hill, married for his first wife, Eliza Hill, daughter of William and Lydia, who would have been, by virture of Lydia's marriage to Isaac, Sr., a step-sister to H.J.A. Hill. H.J.A.'s third son, Asa Hill, married the other daughter, Louvisa Hill, of William and Lydia. fifth son, Melchesedek Hill, was educated at an academy and became a medical doctor who practiced medicine as a physician in McMinnville for a number of years. H.J.A.'s seventh legitimate child, H.L.W. Hill, was elected, himself, to three terms to the Tennessee House of Representatives followed by one term to the U. S. House of Representatives. H.L.W. was also elected to the Constitutional Convention. H.J.A.'s third illegitimate child, George Washington Hill, went to Texas and became a rather prominent citizen in his own right with both Hill County, Texas, and the town of Hillsboro, Texas, being named for him. Elenza Grundy Hill, the last of H.J.A.'s illegitimate children married John Bess and had a sizeable family. Elenza Grundy's mother, Polly, eventually married a brother of John Bess, husband of Elenza Grundy. By the time of Polly's death, there had come to be placed an iron fence around the burial plot of H.J.A. and Susannah Hill. The legitimate children would not let Polly be buried inside this iron fence. Thus, her children did the next best thing and had her buried at the head of H.J.A. Hill's grave just outside the iron fence. Today, the iron fence has passed into history. However, Polly's grave, as well as those of H.J.A. and wife, Susannah, are well marked and located on the uppermost part of the hill known as Hill's Creek Cemetery with the name having only recently been changed to Center Hill Cemetery.

The Hills following in the main line of descent from H.J.A. prospered or failed to prosper in direct relationship to how the region prospered or failed to prosper. Along about 1840-1850, the region or valley tied its economic livelihood to the brandy industry. The entire valley became one massive orchard. The Civil



Irvin Bowen's son, Benjamin Jefferson Hill, with wife Minnie, would later name one of their sons James Benjamin Hill in continuation of this respect and honor for Colonel (General) Benjamin Jefferson Hill. And, indeed, it was a respect that continued throughout Ben Hill's adult life as evidenced by the large oval portriat of Colonel Hill which hung on the living room wall of Ben Hill's home until his death. This portrait, minus frame, was recently recovered from Ben Hill's old trunk which was left in possession of one of his children.

In conclusion, the above sketch represents only a very brief summary of the ancestry of the Ben Hill family of Beersheba Springs. The writers continue to do Hill family research in preparation for a much more elaborate and expanded version of his history. Any and all materials, regardless of how seemingly insignificant they appear to the owner, are welcomed by the writers as this investigation is pursued. Where requested, such items will be returned to the owner with the expressed appreciation of the writers.

War interrupted, albeit only briefly, this growing and thriving industry. As this industry prospered, the government came to tax the product. Gradually, over time, a few, and then most, came to withhold a portion of their daily run and not declare it for tax purposes. Revenue agents came to police this tax collection process.

Informers soon followed in a natural evolutionary process with a sort of "gurilla war" being waged by the makers and orchard owners against the agent cooperatives with some lynchings following as a consequence. Thus, in a way, success of the industry and the viable climate and geography led to the eventual demise and collapse of the brandy industry, since it threatened to overwhelm the social, moral and governmental fabric that held man to his land. In short, groups taking the law into their own hands threatened the very existence of the legal and political structure and soon came to embellish the area with a moral blemish or stigma. When this is played against the larger context or backdrop of the times prevailing around the turn of the century and on into the era of World War I, the twenties and thirties and resulting economic depression, prohibition and general failure of man's institutions of government, it is easy to understand the poverty conditions that came to prevail in this area.

Our great-grandfather, Irvin Bowen Hill, was born and raised in these times. He was a boy of fourteen at the outbreak of the Civil War. Caught up in the patriotic fever of the moment, he enlisted in the 5th Regiment (later designated the 35th Regiment), Tennessee Volunteers, formed in McMinnville by men from Warren and surrounding counties. They trained briefly at Camp Smartt and were then ordered to Bowling Green, Kentucky. It was during a skirmish around Bowling Green that Irvin Bowen had a horse shot from under him resulting in his being crippled when his mount fell on him. Detailed to light duty as a hospital orderly around the regimental physician's tent, Dr. William Carroll Barnes came to see that he would not soon recover well enough from his injury to be able to return to active duty. This was coupled with Dr. Barnes learning of his youghful age of 14. These two factors influenced Dr Barnes to send Irvin Bowen home on medical discharge.

The custom prevailing at this time was for volunteer units to elect their officers. At the formation of the 5th Regiment, Tennessee Volunteers, the group elected Benjamin Jefferson Hill their Colonel and Commander. Irvin Bowen Hill enlisted at the rank of Private and had been promoted to Sergeant by the time he was injured and discharged. However, during his short tenure, Irvin Bowen came to have such respect and admiration for his Colonel that he named a son, later in life, Benjamin Jefferson Hill, in honor of his respected Regimental Commander. Whether he knew it or not, and this is very doubtful, he was also related to Colonel Benjamin Jefferson Hill who would end the Civil War as Brigidier General. The following diagram portrays this relationship:

He was the Rev. War soldier.

Only wife mentioned in most sources is Phoebe Flournoy, d/o Gibson Flournoy.

R.H. Smith qualified as exr. Sept. 14, 1894. Heirs HERRING, JOHN R. were Mattie Josey (wife of James L. Josey), William Herring (a minor) and Charles Herring (a minor). The said Mattie Josey renounced her right to be gdn. of the orphans and R.M. Johnson was apptd. gdn. Aug. 7, 1894. The dec'd. died in 1894.

The dec'd.'s will had devised a one-sixth share HERVEY, THOMAS, SR. of land to the children of Polly Williams (daughter of Betty Pritchett), with the remaining five-sixths to be divided equally among the other five children of Betty Pritchett: Gideon Harvey Pritchett, Peyton Hervey Pritchett, Betty Hervey Pritchett, Judith Hervey Pritchett and Stephen Hervey for his wife Nancy. The last five persons signed over their rights to the estate to Sarah Ann Hervey (widow of the dec'd.), Feb. 20, 1806. John Williams of Nash County, husband of the said Polly Williams, also signed over his right to the estate to Sarah Ann Hervey, Feb. 20, 1806.

The estate was ordered to be divided, February Court, 1822. HIGGS, JACOB Negroes went to the four sons of the dec'd.: Willie, Joseph, Jacob and Reuben Higgs, July 20, 1822. Legacies were also paid to Sally Higgs, Joseph Higgs, Jacob Higgs, Reuben Higgs and Judea Higgs by Willie Higgs, exr., Feb. 7, 1822. Willie Higgs was apptd. gdn. to the orphans Joseph, Jacob, Reuben and Judea Higgs, Feb. 21, 1825.

This record contains several judgements against P.M. Edmundston in favor of William Fenner, admr. of the dec'd., dated May, 1868. John S. Dancy was later apptd. admr., Dec. 6, 1869 and filed a final account from Dec. 6, 1869 to Dec. 24, 1877.

G.E. Butts was apptd. admr. Aug. 4, 1891. Heirs HIGGS, TEMPERANCE were G.E. Butts and "his brothers and sisters"(sic).

Edward T. Clark was apptd. gdn. to Betty Hyman Hill HILL, CHARLES U. and Thomas Norfleet Hill July 2, 1889 after their father A.B. Hill relinquished his right to be their gdn. The court later recognized that an error had been made and the above named minors were entitled to nothing from the estate of the dec'd. The case was discharged Nov. 28, 1889.

Hanny(?) Bond qualified as exr. May 12, 1881. Only heir HILL, MARY E. was Mary L. Bond.

George E. Spruill was apptd. gdn. of Whitmill Hill, HILL, THOMAS B. Eliza B. Hill, Thomas B. and Winifred B. Hill (orphans of the dec'd.), May, 1825.

James C. Hill and Gilbert Elliott (of Norfolk, VA) HILL, WHITMEL J. having refused to qualify as exrs., Benjamin G. Smith qualified as exr. May 15, 1872. Heirs were Rebecca N. Smith (wife of Peter E. Smith), A.B. Hill, Thomas N. Hill, Louisa C. Smith (wife of B.G. Smith), J.C. Hill and Lucy A. Elliott (wife of G. Elliott of Norfolk, VA). James C. Hill was later apptd. exr. July 28, 1891 , when Gilbert and Lucy Elliott were listed as residents of St. Louis, Missouri.







JAMES HILL FAMILY

According to family tradition, James Hill and a brother migrated from Virginia to Tennessee about the beginning of the 19th century. The brother settled in what is now Union County.

James Hill established a home on Hines Creek, in Anderson County. The site is near Mt. Hebron Primitive Baptist Church. In the same valley, one will find the burial place of his family.

In an old Bible, which originally belonged to James Hill, the following deaths are recorded:

Stephen Claton died March 1, 1819 Cander F. Hill died September 20, 1820 Molly Claton died September 15, 1821 Ery Thu Hill died November 23, 1821 Mary Hill died April 3, 1824 James Hill died September 4, 1826

Stephen Claton and Molly Claton were the parents of Mary Claton, the wife of James Hill. The Clatons were from Wilkes County, North Carolina.

Nothing definite is known about the other three Hills in the above list. Presumably, they were brothers and sisters of James Hill. However, Cander F. Hill could have been a child of James Hill, since it is known that he had a child by that name.

To James Hill and Mary Claton Hill were born the following children:

Eary Hill born January 15, 1813 (Never Married)

Aletha Hill born October 18, 1818 married George Miller and their
children were Tiny, Ruch, Jane, Isaac, and John

Out of this family Marvel Hill became the direct ancestor of the present Hill family. His wife was Milly Cox (born March 1, 1806). She was the daughter of Curd Cox and Susan Overton Cox. It is of interest to note that Curd Cox is listed among the heroes of the American Revolution in Goodspeed's History of East Tennessee, Knox County, Page 957.

Marvel Hill and his wife settled on Bull Run Creek near the site of the Hill Cemetery. The original tract of land contained about 1,000 acres. The old home still stands, and is occupied by Isaac Ellison. Marvel Hill died August 29, 1870, and his wife, Milly, died July 22, 1886.
