Dear Bob:

Thank you for all the new material you sent. I am putting all your research in a special folder to add to all my other files on various families I have worked on. I have many Hill lines, but to date have not placed mine.

If I read you correctly, your Lewis Hill/5 died 7-10-1795. Now check the enclosed list of deeds from Franklin County and we see that Henry Hill sold land 3-30-1792, and Rebecca Hill relinquished her right of dower in the land.

This would indicate to me that this Rebecca was a widow on the earlier date since her husband apparently did not sell with her, unless Henry Hill was her husband.

There obviously were more than one Rebecca in this Hill line. Maybe you can set me straight on this. As you have probably guessed, I am more interested in the name Henry and Rebecca, since both names appear in my family history.

I think I told you that I am not convinced that the Green Hill who married Grace Bennett is a part of the Robert and Tabitha Hill family. You may be correct in thinking that my Hills came from Maryland. Do you have anything at all on the family of Green Hill's son Henry, born 1840? All I have found is that he had two sons, Henry and Green, and was senator of Franklin Co. 1780-1798. I know you think I am wasting a lot of time, but I have good clues that this Green Hill Sr. family is the one we came from, or at least had a close connection.

At the library yesterday I found a few more deeds which might be of interest to you, so will enclose a copy of the transcript. I hope you have a good magnifying glass so all this reading will not put a strain on your good eye. They are coming forth with so much new technology now, you may soon be able to get some of the problems corrected. We have to hope.

I don't want to be a burden to you, so do not feel that you must answer my letters. If I find anything of interest to you, I will send it along.
