This shows James Head received payment in 1845 & 1846 for service in the Revolution. (Is he related to your line)?

SCMAR; Vol V, Number 2, under Spartanberg District (County) S.C. Pages 69-77, Will of a Samuel Farrow, dated 9th January 1824, proved 14th May 1825....A long will and mentions his aunt, Sarah Head ..Quote: "If my aunt Sarah Head is still living, I give to her, \$ 200.00."

SCMAR; Vol VI, Number 4, Page 232: Under Marriage & Death Notices of the (newspaper) Greenville Mountaineer: Quote "Near Hickory Land, Pickens District (County) S.C. on the 22nd of August 1848, (A Marriage) by L. N. Robins, Esq., Mr Jacon Fricks and Miss Elizabeth head, daughter of George Head. (1st September 1848)

SCMAR: Vol. IX, Number 2, Page 92: Under Marriage & Death Notices From the Sumter Gazette: Quote: " Married at Sandy River, Chester District, on the 1st ult., Dr. James B. M'Lelland to Miss Eliza G. Head (August 4, 1832).

THIS ONE I THINK YOU MAY BE VERY INTERESTED IN...... SCMAR: Vol. XII, Number 3, Page 157: Under Marriage, Death and Estate Notices of the Lancaster Ledger: "On Thursday evening the 16th inst. by the Rev. Peter Nicholson, the Rev. L. Head to Miss Rebecca C. Key, daughter of Cap. (sic) Cephas Key, all of Lancaster (District) formerly of Chester (District). (Ibid.)" (Looks like some of the Heads moved from Chester County to Lancaster County, S.C.).

SCMAR: Vol. XIII, Number 1, Page 16: Under War of 1812 Militia Records of Darlington County, S.C.: "Black Creek Muster Roll dated 1813 is listed Absolem Head (crossed out) sic..

SAME BOOK, VOL & NUMBER but next page 17: Under Defaulter deficient in equipments on the 14th May last-being Gen. review: Among those listed was "Absolom Head-excused-not being six months enrolled." (dated 19th June 1813).

SAME BOOK, VOL. & NUMBER but Page 18: Under War of 1812 Militia Records: "South Carolina, Darlington County) We the subscribers thinking it highly important to have a muster house erected on out present muster ground to shelter us from the inclemency of the weather on our muster days and for? the sole purpose of accommodating the company to which we belong as Militia or Alarm Men, promise to pay seven? annexed to our names to Danl McLeod or his successor in office on the third Saturday in Jany (sic) this 20th Nov. 1813.

(43 names listed including Absalom Head 25 (sic).

Note 22 names were crossed out..most had the figure 25 after their names including Absalom Head (who was not crossed out), a few names had the figure 50 after it.

Absalom Head was not listed in the Muster Rolls for the Company in 1813, 1814, but was on the list dated May 1815 but name was crossed out.

Joseph Grisham & Rowland Cobb, who each agree is saying that the Tract of 200 acres as above described, is not worth One Thousand Dollars and that in their opinion it is most for the benefit of the Heirs to sell the same for the purposes of Distribution.

June 13th...Having obtained the consent of those in the District and having published the usual Notice in the Messenger for absent Legatees and no objection having been made to a sale of said Land and on due Examination, It is ordered & Decreed that the lands described in the original Summons the Real Estate of Morgan Morgan (deceased) be sold by the sheriff of Pickens District on the 1st Monday of October next, or on such other sale say as shall be most for the advantage of the parties in interest and on a credit of one & two years, the purchaser giving bond and good security & a mortgage of the premises if deemed necessary to the Ordinary for the payment of the purchase money. 5th September 1836
