Pursuant to a tract requiring partition and division of the estate of MOSES HILL ESQUIRE, deceased, I have reserved the lands belonging to the estate of the said deceased, (one?) CONTAINING 884 AND 1/4 ACRES (THREE OR FOUR WORDS NOT LEGIBLE) each a different tract (AND) all adjoining, the figure of which are contained in the above plats and where as being required by a majority of the commissioners to equally (APPRAISE THE LANDS??) which of a (TWO OR THREE WORDS NOT LEGIBLE BUT APPEARS TO SAY PORTION?) whereof unto two lots of division (RUNNING ALONG?) the South West Fork of Little River (THE BEGINNING LINES N AND S?) which (HAS FORMS SUCH?) that the lots on the West side of the South West Fork of Little River (GRANTED?) unto MOSES HILL, now deceased, contains 449 acres (TWO OR THREE WORDS NOT LEGIBLE?) the lot on the East side of said South West Fork of Little River contains (SOME?) 35 and 1/4 acres-situate in the State and District aforesaid (ON THE SOUTHWEST FORK OF) Little River and (I HAVE SEPARATED? THEM APART) showing such shapes and forms as the above plats represents (ABOUT THREE WORDS NOT LEGIBLE BUT APPEARS TO SAY PESURING LINES DRAFTED?) 23 October 1822.

NOTE: The lower lines (ONE OR TWO WORDS NOT LEGIBLE) being South West Fork of Little River is South 54 West (02?) North 54 East ??? and Little River is the boundary between the above lots of land (THREE OR FOUR WORDS NOT LEGIBLE) from it to a stake corner to a (THREE OR FOUR WORDS NOT LEGIBLE) from South West is Little River to a stake (CORNER?) to a Hickory is 10 chains 64 links of chain and from Little River to stake corner is 13 chains 36 links and the above distances (IS? ARE?) hereto outlined in the above plats.
