

M.022 POWER OF ATTORNEY FROM SAVILLA N. HILL TO SON GEORGE
WASHINGTON HILL ON 15TH DECEMBER 1834. (FILED IN
FAIRFIELD CO. S.C. DEED BOOK PP, PAGES 265-2680

(Note of Explanation: The Hill Family moved from Fairfield District S.C. to Green Co., Ala. ca. April or May 1831. Apparently Savilla Hill gave her son a Power of Attorney to handle affairs of her deceased husband, Moses Hill, but it was lost. She apparently made a new request for the same Power of Attorney. Since recording of deeds and other acts were quite slow in those days, it is obvious that the new Power of Attorney was completed AFTER her death. Savilla N. Hill died on July 23, 1844 in Green County Alabama).

SAVILLA HILL TO GEORGE W. HILL, POWER OF ATTORNEY (of) STATE OF ALABAMA GREEN COUNTY TO THESE PRESENTS, ACTING CLERK OF THE COURT, FAIRFIELD DISTRICT, SOUTH CAROLINA.

Sir: From information given me by my son, George W. Hill, it appears that the Power of Attorney and receipt, given by myself to my said son, G. W. HILL, while S.W. YOUNGE was acting as clerk of said court, for my full distributive share of the real estate of my husband, MOSES HILL, of the District and State above mentioned, deceased, are lost or mislaid said papers were witnessed by JOHN SHIRLEY and were proven before R. T. MOTT ESQ, and left with said clerk for recording and my said son states that to the best of his knowledge, he paid a fee of fifty cents each. I do hereby acknowledge to have duly executed said papers to my said son, G. W Hill for his own exclusive right and behoof. I therefore wish of you please to enter credit on his bond for my full distributive share of said real estate and this instrument shall be binding on myself, my heirs and assigns as much so as the aforesaid Power of Attorney and receipt or any other instrument of writing could or (would?) have bind both in Law or Equity, IN WITNESS where of I have here unto set my hand and seal this 15th day of December in the year of our Lord 1834.

Comments by Robert Hill Sr of Brandon, F;. Savilla Hill had to have given her son, George W. Hill, the Power of Attorney before he sold the home place about 1831. Apparently it got lost (as indicated above). This simply shows Savilla was confirming the act and again gives her son the Power of Attorney.
