Significance of this document is that it is the first document that I have found that actually connects Leonard and Moses Hill together. Now with Susannah Dunford (Dunsford) signing as a witness, it also proves that this is the same Leonard Hill that is later found in Clark County, Kentucky by 1790 and who (in his will) names Susannah Dunford (Dunsford) as the mother of two of his daughters.

HENRY LAND to LEONARD HILL, 100 Acres. Granted 28 July 1774, bordered (by) James Thomas and land laid out to the Irish. Witnesses: Burr Harrison, MOSES HILL, Susannah (X) Dumport (or Davenport). Fairfield B-55 8 Aug. 1785.

CHARLES HILL AND WIFE MARY, SELLS LAND TO WILLIAM TIDWELL (FAIRFIELD DEED BOOK H, PAGES 84 & 85 IN 1772).

Significance of this: This appears to be the same Charles Hill, who's wife was referred to on the fly leaf of the remains of the old Moses Hill bible as Quote: "Coz. Mary Heyll departed this life on 7th of June in the year of our Lord 1827-the wife of Charles C. Heyll." End of Quote. I AM CONVINCED THAT THIS IS CHARLES C. HILL JR, SON OF CHARLES HILL SR., AND BROTHER OF WILLIAM AUGUSTA HILL.

HILL, CHARLES and wife Mary, Granted 28 May 1771. Fairfield Book H, Pages 84 & 85, 1772 To: William Tidwell, 100 acres on Wateree Creek, St Marks R (Road?) Bordered William Hill, Charles Hill Sr. and vacant (lands).

HILL, RICHARD and wife Agnes (x) granted 13 August 1762, To Jane Rogers, spinster and weaver, 100 acres on Bowen's (Bower's?) Mill Creek. Fairfield Deed Book B, pages 113-115. April 5, 1788.

HILL, WILLIAM and wife Dorcas, both (signed by) X to Samuel Mobley. Fairfield Deed Book H-2, 1792 200 A. (acres?) No page numbers given. (suspected son of above Richard?)

HILL, WILLIAM from William Mobley and wife Mary (x) Fairfield Deed Book H, pages? 19-20 1792, 318 acres on Beaver Creek of Broad River. Originally granted to Job Meadow 12 March 1760. Also 50 acres granted to John Mobley 18 May 1771 and also 180 acres, Granted (to) said John Mobley 26 July 1774. Witness: John F. Hill, Richard Hill, William Alsop.

Hill, William Fairfield Will VOL.1, (page?) 83 dated 17 Sole heir William Hill Jr. Date: June 1, 1790. Witnesses: William Alsop, Adam Effird and Richard Odom.

Note by Robert Hill Sr: The above transactions are very important for the following reasons... When Leonard Hill sold his land in 1788, he sold it to a Thomas Hill. Later when Thomas Hill sold the same piece of land, his wife JUDITH signed, thus showing us which of the three Thomas Hills, known to have been living in the area, it was that bought the land. It is my contention that Leonard Hill originally sold the land to his brother THOMAS HILL.

It was the same piece of land that William Augusta Hill had left to his son Richard Hill (wife Agnes) and then Richard & Agnes Hill had sold to Jane Rogers (spinster).

Charles Hill Sr. is named as the father to the William Augusta Hill. Since Charles C. Hill (wife Mary) appears to be Charles Hill JR. (son of Charles Hill Sr.) he would then be the brother to William Augusta Hill.

Now, since Charles C. Hill is now believed to be Charles Hill Jr. and since his wife MARY HILL was referred to as "COZ." (Cousin) in the Moses Hill Bible remains, it is believed that it was acutally Charles C. Hill who was the COUSIN, thus William Augusta Hill and Charles C. Hill (Jr.) would be cousins to Moses Hill.

Now assuming that Moses Hill, Leonard Hill and Thomas Hill (wife Judith) were brothers then, the three would all be cousins to William Augusta Hill and Charles C. Hill Jr. Therefore Charles Hill Sr. (wife Nancy) must be their UNCLE and AUNT (who came to SC from Pennsylvania).
