NOTE OF EXPLANATION BY R. HILL: Spilsby Glenn was the father in law of Moses B. (Berry) Hill, who's wife was Mary Bowles Glenn. The Justice of Peace, John P. (Potts) Roden was the uncle of Moses B. Hill and the brother of his mother Savilla N. (Nance?) Roden. Savilla's mother was Mary Potts who had married Thomas Roden. The Rodens immigrated from Maryland via way of Loudoun Co., Va., then finally into Chester Co. (District) S.C. ca. 1760.
