STATE OF SOUTH CAROLINA) Know all men by these presents that FAIRFIELD DISTRICT) I SAMUEL WEIR of the state and district aforesaid, planter for and in consideration of the sum of One Hundred and Fifty Dollars, to me in hand, paid by JENN WEIR of the state and district aforesaid, have bargained sold and released by these presents, do grant bargain sell and release unto the said JENN WEIR, planter, my eighth (eighth?, meaning one eighth 1/8??) and (of?) claim of that real undivided estate of DAVID WEIR SR., deceased, I the said SAMUEL WEIR do bargain and sell all my part of that two hundred acres of land (200 acres) whereon I now live unto the said JENN WEIR, HER HEIRS and assigns forever and I do hereby bind my heirs Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said JENN WEIR, her heirs and assigns and against myself and my heirs and against every other person or persons-WHOM SO EVER lawfully claiming or to claim the same or any part thereof. WITNESS my hand and seal this 4th day of November in the year of our LORD 1808 and in the 32nd year of American Independence.

4thg Novvember 1808 (date of this deed) was on a Friday.

19th January 1830, date deed was officially acknowledged by court was on a Thursday.

Note by Robert Hill: I do not know who this Green B. Hill was. I have found no such person in the Moses Hill family records. He could be a brother to Moses Hill and the name suggest to me a Maryland origin. This is a 2nd deed found that was witnessed by Green B. (Greenberry) Hill that involves the Moses Hill family. While this deed does not involve the Moses Hill family, a son of Moses Hill named George W. Hill 2/ later had dealings with this Weir family.

There was a Greenberry Hill, son of Thomas Hill that lived in adjacent Union County. This Greenberry Hill was born ca. 1790 (Ref: 1850 census) and died June 22, 1870. His wife was Jane Starnes, dau. of Aaron Starnes. She died on 2nd of January 1874. The father of Greenberry Hill was Thomas Hill and part of a Maryland family. IT could be that this Greenberry Hill knew on or both of the above families and was in Fairfield County and witnessed this deed.
