

MC.002 AN INDENTURE (DEED) SHOWING JOHN MCCULLOUGH SELLING  
50 ACRES OF LAND TO GEORGE AUGUSTUS HILL ON 9TH AUGUST 1792  
(CHESTER COUNTY, S.C. DEEDS, VOLUME D, PAGES 133-137).

Copied & Entered by Robert R. Hill Sr. on 7th December 1988.

Note: I am of the opinion that this George Augustus Hill was a son of Charles C. Hill Jr. & wife Mary, said Mary referred to as "cousin" in Moses Hill bible and wife of Charles C. Hill. Based on a deed giving original grant to a Charles Hill, and date of deeds, I am of the opinion that George Augustus Hill was probably a brother of Burrill Hill, of Rutherford County, N.C.

There is a possibility that George Augustus Hill was a brother of William Augustus Hill, and thus were sons of Charles Hill Sr. (Wife Nancy), all of old Craven County, S.C. (today's Fairfield County).

THIS INDENTURE made this Ninth (9th) day of August in the year of our Lord, One Thousand Seven Hundred and Ninety Two (1792) and of the Independence of the United States of America, the Seventeenth (17th), between JOHN MCCULLOUGH of the State of South Carolina and County of Chester of the one part and GEORGE AUGUSTUS HILL of the state and county aforesaid, storekeeper, of the other part, WHEREAS in and by a certain grant bearing date of the 23rd day of June in the year of our Lord One Thousand Seven Hundred and Seventy Four (1774) and in the Fourteenth year of his Majesty's reign, under the hand of his Excellency WILLIAM BULL, Lieutenant Governor and Commander in Chief on and over the (then) Province of South Carolina and the great Seal of the (then) Province for that (word unreadable) appointed, did give and grant unto ROBERT MORRISON a plantation or tract of land containing 100 acres in CRAVEN (now Chester) COUNTY on a Branch of Rocky Creek, bounded Northeast on Samuel McCullough, James Raiford and Alexander Henry, Southeast by William Gaston & Alexander Roseborough, Matthew Gaston & Alexander Roseborough, S.H. Mose, Bishop's land and hath such shape and marks as appears by a plat thereof to the said grant annexed as in and by the said plat, and duly recorded in the Secretary's Office of said Province, reference being there unto had may (made) more fully appears which said plantation or tract of land containing 100 acres as above mentioned and described hath transferred and legally conveyed to the said JOHN MCCULLOUGH by the said above mentioned ROBERT MCCULLOUGH which by deed of conveyance bearing date the Ninth (9th) day of June in this present year 1792 which hath been recorded in the Clerk's Office of Chester County. Now this Indenture, WITNESSETH that the said JOHN MCCULLOUGH for and in consideration of Ten Pounds Sterling money to the

said JOHN MCCULLOUGH in hand, well and truly paid by the said GEORGE AUGUSTUS HILL, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged and to be fully (Contracted?) (another word not legible) and paid hath granted, bargained, sold, aliened, (revised?) and released, conveyed and confirmed and by these presents doth grant, bargain and sell, alein, revise, release, convey and confirm unto the said GEORGE AUGUSTUS HILL in his actual possession, now being by viture of a bargain and sale to him for one whole year and by force of the statute for transferring of uses into possessions and to his heirs and assigns forever, all that plantation or a tract of land containing 50 acres, lying and being in Chester County, on a branch of ROCKY CREEK beginning at a Hickory & running N 40 E 89 chains, 52 links to a stake, thence N 45 E 15 chains to a Black Oak, thence S 10 W 42 chains to a stake, thence N 75 Rd (Rods?) to the beginning corner, TOGETHER with all and singular the houses and house edificies and buildings, barns, stables, yards, gardens, orchards, woods, underwoods, woods timbers, trees, meadows, pastures, ponds, lakes and fishing ways, waters and water courses, paths, passages, profits, (a word?) privileges, hereditaments, rights, members & appurtenances thereunto belonging or in any way appertaining & the revision or revisions, remainder or remainders, rents, (a word?) & profits thereof and every part and parcel thereof and all the estate rights, titles, interest, use, trust, possessions, property, profits, benefits, claims, & demands WHAT SO EVER of him the said JOHN MCCULLOUGH of into out of the same premises and every part thereof, and all evidences, receipts, writings, WHAT SO EVER touching or concerning the said premises and every part thereof TO HAVE AND TO HOLD the said plantation or tract of land containing 50 acres with all the premises and appurtenances hereunto belonging herein before granted and conveyed unto the said GEORGE AUGUSTUS HILL, his heirs and assigns forever, to the only proper and absolute use and behoof of the said GEORGE AUGUSTUS HILL, his heirs and assigns and the said JOHN MCCULLOUGH doth hereby for himself his heirs and administrators and assigns promises convent and agree with the said GEORGE AUGUSTUS HILL his heirs, Executors, Administrators and assigns in manner and form following, that is to say that he, the said JOHN MCCULLOUGH now is and until the execution of these presents shall stand seized of a good sure perfect and indefensible estate of Inheritance in fee simple of and in all the aforesaid plantation or tract of land containing 50 acres with the profits rights members and appurtenances without any manner of condition, trust, mortgage, judgement, execution or incumbencies what so ever to alter, change or determine the same, and also the said GEORGE AUGUSTUS HILL his heirs and assigns shall and may from time to time and at all times hereafter peaceably and quietly have, hold, use, occupy and possess and enjoy the said plantation or tract of land containing 50 acres with every--? the premises and appurtenances thereunto belonging without any manner of

trouble, hindrances, molestation, denial and interruption of him the said JOHN MCCULLOUGH for himself, his heirs, executors and administrators the said plantation or tract containing 50 acres with the premises and appurtenances thereunto belonging unto the said GEORGE AUGUSTUS HILL his (a word?) his heirs and assigns and all and every other person or persons whom so ever shall and will warrant forever defend by these presents IN WITNESS, whereof I the said JOHN MCCULLOUGH have hereunto set my hand and seal the day and year above written (9 August 1792).
