MD.008 GENEALOGICAL INFORMATION ON HENRY HILL (1695-1773) OF FREDERICK COUNTY, MARYLAND AND HIS DESCENDENTS, OBTAINED BY L.P. (SKIP) HILL.

Sources: A Little of my own research and data provided by L.P. (Skip) Hill of Harrisonburg, Virginia.

Note: L.P. (Skip) Hill has done a very remarkable job of researching this family in Maryland. He is to be given credit for most of the research in Maryland. My research was mostly confined to South Carolina, and the Henry Truman Hill family.

HENRY HILL 2/ (SON OF ROBERT HILL)

During the later part of the 17th century (late 1600's) and the early 18th century (early 1700's), there appeared to be two prominent Hill families in Maryland History. One was the Hills that lived in and around the West River Quakers in Ann Arundel County. The given name of Henry was often used by this Hill family. This family is well documented but nothing has been found to link the above Henry Hill 2/ as part of this line.

The other well documented Hill family was the Clement Hill Family, who were associated with the famous Carroll Family of Maryland. These Hills were Roman Catholics and while the name of Henry was often used, it does not appear that Henry Hill 2/ or his family were part of this line either. Not one single member of Henry Hill's family has been found to be of the Catholic religion.

The thinking is that Henry Hill 2/ was a son of Robert Hill 1/. When Robert Hill 1/ of Charles County, Maryland died in 1697, his widow Mary Hill was left with "a good many poor children." Mary Hill died shortly after her husband and based on data found by Skip Hill in the Maryland Hall of Records in Annapolis, Maryland, left many Hill orphans (children). This information can be found in Liber 18, Folio 242 and Liber 18, Folio 78 in the Hall of Records in Annapolis, Maryland.

Henry Hill 2/ is believed to be one of those orphan children as he probably named his first born son, Robert Hill 3/, after his own father, Robert Hill 1/.

Now there was an early Truman Family located in Charles County, Maryland, in an area located Northeast of todays Bryantown. Now based on the fact that Henry Hill 2/ named a son Henry Truman Hill 3/, leads us to believe that Henry Hill 2/ was probably of a Southern Maryland origin. He was

located along the border of south Prince George County and Northern Charles County, Maryland in the early 1700s.

Further location of Henry Hill 2/ is supported by information found in the Prince George Testamentary Proceedings Index for 1736, Page 484 which shows a Sarah Glaze bringing the will of her husband John Glaze from Charles County to court. She is listed as the Executrix of the will and suritors for her bond was Richard Wilson and Henry Hill of Charles County. The Glaze farm is said to have been located in the same area as the Trumans lived in Charles County, Maryland.

Later, Henry Truman Hill 3/, owned a 243 acre farm named "Buthinton," which straddled the Charles County and Prince George County lines.

Other "poor Hills" found in this area were a Thomas Hill who died in 1732 and a John Hill, who had to petition the courts for help in 1736-38. It is felt that both of these men were part of the afore mentioned Robert Hill 1/ family and probably were brothers to Henry Hill 2/.

There has been found no records what so ever of Henry Hill 2/ of Frederick County, Maryland either buying or selling land nor has there been found any residue of land willed, real or personal received by Henry Hill 2/. Skip Hill is convinced that he was the son of Robert Hill 1/.

In the early 1700s all of the western part of present day Maryland was known as Prince George County. Frederick County was formed from the part of Prince George County in 1748. Prince George County Land Record, Book B#1 (1743-46) Pages 185-186, dated March 25, 1744 shows a lease of 100 acres of Carrollton Manor from Charles Carroll, Esquire of Annapolis, Maryland to Henry Hill for 17 and 1/2 years. This is the first piece of documented evidence of Henry Hill 2/, the patriarch of this Hill Family. Henry Hill's 100 acres was located in the vicinity of today's Buckeystown, Maryland.

Note by Skip Hill: Reference to the lease dates in those days, until 1752 March 25th was considered like the first day of the year. This date was known as the "Feast of Annunciation" or "Lady Day." It was also near the first day of Spring and thus was considered the first day of the year for leasing purposes. Usually rents were payable then and at "Michaelnas," which was on 29th of September, was considered the first day of fall.

Henry Hill 2/ left a will in 1773 in Frederick County, Maryland. Since there is no mention of a wife, it is felt she had apparently died prior to Henry. The will mentions six sons and three daughters. Skip Hill states that he believes that the sons are listed in order according to age. Those sons were: Robert 3/, Joseph 3/, Henry Truman Hill 3/,

Phillip 3/, Thomas 3/ and John Hill 3/. The girls named were Elizabeth 3/, Catherine 3/ and Ann Hill 3/.

This is the first Hill will listed in Frederick County, Maryland (Maryland Provincial Wills 39184). Henry Hill 2/ signed the will by mark, indicating illiteracy. The will directs the sons Robert 3/ and Joseph Hill 3/ to divide his personal estate among the nine children. His 50 acres (Park Hill) Farm was bequeathed to the son John Hill 3/.

Both Skip Hill and I have come to the conclusion that earlier genealogists and other Hill researchers have missed a generation and have treated the grandsons of Henry Hill 2/ as his sons.

In Frederick County Court Term for March 1759, Henry Hill 2/petitions the court for relief, stating that he was not able to make a living since he "being upwards of sixty years of age." This places his birth ca. 1695. His rent would appear to be coming due at this time (March). The court awarded him 800 pounds of tobacco.

Henry Hill's 2/ older boys were born in the 1720's with John 3/ being the youngest, born in 1735. Robert Hill 3/, Joseph Hill 3/, Henry Truman Hill 3/, Phillip Hill 3/ and possibly Thomas Hill 3/ were young men, probably married and starting their own families by 1744 when Henry Hill 2/ leased his farm.

The Calendar of Maryland State Papers-The Black Books, page 227. Item 1582-shows that ca. 1745-46, Henry Truman Hill 3/ and Joseph Hill 3/ signed a petition with other Prince George County residents who were living along the Monocacy River. The petition was asking for an appointment to fill the Office of a Justice and was signed ca. 1745-46, before Frederick County was formed. Henry Truman Hill 3/ and Joseph Hill 3/ had to have been at least 21 years old to have signed this petition, which places their births in the early 1720's.

There are records available in the Maryland Historical Society at Baltimore, that gives some record of Charles Carroll of Annapolis, Maryland and the early Hills of Carrollton Manor. The book that they have is part of the Carroll Collection and is for 1754-1784. The first book for the period of 1700's-1754 is missing.

The following is from Charles Carrollton's Account Books from Carrollton Manor:

Henry Hill? 1773 (fol.31) rent account has been carried forward from liber T (the missing book) fol.63, 110

Joseph Hill Jr. (fol 86) appears to have assumed case's lease in 1777 or 1778: was charged for surplus land from 1777

Phillip Hill (and Penelope (Robey?) (fol. 59) was charged for surveying in 1769 (This might mean a new lease until the next entry was found)
Phillip's last lease 1769-74
Penelope's lease 1774-79

Robert Hill (fol.32) Liber T. fols. 62, 116 last lease 1767-78

Joseph Hill 3/ did not lease from Mr. Carroll but just to the west of Carrollton Manor and on the east side of Catoctin Mountain, between the present day Point of Rocks, Maryland and Frederick, Joseph Hill 3/ bought his 87 acre "Mountain Branch" farm on 9th December 1749.

It appears that Joseph 3/ may have married into a family of wealth or his wife may have been a lady with money for he is the only one of Henry Hill's 2/ sons to own land early.

On June 7th, 1758, Joseph Hill 3/ bought "Lashmuts Folly." On April 29th, 1769 he bought "Ralph's Field and on October 23rd, 1779, Joseph Hill 3/ bought "Mountain Glade" and other farms too. All of these tracts are adjacent and in 1796 he re-surveyed all of the parcels of land into one tract and named it "Mountain Fields." This survey is on file in the survey book of Frederick County, Maryland and totals 300 acres.

Now as for Thomas Hill 3/ the only thing found was an item in the Maryland State Papers-The Black Book, page 180, Item 1244 in which a Mrs. Nichols, a William Nichols, THOMAS HILL and William Ellston petitioned Governor Horatio Sharpe to pardon or reprieve two slaves sentenced to death. (William Nichols was a witness to the will of Joseph Peach as well as being a witness to the will of Joseph Peach Jr. More about this later).

John Hill 3/ was nine years old when his father Henry Hill 2/ rented his farm in 1744 and seems to have stayed with his

father until Henry Hill's 2/ death in 1773.

Early Court records of Frederick County, Maryland shows some early problems for this Hill family but after the mid 1770's only the usual debt cases are found. These cases concern mainly the grandsons of Henry Hill 2/ and were helpful in reconstructing the family.

In the November court 1751, James Burgess and his wife Alice vs. Joseph Hill "in a plea wherefore with force and arms he the said Joseph Hill upon her the said Alice at the county aforesaid an assault did make and her the said Alice did beat wound and evilly treat so that of her life it was despaired and other harms to her did to the great damage of them the said James and Alice and against our peace, etc.." A jury was impaneled who found for the plaintiffs awarding James and Alice Burgess a judgement against Hill for ten shillings and 1,293 pounds of tobacco for their costs.l

Frederick County Court Judgements, 1748-1765: "William Hayward of Anne Arundel County, Maryland, removed up back in the woods, from thence down to Monacacy, he being there in debt to a certain Joseph Hill of Monacacy and had not the money to pat him. When he came up the country last July (1748) a bound girl Mary Thacker) was sold as a servant (by Hayward) to the said Hill for three years to pay the debt. Mary Thacker, now about fourteen years old, petitions the court for liberty and the court ordered a summons issued returnable to the next county court for the said Joseph Hill to answer the complaint (March Court 1748).

In the March Court Session for 1749 "Mary Thacker age fourteen the 25th of October next (1749), is by the court here bound to Joseph Hill until she arrives to the age of sixteen. The said Joseph Hill promises to learn her to read distinctly in the Bible and to give her at the age of expiration of her time of servitude, a gown and petticoat made of linsey woolsey, a paid of shoes and stockings, an apron of white linen, two white hats and two shifts-one of brown and the other of white linen."

At the March Court of 1751-52, Elizabeth Hill of lower part of Monocacy Hundred is presented by the grand jury for having a baseborn (meaning child out of wedlock) child. Skip Hill states that he feels this is Henry Hill's 2/ daughter Elizabeth. Skip Hill states: "She would be in her early twenties. This is the only mention of any of Henry's daughters."

THE SONS OF HENRY HILL 2/.

Robert Hill 3/ (ca. 1720-1796). Robert 3/ was the oldest son and is listed first in Henry Hill's 2/ will. According to Charles Carroll's account books, Robert 3/ rented his own land on Carrollton Manor earlier than any of his brothers.

Skip Hill states that shortly after his father (Robert 1/) Henry Hill 2/ rented his farm in 1744-around 1746-47 and thinks that Robert Hill 3/ was named for his grandfather (Robert Hill 1/). Skip goes on and states that he thinks that Robert Hill 3/ married Rachel Robey of Charles County, Maryland and had the following sons, among others:

Robert Hill 4/, Benjamin Hill 4/, and Henry Robey Hill 4/. (The Robey Family was concentrated in Charles County, Maryland).

Now the reason for the above deductions are that it is obvious from Henry Hill's 2/ will that Robert Hill 3/ is in the area in 1773 to administer his estate. In the 1790 Census of Frederick County Robert Hill 3/ is living in a cluster of Hills with Henry Robey Hill 4/, Benjamin Hill 4/ and Robert Hill 4/. Skip states that he think that Robert Hill 3/ introduces the name of Benjamin into this family, the name being carried on in this Hill family until the present time.

Robert Hill's 3/ son, Benjamin Hill 4/ married Sara Scaggs in 1778. The following items can be found in the Register of the Evangelical Lutheran Church of Frederick, Maryland.

Note by Skip Hill: (This is during a period of history when the Anglican priest had been run out of town because of the Revolutionary War and the Lutheran church was the only one available for marriages, baptisms etc..).

"Benjamin Hill and his wife Sara baptized their son Robert on November 24, 1782. The sponsor was Robert Hill, Benjamin's father."

"Benjamin Hill and Sara baptized Phoebe on August 31, 1784 and John on September 2, 1786."

Robert Hill 3/ was the only Hill in Frederick County that had an administrative account settled before 1800. He (Robert Hill 3/, son of Henry 2/) died in 1796 and HIS son Robert Hill 4/ settled his accounts. Robert Hill 4/ never bought or sold land in Frederick County and probably died on a rented farm in Carrollton.

JOSEPH HILL SR. 3/ (1723-1798) SON OF HENRY HILL 2/.

Joseph Hill 3/ died in Mason County, Kentucky, leaving a will which was recorded in both Mason County. Kentucky and Frederick, Maryland. The will names the following children: Henry Hill 4/, Joseph Hill Jr. 4/ Nathan Hill 4/, Thomas Hill

Henry Hill 4/, son of Joseph 3/ (Henry 2/, Robert 1) went to Newberry County, South Carolina. He paid 36 pounds for the 30 acre "Mountain Glade" land and when he sold this tract to his father, Joseph Hill Sr. 3/, on 23rd October 1779, he received 400 pounds. This in effect was Henry's inheritance which is why he received only 10 pounds in Joseph's will, while the other heirs received approximately 400 pounds each.

Note: I am of the opinion and Skip Hill agrees that past researchers have confused Henry Hill 4/ with his uncle, Henry Truman Hill 3/, who was also in South Carolina, arriving some 8 to 10 years prior to the arrival of Henry Hill 4/ and his wife Alice Ridgley.

Based on records from the Carroll account books it is known that Joseph Hill Jr. 4/ assumed a lease of a Mr. Case in 1777 or 1778 and that the last renewal of this lease ran from 1778-1784. The will of Joseph Hill Sr. 3/ (his father) did not mention the names of the children of Joseph Hill Jr. 4/ and his wife Margaret.

Frederick County Final Account RB 1-(1806-1809)-202 of a Christian Hill, administrator of the will of "Margaret Hill, late of Frederick County, deceased" shows the following children as receiving shares. This seems to be the children of Joseph Hill Jr. 4/ and wife Margaret Rowe:

Elizabeth Fisher 5/ Christian Hill 5/ Lewis Hill 5/ Ruth Jenkins 5/.

Nathan Hill 4/, son of Joseph 3/ (Henry 2/, Robert 1/) was born ca. 1756 and he was the third son of Joseph Hill Sr. 3/. He was the son that inherited the 150 acres Mason County, Kentucky farm. Skip states that he feels that Nathan 4/ was living on the farm in 1798 when his father left Frederick County, Maryland and probably went to live with Nathan in Kentucky. Skip states that the Mason County Historical Museum in Kentucky at Maysville states that Nathan Hill and his family can be fairly well documented by future researchers.

Records of the Evangelical Lutheran Church of Frederick County, Maryland shows a Nathan Hill and Barbara Hill baptizing a son Joseph Hill on August 29, 1783. The same church records shows a Nathan Hill marrying Druscilla Davis on 17th September 1786. The latter marriage was witnessed by Joseph Hill, Levi Davis and Robert Hill. Skip Hill states her is not sure if this is the same Nathan Hill and further research in Kentucky might answer this question.

When his father died, the son Nathan Hill 4/ was in Kentucky and he handled the portions of his father's estate that was in Kentucky. Both are named as executors in the Frederick County, Maryland will (G.M. 3-274).

Thomas Hill 4/, son of Joseph 3/ (Henry 2/, Robert 1/) was born in 1759. He married Sarah Howard on 16 April 1783. She was the daughter of Cornelius Howard of Frederick County, Maryland. The estate of Cornelius Howard dated 20th October 1791 (GM 2:214,219) lists Joseph Hill as a debtor. It is not clear if this was Joseph Hill Sr. 3/ of Jr. 4/.

Thomas Hill 4/ along with his brother Nathan 4/ were named as executors in their father's estate (Joseph Hill Sr. 3/). When Joseph Hill 3/ died his son Thomas Hill 4/ was living in Frederick County, Maryland. Thomas 4/ handled the Maryland part of his father's estate affairs.

Thomas Hill 4/ filed his father's final account and the Kentucky settlement was included in the account (R.B. 2-(189-1811)-101 and was passed by the Orphan's Court for Frederick County on 14th November 1809.

Thomas Hill 4/ and his wife Sarah finally settled in Miami County, Ohio. Thomas 4/ die in Miami County, Ohio in 1821 and he is buried in the Pleasant Hill Cemetery. IN Will Book Number 1 of Miami County, is shows that he had a son named John Hill 5/, born in 1783, who fought in the War of 1812.

Another known son was Nathan Hill 5/, born on 15th March 1788 near Elliott's Mill, Maryland. He died in Miami County, Ohio on the 15th of January 1862 and was buried on the 29th of January 1862.

Other children were Barbara Hill 5/, born on 21st June 1814 and died on the 15th August 1862, and was buried at Pleasant Hill Cemetery in Miami County, Ohio.

Still other children were Elizabeth Hill 5/; Sarah Hill 5/; Thomas Hill 5/; Jonathan Hill 5/, who was born on 17th February 1793 and Matthew Hill 5/.

Thomas Hill 4/ states that he came from North Carolina to Miami County, Ohio and that he was a son of Joseph Hill, who died in 1798. This particular Hill Family appears to have had some Quaker influence in that they mention the "Back Creek Meeting" in North Carolina.

Extensive research on this family has been done by Mrs. Jerome R. Jekel, 240 Palmer Park Blvd # 207, Colorado Springs, CO. 80909.

Ruth Hill 4/, was a daughter of Joseph Hill Sr. 3/, son of

Henry 2/, Robert 1/). She married Richard Ankrom Jr. and was named in her father's will. This marriage was before 1778 when Maryland started issuing marriage licences and records. Skip Hill is of the opinion that she was the second child of Joseph Hill Sr. 3/.

The Ankroms lived just south and west of Joseph Hill's Sr. 3/property, towards the Potomac River in Maryland. Ruth was probably the name of Joseph Hill's 3/ wife but has not been proved.

Skip Hill states that Richard Ankrom in later years can be found in southwest Pennsylvania and the land grants can specifically be pinpointed in the map volume of the Horn Papers of southwest Pennsylvania.

Now after reviewing the above information, it can be seen why Joseph Hill Sr. 3/ would sell his Maryland lands and leave Maryland in 1798. His son Henry Truman Hill 4/ was in South Carolina, Joseph Hill Jr. 4/ had died, daughter Ruth 4/ and her husband were in southwestern Pennsylvania and Thomas 4/ and wife Sarah were in Elliott City, Maryland. It appears that Joseph Hill Sr. 3/ decided to go to the farm in Mason County, Ohio and live the remainder of his days with his son, Nathan Hill 4/.


Now as stated before it is felt that Joseph Hill 3/ had married a woman of some wealth prior to buying "Mountain Branch" in 1749.

Now the earlier mentioned court case that involved Mr. Hayward indicates that Joseph Hill 3/ was in the upper areas of Ann Arundel County in 1746-1747 and he could have married a woman from that area. It is known that he had a daughter named Ruth Hill 4/, which may be a clue to his wife's name. Once again the collection of Maryland State Papers-The Black Book, Page 86, Item 568, shows Joseph Hill 3/ signing a petition to Governor Ogle, just prior to his buying land in lower Frederick County.

Before Joseph Hill 3/ left Maryland for Kentucky, he sold all of his land holdings in Frederick County, Maryland. (Deed W.R. 16-354 and W.R. 16-356). When he died in Kentucky he owned the Kentucky farm and cash and bonds from the Maryland sales. In checking the Frederick County Court Dockets, the name of Joseph Hill Jr. 4/ appears often in the late 1770's and the 1780's. Suddenly in 1794 his name disappears and his wife Margaret appears to take over the collection of debts.

Skip states that Quote "It is right here where I think past researchers of the Hill Family have made a mistake. The Henry Hill, who bought the 30 acre "Mountain Glade" farm on 12th January 1773 (Deed P-597-98) from William McCarty was Henry Hill 4/ the son of Joseph Hill Sr. 3/ (son of Henry Hill

McCarty (spelled various ways) bought this land on 27th February 1755 and it was adjacent to "Ralph's Fields" which Joseph Hill Sr. 3/ purchased in 1769 as previously mentioned and "Mountain Glade" was part of his re-survey in 1796. Henry Hill 4/, son of Joseph Hill 3/, would have been born ca. 1746 and probably married in the 1760's in Frederick County to Alice Ridgley.

- 4. Mary Hill, b. ca. 1786 ???, married Hosea Canady (Kennedy).
- 5. Green Berry Hill, b. ca. 1789-1790 in S.C., married Jane Starnes, he died 22nd June 1870 in Union Co., S.C. He & wife buried Padget Creek Baptist Church, Union Co., S.C.
- 6. Bird (Byrd) Hill, b. ca. 17990-1792 in S.C.
- 7. Drucilla Hill, b. before 1794 in S.C., married Sampson Gilliam. He was dead by 14 Jan. 1828, Drucilla still alive.
- 8. Catherine Hill, b. ?? in S.C., married Ira Casey, she was dead by 28th September 1828.
- 9. Winifred Hill, b. between 1790-1800 in S.C., married James W. Willard.

NOTE: Thomas Hill was first suspected by me to be a brother of Henry Trumna Hill but have since changed my thinking. Other researchers feel he is somehow related to this Maryland Hill Family, but so far no connection has been established.

HENRY TRUMAN HILL 3/ (1725-1797)

Henry Truman Hill 3/ was a son of Henry 2/ (Robert 1/)/. Henry Truman Hill 3/ had moved from Maryland to South Carolina in what is today's Newberry County. South Carolina information on him is scarce and has been rather difficult for us to find. Skip Hill has also stated the same fact.

A Will of a William Cooper of Ninety Six District dated June of 1775 was witnessed by Henry Clark, HENRY TRUMAN HILL and Mary Pritchard.

Skip Hill has pointed out that both the Clark and Cooper Families were originally Maryland Families and participated in the large movement south by the Maryland settlers.

Skip Hill located in Volume 13, 1914, Page 263 of the Maryland Historical Magazine that a John and Henry (T.) Hill collected pay for efforts in the French & Indian War. Both men served in Captain Elias DeLashmut's Company. The pay was for service in 1758.

(Note: There was a DeLashmut located in today Fairfield County, S.C., adjacent to Newberry County, S.C.)

Now I have been of the opinion that it was Henry Truman Hill 3/ that married Elizabeth Peach and on this matter Skip Hill concurs and (I think) has proved the point.

Elizabeth Peach was a daughter of of Joseph Peach, who arrived in Maryland ca. 1720 as a young schoolmaster. He married Mary Isaac, a daughter of Richard and Sarah Isaac. The marriage was on 17th February 1726 and the ceremony was performed by Rev. Jacob Anderson of Queen Anne's Parish.

Joseph Peach started acquiring land along the Patuxent River in 1726. In his will, dated 26 January 1760 and probated on October 30th, 1764, there are listed five sons and four daughters. The third child and first daughter listed was Elizabeth Peach, who was born on 27th April 1733 and married _____? Hill.

This birth date clearly shows that Elizabeth Peach was younger than Henry Hill 2/, whom most researchers said she had married. Henry Hill 2/ was born ca. 1695 and died in 1773. Elizabeth Peach was younger than most of his children and her birth dates seem to me to coincides more with the son Henry Truman Hill 3/ and thus the reason for my thinking it was he that she married.

PHILLIP HILL 3/ (1726-SEPT 1774) SON OF HENRY HILL 2/.

Maryland Testamentary Proceedings 1634-1777 (Liber 46: 158) of Frederick County, Maryland show returns dated 9th September 1774, Administrative Bond of Phillip Hill (Estate) by Penelope Hill, administrix, with William McCarthy and Joseph Hill. Surities was 300 pounds sterling, dated 3 June 1774.

Frederick County Inventory Account Book 8, Page 60:

Phillip Hill and Penelope Hill.

Phillip's estate was appraised by Joseph and Thomas Johnson at 65 pounds, 18 shillings and 8 pence.

Creditors were: Roth Ferguson for James Glassford and Company, Robert Hill (kin?), HENRY TRUMAN HILL. 6th October 1774. Sworn to by Penelope Hill, administrix.

An account book of Mr. Charles Carroll shows a lease for Phillip Hill and Penelope Hill dating 1769-1774 and when Phillip died, Carroll extended the lease for Penelope, his widow, until 1779. This lease was also transferred from the first account book (missing) which would cover the time period to 1754 and before.

Skip Hill states that he feels that the children of Phillip Hill 3/ and wife Penelope were:

William Hill 4/, born ca. 1748. James Hill 4/, born ca. 1753. Thomas Hill 4/, born ca. 1756. Zephaniah Hill 4/, born ca. 1758.

JOHN HILL 3/ (1735-1803) YOUNGEST SON OF HENRY HILL 2/.

John Hill 3/ was the youngest of Henry Hill's 2/ six children, being nine years old when his father rented from Charles Carroll on Carrollton in Maryland in 1774. Skip Hill states that he thinks John Hill 3/ spent his early days helping with the daily chores on his father's farm.

Skip states that the earliest record he can find for John Hill 3/ is from the Committee of Observation of Frederick, Maryland. This was reprinted in the Maryland Historical Magazine, Vol. 13, in 1914..The article shows that John Hill 3/ was serving with his brother Henry (T.) Hill 3/ in the French and Indian War, in the company of Captain Elias DeLashment's. It shows a muster roll call for 1758. John Hill 4/ would have been about 22 or 23 years of age during his service in the French and Indian War.

His five brothers were already married and having children of their own. John Hill 3/ and his father Henry Hill 3/ were living on the leased farm near present day Buckeystown, Maryland with their lease expiring in 1761.

Skip Hill states that John Hill 3/ married Elizabeth Buher in 1762. As a wedding present or probably "a thank you" for sticking with him, his father Henry Hill 2/ conveyed to John

Hill 3/63 acres of his 113 acres on 19th November 1762 for 15 pounds in Frederick County. (Deeds of that county, Liber H. folio 24). This left Henry Hill 2/ (the father) with 50 acres which he bequeathed to John Hill 3/ in his 1773 will.

John's mother must have been deceased at the time the will was wrote as she is not mentioned in the will of her husband, Henry Hill 2/.

The following is the children of John Hill 3/ and wife Elizabeth Buher:

- 1. John Hill Jr. 4/, b. 27 July 1792, married Rachel Butner.
- 2. Joseph Hill 4/, born 1764, married Rosanna--? others later.
- 3. Jacob Henry Hill 4/, born 1766, married Mary or Jemima ??
- 4. Phillip Hill 4/, born 3rd February 1769, married Elizabeth Spear.
- 5. Thomas Hill 4/, born 1772, married Elizabeth--?
- 6. Elizabeth Hill 4/, b. 1774.
- 7. Sarah Hill 4/ born 1776.
- 8. William Hill 4/, born 1778, died in N.C. as a youth.
- 9. Samuel (Judge) Hill 4/, born 2nd July 1779, married Jane Easton on 27th January 1799.
- 10. Benjamin Hill 4/, b. 1784, married Isabelle Ann Hewitt on 1st November 1804. He died on 30th September 1831.

Skip Hill states that all of the above children were born at "Park Hall" with the exception of Benjamin Hill 4/, who was born in Salisbury, North Carolina.

He goes on and says "John and Elizabeth Hill sold Harmon Clapper 113 acres of Park Hall in November of 1780. (Washington County, Md. Deeds Book B, 2: 408-410). The price was 400 pounds and the deed states that John's father was Henry Hill, deceased. This land sale was in preparation for the entire John Hill family to move to Rowan County, North Carolina.

This family spent the next seventeen years in North Carolina around Salisbury, where a number of the children marry, start families and remain basically farmers.

John Hill Jr. 4/ became the jailer in Salisbury in the late 1700's. The historical court square today lists some of his property on the north side of the square. His father John Hill 3/ owned a farm outside the town.

Skip Hill states that he does not know the reason for a move of this family from Maryland to North Carolina but if the family pattern was being followered, there were relatives there.

For some unknown reason by ca. 1800 this family packed up again and headed for the northwest territory. Grandchildren

were not involved in this move.

After staying a year in Newport, Kentucky, they settled in the area of Cincinatti, Ohio. Further information on this family can be obtained from the Histories of Clermont, Hamilton and Warren Counties Ohio.

Skip Hill states that a Mrs. Ruth Hill of Milford, Ohio has adocument in which was written by Aaron C. Hill. He states his great great grandparents were John Hill and Elizabeth Hill. After travelling around thge county, visiting many relatives, he wrote this interesting account of the family. This deals only with the John Hill 3/ and Elizabeth Hill Family of "Park Hall" Maryland.

Another interesting item is that from the Goshen Methodist Church records by Rev. Francis McCormick shows that henry Hill's 2/ grandson, Joseph Hill 4/ his wife Rosamund, another grandson, Phillip Hill 4/ and his wife Elizabeth, and Jane Easton, wife of a grandson Samuel Hill 4/, were members and leaders of the First Methodist Sunday School Class in the Northwest Territory in 1798. (Note by Skip Hill: The wife of Francis McCormick was a sister of Jane Easton).

These were all children of John Hill 3/ and his wife Elizabeth Buher and listed above.

COMMENTS MADE BY L.P. (SKIP) HILL ABOUT HIS RESEARCH IN MARYLAND

Skip Hill states that there was a Richard Hill in the 1790 Census of Frederick County, Maryland who married Mary Wells and was located in the northeast section of the county in "Towneytown-Haraey area. Richard Hill has sons named Abraham Hill; James Hill; Isaac Hill; William Hill; and Richard Hill. He stated that he could make no connection to these Hills to the Henry Hill line.

There was a Robert Hill 4/, born 2nd June 1764 that married first to Eleanor Hyfield in 1786 and secondly to Amelia Fitzgerald in 1790. This was the grandson of Henry Hill 2/ and son of Robert Hill 3/.

Frederick County Records WR #18, 383/384 dated June 1795 shows him selling livestock and two beds to Joseph Hill and then moving with his family to Mason County, Kentucky.

Robert Hill 4/ died there in 1846. From his first marriage he had a son Benjamin Hill 5/, who married Sophia Tarleton. He and his second wife had children: Otha Hill 5/; Lindsey Hill 5/; John F. Hill 5/; Dempsey Hill 5/; William Hill 5/; Jane Hill 5/; Tabitha Hill 5/; and Ellen Hill 5/, who married Augustus Dillon in 1844. (The first wife of Augustus was the daughter of Benjamin Hill 5/ son of Robert Hill 4/ and wife

Eleanor Hyfield).

There was also an Elizabeth Hill, born 8th February 1793 and was probably the oldest of the children of Robert Hill 4/ and wife Sophia. Elizabeth Hill 5/ married Calip Tarleton on 16th March 1812.

Joseph Hill SR 3/ died in Mason Co., Ky ca. 1799. On the 23 Ocyober 1778, Joseph Hill 3/ purchased Maryland land (30 acres) from son, Henry Hill 4/.

Upon the sale of "Mountain Glade" Henry Hill 4/ and his wife Alice Ridgley had moved to Newberry County, South Carolina.

Frederick County Deed Book W.R. 10: 465-6 dated 27th September 1791, Henry and Alice Hill of Newberry County, South Carolina signed a quit claim deed, selling their shares in the estate of Westal Ridgley to Richard Ridgley. Westal Ridgley was the father of Alice Ridgley Hill (wife of Henry Hill 4/) and Richard Ridgley was her brother.

Joseph Hill Jr. 4/, b. early 1750's. m. Margaret Rowe, remaines in vicinity of Frederick Co., Md.
