RICHLAND SOUTHERN RIGHTS ASSOCIATION.

Columbia, March 22nd. In pursuance of notice given in the papers of the town, a special meeting of this Association was held this day, at the Town Hall. In accordance of the President, Col. C. Goodwyn, Vice President, took the chair and proceeded to explain the object of the meeting, viz: to take into consideration the proposition of the Orangeburg Association, to hold a convention of the Association of the State, and to to consider the propriety of appointing delegates therto.

Col. Maxey Gregg, in the absence of the President of the Council of Safety, submitted the following report from that body which is constitutionally appointed to prepare business for the Association:

Report of the Council of Safety--Several of the Southern Rights Associations of the State have adopted the proposition to hold a meeting of delegates in May next, for the purposes of consultation. Both Charleston and Columbia have been mentioned for the place of meeting. It appears proper to respond to the proposition: and it may be becoming in this Association to remove any occasion of disagreement as to the place for giving its suffrage to Charleston, which seems to have received the most voices.

No principal having been proposed for regulating the number of delegates, and the purposes of the meeting being for consultation, the council would recommend the appointment of a large representation. In suggesting the names of gentlemen to compose it, they have been governed by the following considerations: It seems desirable that the proposed meeting should have the benefit of the counsels of our delegation in Congress whose position has enabled them to observe most closely the progress of affairs at Washington. The council have therefore suggested the names of our two Senators and our immediate Representative, who they hope would consent to attend upon our invitation. They have thought it proper also that our members of the Convention and of the Legislature should take part in a consultation on matters of public policy, and they have endeavored to complete the list in an acceptable manner by a large selection of citizens from all parts of the district.

Regarding also as desirable at this time an expression of the sentiments of this Association on some of the grave questions of public policy before us, they recommended the adoption of the following resolutions:

Resolved, As the opinion of this Association, that concert of action between two or more of the Southern States, through the proposed Southern Congress or otherwise, for the purpose of resisting the aggressions of the Federal Government and the Northern States, is an object in the highest degree to be desired, and most earnestly to be sought: but that if such concert of action cannot be brought about the State of South Carolina, acting through the Convention of the people, which has been provided for by law, ought to secede alone.

Resolved, That every preparation ought to be made to maintain by arms the right of secession and the independence of the State.

Resolved, That this Association accepts the proposition for a meeting of delegates from the District Association to be held in Charleston on the first Monday in May next; and that the following gentlemen be requested to attend as delegates from this Association:

The report, after some friendly discussion, was unanimously adopted.

On motion of Mr. DeSaussure, the Chairman of this meeting was authorized to fill any vacancy that might occur in the delegation just elected. After which the meeting adjourned.

(Note: Charley Neuffer was Nathan's deputy and was elected to the position of Sheriff on 5th May 1851).

(MY NOTE: The significance of this is that it is the proof that Nathan Hill resigned before his 4 year term as Sheriff was up (in 1852). This resignation was confirmed in the obituary published at his death in the Charleston Courier in 1854, and found later on in this data.
