- 1. (F) Emma Cornelia Hill, born 14th February 1868 Sandy Run, Lexington County, S.C., married ca. 1887-1888 to John Victor Bates, she died on 28th September 1940 in the town of North, (Orangeburg Co.,)S.C. Buried Bull Swamp Chapel, near twon of North, S.C. (Orangeburg County).
- 2. (F) Sally Elizabeth Hill, born 18th February 1869 Sandy Run, Lexington County, S.C., she was christened (baptized) on 15th August 1875, with her two older brothers in the Sandy Run Lutheran Church, she married ca. 1898 Ansol Price Dannelly, they moved to Statesboro, Georgia, she died there ca. 1918.
- 3. (M) Nathaniel Barrett Hill (Barrett), born 8th October 1871 at Sandy Run, Lexington County, S.C., he married ?? Mary Elizabeth Geiger, he was killed in a logging accident on 1st April 1927 and died in Columbia Hospital. He is buried in Elmwood Cemetery, Columbia, S.C.
- 4. (M) PETER JOSEPH HILL (Pete) MY GRANDFATHER, born 31st October 1874 in Sandy Run, Lexington County, S.C., married Mary Jane Rickenbaker of Lexington County, S.C. on 28th December 1900, he died of pneumonia in December of 1906. He is buried in Congree Baptist Churchyard in Calhoun County, S.C., near St. Matthews.
- 5. (M) James Franklin Hill, born 13th January 1878 at Sandy Run, Lexington County, S.C., married 13th January 1903 to Essie Isota Furtick, he died 21st March 1950, buried Rucker Cemetery (Oak Grove Methodist Churchyard) at Sandy

Run, S.C.

- 6. (M) William Woodward Hill, born 14th May 1880 Sandy Run, Lexington County, S.C., married on 13th January 1903 to Rosa Belle Meetze, died on 14th March 1974, buried in Elmwood Cemetery, Columbia, S.C. He ran a hardware store in Columbia. Buried in Elmwood Cemetery, Columbia, S.C.
- 7. (F) Susan Hill (Sooney), born 15th April 1883 Sandy Run, Lexington County, S.C., married Charles Saylor, died on 16th March 1947 in Columbia Hospital. She is buried in Rucker Cemetery (Oak Grove Methodist Churchyard), Sandy Run, Calhoun County, S.C.
- 8. (F) Beulah Lee Hill, born 19th January 1886 in Sandy Run, Lexington County, S.C., married on 25th December 1907 in Columbia, S.C. to Edward K. McQuatters, they moved 1st to Lakeland, Florida, then to Hampton, Virginia. She died in Hampton, Virginia on 13th August 1970 and buried there.
- 9. (M) Michael (Mike) Hill, born 1st October 1889 in Sandy Run, Lexington County, S.C., never married. He died on 15th January 1969, buried in Rucker Cemetery, (today Oak Grove Methodist Churchyard) at Sandy Run, S.C.

NOTES: Information on 2 Death Certificates, concerning Woodward Hill is wrong. The first one is on the death certificate of his daughter, Emma. Someone stated that Woodward was born in NY. THAT IS WRONG! What happened was that he and his parents went to New York in 1854, but his father Nathan died there suddenly and they returned to South Carolina, with Nathan's body. They must have thought the family was from NY but all census data, family records state he was born in S.C. (Columbia).

The second error is on the death certificate of Woodward Hill...His mother was listed as "Lula Smith." Now Lula was probably a nickname but SMITH IS WRONG! HER NAME WAS STEWART, and the old Sgt Jones, who gave the data, just got mixed up.

Woodward Hill was injured in the temple and his arm was badly burned and mangled in the Civil War. The injuried were received in the skirmish at Pocotaligo, S.C. on 22 October 1862 (service records).

Information from census indicates that there were 11 children, but two of them must have died as infants as no one knows of their names. Two infant graves (no names) in Rucker Cemetery may have been these two unknown children.

Woodward D. Hill remarried a 2nd time to a widow Kimbal, he out lived her, no children. She & her husband knew the Hills before Sally Rucker died, and were friends.
