Regarding the burial of Nathan Hill:

His remains were sent back to Charleston by a steamer and his family returned on a boat just ahead of him. Nathan Hill claimed Columbia as his home and the family lived there long after his death, so it is felt he was buried in Columbia. probably in an unmarked grave in Elmwood Cemetery.

Children:

- 1. Woodward D. Hill 4/, Writer's great grandfather, (CSA Veteran), born 10th September 1837 in Columbia, S.C.; married 1st in 1866 to Sally Elizabeth Rucker; 2nd to a widow Kimbel; he died in Columbia in the Old Soldier's Home on the 27th of November 1919. He & 1st wife buried at Oak Grove Methodist Churchyard at Sandy Run, Calhoun Co., S.C.
- 2. William Stewart Hill 4/, (CSA Veteran), born 1839 in Columbia, S.C.; married Susan Jane Mobley McCrory, he died ca. 1885-1886 in Columbia.
- 3. Eliza M. Hill 4/, born 1st June 1840 in Columbia, S.C.; married in 1857 to Henry C. Nunnamaker, she died in Columbia Hospital on 19th April 1923, buried in Columbia

- in Lutheran Churchyard (unmarked grave).
- 4. John Hill 4/, (CSA Veteran), born 1844 in Columbia, S.C., never married, he died in Army Hospital in Richmond, Va. from wounds received at Petersburg, Va. on 29th June 1864.
- 5. Lawrence (Lonnie) Hill 4/, (CSA Veteran, a drummer boy), born 13th December 1848 in Columbia, S.C., became a deputy sheriff in Union County but the moved to Noxubee County, Mississippi. There he married 1st a cousin.

 Martha Louise Glenn; 2nd to Ada---?, he died in Noxubee County, Mississippi ca. 1913-1914.

Note:

All four brothers were members of the 7th S.C. Volunteers, Infantry, Company, "C."

Woodward Hill lost an eye in the war and his left arm was badly mangled. He was medically discharged as a Sergeant but was later taken back into service as a Lieutenant. He taught school after the war in Sandy Run, S.C.

William Stewart Hill was a prisoner of war for about three years. He returned home ok after the war.

John Hill died at Richmond, Va. due to wounds he had received at the battle of Petersburg.

Lawrence Hill went first to Union County as a Deputy Sheriff, moved to Noxubee County, Mississippi where he later died.
