

NC.008 MISC. INFORMATION ON HILL FAMILIES OF N.C. AND
WHO'S SOURCE IS TAKEN FROM SEVERAL DIFFERENT
PERSONS, BOOKS ETC...

Gathered, Entered & Partly Compiled by Robert R. Hill Sr. in
February 1987.

There is a record of a Moses Hill (born ca. 1680 probably in
Nansemond County Virginia) moved from Nansemond County
Virginia into Chowan County N.C. ca. 1717 with wife Dorothy.
He left a will in Chowan County in 1745 naming sons:

- i. Moses Jr. b. 1705/12 d. 1762-63, of Bertie County
N.C. left no sons.
- ii. Guy Hill, b. 1710-17 d. 1775 of Chowan CO. Sons:
 - a. Kadar Hill d. 1790 Gates Co.
 - b. Guy Hill Jr. d. 1787 Gates Co.
 - c. John Hill d. 1776 unmarried.
- iii. Isaac Hill b. after 1716. Sold land and left Bertie
County in 1754.
- iv. Abraham Hill, b. after 1716, died Gates Co., N.C. in
1786. Sons:
 - a. Moses Hill d. 1797 Gates Co., N.C. no sons.
 - b. Aaron Hill
 - c. Henry Hill
 - d. Mills Hill

William Hill, probably a brother of the above Moses Hill,
married Mary Spivey and died in Chowan County N.C. ca.
1750/51. Sons:

NOTE: Based on information from Hinshaw's Quaker Records,
William Hill was son of Samuel Hill, a Quaker, who immigrated
to Virginia then Perquimans Co., N.C. If he was a brother of
Moses Hill, then Samuel Hill was naturally the father to
Moses Hill. It is known that a Sheriff John Hill (unrelated),
of Lower Norfolk County, Va. persecuted the Quakers & since
Nansemond County, Virginia is adjacent to Norfolk County, it
is wondered if Samuel Hill, along with son William (and
possibly Moses) lived in the area of Nansemond-Norfolk
County, Virginia before moving to Perquimans County, N.C. in
order to get away from the persecution that was being waged
by the above Sheriff John Hill? (No evidence has been shown
to prove this theory)

NOTE BY ROBERT HILL: I am of the opinion that the two above
(Moses & William) are connected to a Maryland family, who's
given names of Moses, Aaron were often used. Quaker records
Prove that Aaron Hill of Pasquotank County, N.C. went to
Prince George County, Maryland and married Margaret Chapell &
returned to N.C. Margaret died in N.C. and Aaron remarried to
Miriam Overman.

The given names of Moses and Aaron in this line is
used frequently, thus a connection to the above two men
(Moses & William) appears likely, probably father & son or
brothers.

Excellency the Governor was pleased to allow and approve of

(Another Hill Family Genealogy)

(NOTE by Robert Hill: Some sources have stated that the
following Henry Hill (of Chowan County, N.C.) was the son of
(Thomas Hill Jr. 4/, son of (Thomas 3/, Robert 2/, John Sr.
1/). These Hills lived in the vicinity of Isle of Wight
County Virginia. Now it is true that Thomas Hill Jr. 4/ son
of Thomas 3/, Robert 2/, John Hill 1/) had a son Henry Hill

5/, who in 1763, married his cousin, Mary Hill 5/, daughter of Joseph Hill 4/, son of (Thomas 3/, Robert 2/, John Hill 1/), but at the time of his marriage, this Henry Hill 5/, (son of Thomas 4) was living in Granville County N.C.

Following from "Colonial Granville County (N.C.) & It's People," by Worth S. Ray (Page 216).

Edward Jones.

The first court ever held in Granville County was at his home in the lower part of what is now WARREN COUNTY (N.C.), as has been mentioned before in some of these notes (see pp 43 and 209). His will was proved in 1750 and that of his son EDGAR JONES in 1761.

Note by Robert Hill: There was a Edward Jones Jr. that married Mary Hill 5/, daughter of Thomas Hill 4 & Sarah Etheridge of Halifax Co., NC.. but he lived longer than the two dates above.

At the time these wills were filed neither the extinct county of BUTE, nor what is now WARREN COUNTY had been established, so they were necessarily recorded in GRANVILLE COUNTY. Had they died after 1764 the records would appear among the records of BUTE later filed in WARREN COUNTY. The wife of EDWARD JONES was Abigail Sugre, a member of a HUGUENOT family, from MANIKINTOWN, from which CAPT. SUGAR JONES obtained his Christian name. EDWARD JONES was the son of another EDWARD JONES whose will was proved in RICHMOND COUNTY, VIRGINIA, September 2, 1715, in which he named four sons and one daughter, SANFORD, JOHN, EDWARD, CHARLES and ALICIA JONES, the wife of a PAYNE (either the JAMES PAYNE who was present at the first court of Granville County, NC in 1746, or a son of that PAYNE who married ALICIA JONES, sister of Edward). SANFORD PAYNE, the older brother of EDWARD of GRANVILLE, died in RICHMOND COUNTY, VIRGINIA, in 1717, and in his will names his "cousin" ANNE PAYNE. EDWARD JONES (son of EDWARD of GRANVILLE County) married MARY HILL, a sister of GREEN HILL (b. 1714, the son of HENRY APPLEWHITE HILL**) who married GRACE BENNETT (daughter of WILLIAM BENNETT of Northampton County, N.C. and Virginia), and WILLIAM HILL (son of GREEN HILL) married MARY JONES, daughter of EDWARD JONES and MARY HILL. SAMUEL JONES, (brother) of MARY JONES and the son of the younger EDWARD, married ELIZABETH SHORT GOODLOW and had a daughter SARAH APPLEWHITE JONES, who married a nephew of GENERAL JAMES ROBERTSON of Nashville, Tennessee (James Cockrill). Hon. Jo. SEAWELL JONES (of WARREN COUNTY)-the old EDWARD JONES estate, was a grandson of JOSEPH SEAWELL (whose namesake he was also) and his mother was a MRS. GORDON (she having married a second time) a sister of JUNE HENRY SEAWELL, her mother being a sister of HON. NATHANIEL MACON, son of GIDEON MACON and his wife PRISCILLA JONES (who married second time JAMES RANSOM-see marriages). In 1834 JOSEPH

SEAWELL JONES was a student at the University of North Carolina, later of HARVARD, and was affectionately known as "SNOCCO JONES." He was an eccentric, but served in the UNITED STATES CONGRESS for a long term of years and was one of the founders of the NORTH CAROLINA HISTORICAL SOCIETY.

**NOTE: Boddie states the father of Green Hill (b. 1714) was Richard Hill 3/ and his mother was Hannah Briggs. Others named as the father of Green Hill 4/ are Sion Hill Jr 3/, his brother Robert Hill 3/ and others....Considerable doubt exists to the above Henry Applewhite Hill being the father of Green Hill. Also it appears that Green Hill 4/ had a sister Mary Hill who married William Malone, not Edward Jones Jr. The above marriage of Edward Jpnes to Mary Hill seems to have been to Mary Hill 5/, dau. of Thomas Hill 4/ & Sarah Etheridge of Halifax Co., NC.

In a book entitled "East Goes West," Sion Hill Jr. 3/ is listed as the father of Green Hill 4/ and it was pointed out by one of the researchers of this book that was a disputed claim.

The Henry Hill listed below moved into Chowan County N.C. from Nansemond County Virginia. Therefore I do not believe this to be the Henry Hill 5/ that was connected to the Thomas Hill Jr. 4/ (Thomas 3/ Robert 2/ & John Hill 1/, of Isle of Wight County Virginia. I personally feel that the Henry Hill below was part of a Hill Family that migrated down from Maryland, via way of Nansemond County Virginia).

HENRY HILL 1/, OF NANSEMOND COUNTY VIRGINIA (BORN 1670 AND DIED 18TH APRIL 1720) AND HIS WIFE MARY, MOVED FROM NANSEMOND COUNTY VIRGINIA INTO CHOWAN COUNTY N.C. (NOW GATES CO.) IN 1700.

Among their children (names unknown) was a son: Abraham Hill 2/.

Note: Daughter Sarah was not named in her father's will but her daughter was (Leah Hunter) so apparently Sarah was dead when will probated. (Will Dated 7 April 1760 in Chowan Co., N.C.).

Some genealogical sources state that Henry Hill 1/ and wife Mary (father and mother of above Abraham Hill 2/) moved from Nansemond County Virginia into Chowan County N.C. (now Gates County) in 1700.

Have some strong evidence from Quaker records that this Family has ties with Maryland Hills, due to the known fact that a Aaron Hill of Maryland, moved to N.C., returned to Md. and remarried, then brought his 2nd wife to N.C. (vicinity of Pasquotank County N.C.).

WILLIAM HILL (Revolutionary Soldier) was born (1700?) 1710, married Susannah Smithers in 1736, and died in 1787 in Surry County, N.C. His will was dated in 1777, probated in 1787. (NOTE by Robert Hill...Note the name Susannah Smithers and then note data relating to William Hickman Hill that is mentioned in book "Colonial Granville County & Its People" on page 196 by Worth S. Ray and discussed in DATA NC.16 and DATA NC.18 on this same computer disk.

New data found in 1989 shows Susannah's mother's maiden was Susannah Singleton & daughter of Robert and Elizabeth Singleton of Gloucester County, Virginia. She was married 1st Thomas Smithers and their dau. (Susannah) married William Hill Sr. of Caroline Co., Va..

Joseph Montford). Legatee: Margaret Cochran, gives land to grandson Benjamin McCulloch.

GEORGE HILL, in 1722 ????

ISAAC HILL, Chowan County, 3rd March 1710: sons Michael, Isaac, John & Nathaniel. Daughter Martha. Executor Robert West.

ROBERT HILL, Tyrrell County, 16th January 1735-36, (probated in February Term 1735-36) names son Robert Jr., wife Ann, daughter Sarah Hill. Executor Robert West (note this is same man as executor of above Isaac Hill).

REVOLUTIONARY WAR PENSIONS FOR HILLS OF N.C. BUT FILED IN THE STATE OF GEORGIA.

W-3812 ISAAC HILL, born 10th February 1761 in Chowan County N.C., was brought by his father to Wake County N.C. at age 6 (1767) where he lived and volunteered for service in 1780/81. After the Revolutionary War he moved and resided in Wilkes County, Georgia for about 6 or 8 years then moved to Clark County, Georgia, where he died on 15th August 1833. He

married in Wilkes County, Georgia in March of 1784 to NANCY CRANE, who was living in Clark County, Georgia on 14th October 1844. This information taken from his Pension Application.

He may be father of Isaac W. Hill 4/ of Clarke Co., Ga. This Isaac Hill 3/, appears to be the son of Abraham Hill 2/ (questionable), son of Henry Hill 1/.)

R-5001 ISAAC HILL, served in the Revolution from N.C. and died in Habersham County, Georgia on 20th October 1844. He was married 1st to Anna Harrison in Johnston County, N.C. and who died during the Revolution. His 2nd marriage was to Elizabeth Sing on 17th September 1857???? Amos Hill of Habersham County (Aged 84) was their only surviving child.

NOTE: Reference Isaac Hill (R-5001) The date of his 2nd marriage (1857) is obviously wrong as he died in 1844. I suspect he is somehow related to Moses Hill Sr.

A ISAAC HILL, died 1710, in Chowan County, N.C.

HILL MARRIAGES IN VIRGINIA -NORTH CAROLINA

NOTE: Quite often the families were originally in Virginia and later moved into N.C. so for that reason, the marriages of both states are listed here.

SOURCE OF NO.1: "THE HILL FAMILY" BY AMERICAN GENEALOGICAL RESEARCH INSTITUTE (1975).

1. ELIZABETH HILL married Thomas Thompson in 1682 in Middlesex County, Virginia.

2. AARON HILL, married Margaret Chepell in Henrico County, Virginia, (Va. Henrico County Monthly Meeting Quaker Records) shows Aaron Hill of Perquimans N.C. married Margaret Chepel, of Prince George County Maryland. Did the marriage take place in Henrico County Virginia???? Mr. Meadors did not give a date but is believed to be about 1735-36, based on birth of 1st child Huldah. The children of Aaron & Margaret were Huldah Hill, born 18th September 1737 and William Hill, born 31st January 1740. Margaret (wife of Aaron) died, and Aaron remarried Miriam Hill (must have been a cousin). Their children were: Mary Hill, b. 1746, MOSES HILL, b. 16th September 1748, died 22nd November 1760, Aaron Hill, b. 1752, Miriam Hill, b. 1754, Jacob Hill. b. 1756, Jesse Hill, b. 1758, and Thomas Hill, b. 1760. It appears that Aaron Hill might be originally from Maryland. This family lived in area of PERQUIMANS, CHOWAN AND PASQUOTANK COUNTIES IN N.C.

Later Research shows he was a Quaker, connected to a Samuel Hill, who immigrated into Virginia from England, but still think they are related to the Hill (Quakers) Family of Maryland.

(NOTE BY ROBERT HILL.....I suspect that the above Aaron Hill is a brother of a Moses Hill, who died in Maryland in 1763 and left a will there. This Moses seems to have had no children but his brothers were THOMAS HILL, JAMES HILL, AARON HILL, and SAMUEL HILL. I suggest the above Aaron Hill is the brother, and the names suggest not only a connection to the Maryland Hill Family line but also to the Sir John Hill Family of New England). Later research shows this not to be true.

3. Elizabeth Hill, daughter of Leonard Hill of King William County Virginia, married George Seaton in 1734. Reference VOLUME 25 Virginia MARRIAGES, page 432.
4. Leonard Hill married Sarah Thacker of Middlesex County Virginia on 4 October 1752. VOLUME? 1 Virginia page 119 The figure after names tells what generation he belongs.
5. Robert Hill 1/, who immigrated into Isle of Wight County ca. 1642, married Mary Webb. He is the Patriarch of the large Hill Family often referred to as the "SURRY COUNTY HILLS" of Virginia. Had several children but only two known by name, Sion Hill 2/ & Robert Hill Jr. 2/. (Ref. Family Charts I made from Book " Southside Virginia Families," Vol. 2, by Boddie).
6. Sion Hill 2/, (1654-1705) of Virginia and son of above

Robert Hill 1/, married widow Elizabeth (Smith) Spiltimber, widow of John Spiltimber (Ref. same as above).

7. Robert Hill 3/, (1678-1765) born in Surry Co., Va. and went by the name of Robert Hill Jr. to separate himself from his uncle Robert Hill 2. Hill 5/ dated 1803 in Halifax County N.C., and mentions following children: Martha Hill 6/, James Hill 6/ and Henry Hill 6/, all three in Williamson Co., Tenn in 1812. (Ref. same as above).
11. Sion Hill Jr. 3/, (1682- 17--) son of Sion Hill 2/ and Elizabeth Spiktimber, m. ca. 1707 Elizabeth Marriott. Daughter of Mathias Marriott. (Ref. PROOF OF CHILDREN SHOWS A GREEN HILL AND A ABNER HILL. THERE MAY HAVE BEEN A SION HILL WHO DIED IN WAKE CO., NC. (ref;same as above). (Very Questionable Data, especially name of wife).

12. Richard Hill 3/, (1684-1723), son of Sion Hill 2/, married Hannah Briggs ca. 1713. She was the daughter of Henry Briggs. Note by Robert Hill: Reference to above Clark County, Kentucky Info... In Volume 5, page 339 of "The Abridged Compendium of American Genealogy" located in Columbia S.C. at the South Carolinian Library it states:

A Horace Buckner Hill, a banker of Louisville, was the son of Leonard Hill and Elizabeth Hill. Horace Hill married Susan Talbot Oldham. (Leonard Hill of Fairfield Co., S.C. was in S.C prior to 1785, had a wife Elizabeth. They moved to Clark Co., Ky in 1788, but no son Leonard named in his 1825 will).

Now there was a Leonard Hill with a wife Elizabeth in Fairfield District South Carolina, prior to 1788. He fought in the American Revolution in S.C. and later this Leonard Hill moved to Kentucky (Fayette County, later Clark County) and was in the Kentucky 1790 Census of Clark County. He sold his S.C. land (82 acres) in 1788 to a Thomas Hill and wife Judith. Both Leonard & his wife Elizabeth Hill signed the Bill of Sale, dated 26th May 1788. It is believed that Leonard was a brother of Moses Hill, also of Fairfield District S.C. and either a brother or the father of the Thomas Hill, who bought his S.C. land. (This has not yet been proven).

The Thomas Hill, with wife Judith, later purchased land in Fairfield County S.C., that was originally granted to a Charles Hill, who left the land to his son William Augusta Hill, who then left it to his son Richard Hill (wife Agnes), who sold it to a Jane Rogers, a spinster. Jane Rogers then sold it to a Shadrick Knowland. Knowland in turn sold it to Thomas Hill (wife Judith). One wonders if these Hills are somehow related?

3. Sarah Hill, dau. of Captain William Hill of Salisbury District N.C., married Nathan Ewing.
4. Polly Hill, dau. of Captain William Hill of Salisbury District N.C. married Henry Bateman.
5. Milly Hill, dau. of above William Hill of Salisbury District married a Burroughs.
6. Nancy Hill, born 1785 and daughter of Captain William Hill of Salisbury District N.C. married John Creecy.
7. William Hickman Hill, b. 1788 d. 1853, son of Captain William Hill of Salisbury District N.C., married Sallie Brown. (See information in DATA NC.16 and DATA NC.18 relating to this family). It is obvious that he is related somehow to the William Hill Sr. who married Susannah Smithers as his sister was named Susannah Smithers Hill. His death listed above as 1853 does not agree with the death date of 1867 as stated by Worth S. Ray in his book "Colonial Granville County & Its People" on page 196. Also Ray states

that William Hickman Hill died in Texas in 1867 and was the son named in the Anson County N.C. will (dated 1826) of DANIEL HILL (wife Martha Hickman).

I am of the opinion that there were two different men having the name of William Hickman Hill (probably cousins), with one dying in 1853 (son of Capt. William Hill) and the other having died in 1867 and was son of Daniel Hill. Also note that Lucinda Hill (#8 below and Elizabeth Hill (# 9) below are listed as children of Captain William Hill and not Daniel Hill. One source of data is obviously wrong.

8. Lucinda Hill, b. 1796, daughter of Captain William Hill of Salisbury District N.C., married William Garner.

9. Elizabeth Hill, b. 1796 daughter of Captain William Hill (above), (twin?) d. 1848, married Henry C. Ewing.

10. General William I. Hill, son Thomas Hill and Frances Smith of Brunswick Co., Va., married Ann Dudley

11. Michael Hill, son of Nathaniel Hill & Elizabeth Hardy, married Elizabeth Collins.

(Note: In book "COLONIAL GRANVILLE COUNTY & ITS PEOPLE" by Worth S. Ray, on page 196, he states that William Hickman Hill (# 7 above) was a son of Daniel Hill and wife Martha Hickman. It states that Daniel Hill left a will in Anson County N.C. in 1826, naming children as Sarah Hill, Mary Hill, Nancy Hill, WILLIAM HICKMAN HILL, Green Hill, Mildred Hill, Lucinda Hill (# 8 above) Elizabeth Hill (# 7 above), and Susanna Smithers Hill. William Hickman Hill died in Texas in 1867, where he left numerous descendents, and Elizabeth Hill married Henry Ewing of Nashville, Tenn. He goes on and list Lucinda Hill (# 8), Elizabeth Hill (#9) as daughters of Daniel Hill). Also see computer page 8 of this document that relates to Susannah Smithers etc...

1. Thomas Hill (son of John) married Mary Marshall, who was a daughter of Humphrey Marshall. Another source says father was Robert Hill, son of John Hill Sr.).

2. Joseph Hill, son of Thomas Hill & Mary Marshall, married Frances Woodley (daughter of John Woodley, and granddaughter of immigrant Andrew Woodley. (Woodlee).

3. Ann Marshall, another daughter of Humphrey Marshall married Henry Applewhaite. [One source thinks this was Henry Applewhaite Hill but believe Applewhaite is the last name of husband and not Hill]. Perhaps they had a son named Henry

Applewhaite Hill??? Ann was the sister of Mary Marshall, who married Thomas Hill.

4. Mary Hill, daughter of Joseph Hill & Francis Woodley, (#2) married her cousin Henry Hill, who apparently was the son of her uncle Thomas Hill (Jr.) the son of Thomas Hill (Sr.) & Mary Marshall (listed as # 1).

Joseph Hill was son of Thomas Hill Sr.(son of John Hill Sr.) & his wife Mary Marshall, daughter of Humphrey Marshall.

4. JAMES HILL, son of Number 3, married 21 December 1787 to Sally Graves.

5. JOHN HILL (son of Number 3) married ??? had following children: Sallie Hill m. Alexander Rine; Mildred Hill m. Baylor Walker; & Robert Hill who m. a widow Waller and moved to Alabama in 1837.

6. NATHANIEL HILL (son of Number 3) married Elizabeth Clopton.

7. WILLIAM HILL (son of Number 3) married Catherine

Claiborne.

8. OCTIVIA HILL, daughter of Captain William Hill (Number 7) married Doctor John S. Lewis. Issue: Josephine m. Lt. J.C. Baytop, of Gloucester County; Lavinia m. Doctor C.T. Whiting of Norfolk Virginia; Nora m. F.M. Elphinston, of Newark, New Jersey; Doctor J. Rowland m. Nannie Robinson and Herbert Iverson m. Mattie Parke.

9. ROBERT HILL (son of James Hill Number 3). Robert died in 1844. Was married to Harriet Herbert Claiborne, sister of Judith Brown Claiborne, who married his brother Captain William Hill (number 7). His children were: William (see No. 10); Robert (see No. 11); Mary B.; Mildred; & 5 other, all deceased and unknown.

10. WILLIAM HILL (son of Robert Hill Number 9) married Elizabeth Johnson, daughter of Colonel William Christopher Johnson. Their children were: Clairborne Johnson Hill; Robert Christopher Hill; & James Hill.

11. CLAIBORNE JOHNSON HILL (son of William Hill, Number 7) Major in Confederate Army. Married Susan Ann DeFarges, daughter of John Farges and Adline Neale.

12. ROBERT CHRISTOPHER HILL (son of William Hill, Number 7) married Cornelia Todd Littlepage, daughter of Colonel Hardin Littlepage and Susan Pemberton Robins, granddaughter of Hardin Littlepage and Eliza Suterland Quarles. (See Edwards' Genealogy).

13. JAMES BEVERLY HILL (son of William Hill, Number 7) married Lillian Ochiltree, of Texas. No children. Died 1890.

14. ROBERT HILL (JR) and the son of Robert Hill Number 9... Robert Jr. died 1886. Married Martha Johnson, daughter of Colonel William Christopher Johnson. Issue: Major Augustus Beverly Hill, Juliette, Harriet m. James A. White; Elmira m. T.B. Waring; Lelia m. John Bowers of Richmond, Virginia; and Johnson, who died young.
