

NC.022 ABSTRACTED INFORMATION FROM "N.C. WILLS AND ABSTRACTS," BY GRIMES.

Entered in March of 1991 and updated in July of 1992 by Robert R. Hill of Brandon, Fla.

Source of Information: The book "N.C. Wills & Abstracts," by Grimes.

Page (not legible) Will of Thomas Spivey, Chowan Precinct, dated 23rd December 1729, proved 5th February 1729-30, Son in Law William Hill (90 acres of land), daughter Ma-- (Mary?) Hill, Grandchildren: Mary, Susannah & Sarah Hill.

Page 13, Benjamin Hill, was a witness of the will of William Badham, Chowan Precinct, 28th October 1736, proved 3rd November 1736.r

Page 14, Hannah Hille's (Hill's?) name appears in the will of Richard Baird (no county given) also no date given but probably Chowan Co.

Page 15, William Hill witnessed will of Moses Baker, Chowan Co., Dated 26th January 1723, proved in January Court 1724.

Page 33, Will. (William?) Hill witnessed the will of Benjamin Blanchard, upper Nansemond Co., Va. dated 5th June 1719, no probate date given.

Page 37, Will of William Boge, Perquimans Precinct, dated 20th December 1720, proved 11th April 1721, mentions daughter Elizabeth Hill, grandson William Hill, and Son in Law Jacob Hill. (Note: It appears that Elizabeth Boge, daughter of William Boge, married Jacob Hill & they had a son named William Hill).

Page 50, Isaac Hill, witness will of Francis Brown, Bertie Co., dated 7th November 1748, proved in May Court 1750.

Page 77, Moses Hill, witnessed will of John Collins, Bertie Co., dated 27th December 1749, proved 18th March 1752.

Page 118, Thomas Hill, witnessed will of Richard Farr, Onslow Co., dated 8th November 1757, proved in July Court 1758.

Page 130, Adam Hill, (was) a legatee "of Glasgow (Glasgow?), in the Kingdom of Scotland," in the will of Adam Gambell (no place shown) Will dated 14th November 1694, proved November 1694. (Adam Hill of England is said by some sources to be the father of Isaac Hill who d. in 1710).

Page 143, William Hill, witnessed will of James Griffin on Katherine Creek in Chowan Co., dated 13th June 1748, proved April Court 1749.

Page 144, Elizabeth Hill, witnessed the will of Richard Grist, Beaufort Co., dated 6th June 1752, proved 13th March 1753.

Page 147, Benjamin Hill, was a legatee in the will of Robert Halton, New Hanover Co., Will dated 22nd March 1748, proved April Court 1749.

Page 154, Green Hill, was the executor of the estate of Mary Hart, Northampton Co., Will dated 12th July 1750, proved 7th May 1743. (dates must be reversed). GREEN HILL MAY BE A SON OF HARMON HILL & MARTHA DELOACH OF NORTHAMPTON CO., NC.

Page 161, Will of Francis Hendrick, Craven Co., dated 11th September 1734, proved 17th December 1734, son in law John Hill, Executor.

Page 164, Benjamin Hill, Bertie Co., Will dated 20th June 1872? (1772?), proved August Court 1753. Son & Executor: Henry ("all my lands.") daughters: Margaret Campbell & Sarah McCulloch ("acres on Roanoke River"), Priscilla Hill. Other legatee: Margaret Cockran. Executor, Thomas Jones of Petty Shore. Witnesses: Jesse Brown, Robert Hardy, & John Pitt. Codicil dated 6th June 1753 gives land in Cashia Neck to grandson Benjamin McCulloch. Same Witnesses to the codicil. Clerk of Court: Samuel Ermes.

Page 164, George Hill, Bath Co., Will dated 17th April 1722, proved 30th March 1723. Sons: John, George, & Harmon Hill. Wife & Executrix: Mary. Daughter: Rachel Hill. Executors: John & George Hill. Witnesses: Thomas Goodin, John Leath & John Proctor. Clerk of Court: John Cornick.

Page 164, Harmon Hill, Beaufort Co., Will dated 4th December 1752, proved in May Court 1753??, Sons: Harmon ("land on Callum's Creek," James & William Hill. Daughters: Elizabeth Hanchck, Sarah Rice, & Ann Slade (land on Pamlico River), Mary Smith & Rachel Hill. Executors: Wife Sarah Hill, Joseph Slade & John Barrow. Witnesses: Edmund Pearce, Joshua Pearce, & Griffith Howell. Clerk of Court: Waller Chsuncey.

Page 164, Isaac Hill, Chowan Precinct, Will dated 3rd March 1710, Sons: John, Isaac & Nathaniel Hill, daughter: Martha. Executor: Robert West. Witnesses: William Maule, Edward Bryan & John Hale. Original missing. Recorded in Book 1712-1722, Page 34. (Isaac is said by some to be the son of Adam Hill of Scotland).

Page 165, Moses Hill, Chowan Co., Will illegible.

Page 165, John Hill, Bath Co., Will dated 27 March 1731, proved September Court 1731. Sons: Joshua & John Hill. Friend: Thomas Tison. Executors: Wife (not named) & Edmund Pears. Witnesses: Thomas Tison, Harmon Hill & William Nichols. Clerk of Court, Frederick Goolde.

Page 165, John Hill, Northampton Co., Will dated 15th June 1747, proved August Court 1747. Sons: Nathaniel ("plantation he now lives on") Daniel (Plantation I now live on"), Lewis ("remainder part of my land") & Peter. Executors: Daniel & Nathaniel Hill (Sons). Witnesses: William Addison, William Floaryday & Hosea Tapley. Clerk of Court: Rt.? Forster.

Page 165, Richard Hill, (Craven County?) Will dated 17th February 1728-29, Proved 18th March 1729, Grand-daughter Elizabeth Hill. Executor: Francis Hill (brother). Daughter Ann Jones, Son in Law Evan Jones, Witnesses: James Taylor, Thomas Jones, John Lewis & John Cuming. Clerk of Court: Caleb Metcalfe. (Research in 1993 shows this Richard Hill was born in Accomac County, Va. and was a son of a Henry Hill of same county).

Page 165, Robert Hill, Tyrrell Co., Will dated 16th January 1735-36, proved 4th February 1735-36. Son: Robert ("my plantation"). Wife Ann. Daughter: Sarah Hill. Executors: Cullen Pollock & Robert West. Witnesses: Samuel Durrance, Nathaniel Carruthers & Paul Thorpe. Proven before W. Smith, C.J.

Page 165, William Hill, Northampton Co., Will Dated 3rd September 1748, proved in November Court 1748, Son William ("my plantation"), daughters: Ann Hill & Celia Phillips. Wife & Executor: Ann. Witnesses: John Simpson, Jacob Little & Francis DeLoath. Clerk of Court: I. Edwards. (Note by R. Hill: The wife of this William Hill seems to have been Ann DeLoach). He was the brother to Robert Hill 3/ of Halifax Co., N.C., both sons of Sion Hill Sr. 2/ & Elizabeth Spiltimber.

Comments to above by Robert Hill: This was William Hill 3/, son of Sion Hill Sr 2/ & wife Elizabeth Spiltimber of Surry Co., Va. He was brother to Robert Hill 3/ (m. Tabitha) who went into Halifax Co., NC

Page 165, William Hill, Chowan Co., Will dated 10th March 1750-51, proved in April Court 1751, Grandsons: Aaron & Robert Hill. Sons: William Hill, Aaron Hill. Executors: Son Aaron Hill & Son In Law, Thomas Nicholson. Daughters: Rachel Hill, Sarah Barrow, wife of Joseph Barrow. Witnesses: James Griffin, Jethro Rabey & Ann Peters. Clerk of Court, James Craven.

Page 171, Ann Hill witnessed the will of William Horn (no

county given) on 10th September 1753. No probate date listed.

Page 178, John Hill, witnessed will of Robert Hunter, Bertie Co., dated 20th May 1741, proved 29th October 1741.

Page 196, Henry Hill, was a legatee in the will of Thomas Jones, Bertie Co., in 1754. "Pettyshore in Bertie Co."

Page 198, Thomas Hill was appointed arbitrator to divide the land of William Jones, deceased, Beaufort Co., dated 28th April 1740, proved 1st September 1742.

Page 204, John Hill, witnessed will of Michael King, Bertie Co., dated 20th May 1741, proved 29th October 1741.

Page 207, Abraham Hill, was Executor of the Estate of Christian Lane, Edgecombe Co., (Will) dated 3rd October 1747, proved in May Court 1748. Witness: Sarah Hill. Legatee Christian Hill.

Page 207-307 ??, Harmon Hill, witnessed will of Churchill Reading, Bath Co., dated 19th September 1734, proved 14th February 1734.

Page 209, John Hill, was executor of the estate of Samuel Lawson, Craven Co., dated 24th April 1758, proved 31st May 1759.

Page 217, Francis Hill, witnessed the will of William Linton, Bath County, dated 12th January 1725, proved 20th June 1727.

Page 219, John Hill, was a witness of Joseph Lockley, Beaufort Co., dated 30th January 1746, proved in March Court 1746.

Page 234, Captain John Hill, of Bertie Co., was executor of the will of John McKinzie of Nansemond Co., Va. dated 2nd March 1754, proved in April Court 1754.

Page 249, Thomas Hill, witnessed will of Jonathan Milton, Onslow Co., dated 18th January 1758, proved in April Court 1758.

Page 253, Elizabeth Hill, was a legatee in the will of Mary Moore, Perquimans County, dated 24th March 1756, proved in April Court 1756. She also Witnessed the will.

Page 263, William Hill, witnessed will of Gabriel Newby (no county given) dated 26th March 1733, proved 1st March 1735.

Page 276, William Hill, witnessed will of John Paine, New Hanover Co., dated 9th January 1767, proved 14th March 1767. (Wilmington).

Page 288, John Hill, witnessed will of Richard Pickerin, Bertie Co., dated 25th January 1739, proved in February Court 1739.

Page 291, Isaac Hill, was executor of will of John Plowman, Chowan Co., dated 1st July 1721, proved 4th August 1721.

Page 299, Will of William Power, Chowan Precinct, dated 26th November 1747, proved 11th April 1748, mentions his "friend & executor, Benjamin Hill.

Page 306, Isaac Hill, witnessed the will of John Rasbuary, of Bertie Co., on 11th September 1749, proved February Court 1749.

Page 306, Nathaniel Hill, Executor of the Will & Estate of Samuel Ratliff, Will dated 31st February, proved 11th July 1733.

Page 306, Benjamin Hill, was a legatee in the will of William Smith, of Chowan Co., dated 30th March 1743, proved in July Court 1743.

Page 306, Henry Hill, a legatee in the will of Benjamin Rawlings, dated 10th December 1737, proved in February Court 1738 in Edgecombe Precinct.

Page 309, John Hill, was witness to will of Peter Reell, Craven Co., dated 19th November 1739, proved 24th November 1739.

Page 321, Abram Hill witnessed the will of Moses Rountree, Perquimans Co., dated 21st July 1755, proved in October Court 1755.

Page 322, Aaron Hill, was executor of the estate of Thomas Rountree, Chowan Co., Will dated 6th August 1747, proved 15th January 1774.

Page 323? (blurred) John Hill, executor of will of David Ryan, Bertie Co., dated 9th November 1762, proved 13th November 1762.

Page 340, Harmon Hill, witnessed will of Alexander Simpson, "Late of the Parish of Kennowey in the shire of Fife in that part of Great Britain called Scotland." dated 29th November 1737, proved 9th June 1738.

Page 357, Will of Lott Stallings, Chowan Co., dated 5th November 1749, proved 31st January 1749, Son in law, Isaac Hill ("land adjoining Thomas Newby.") & grand-daughter Sarah Hill.

Page 373, Will of Jacob Ternell (no county given), dated 18th

December 1711, proved 1st July 1713, "Little River" mentions
cousin Rouger (Roger?) Hill ("my land in Kakomak."

WILL BOOK ONE, 1759-1792.

Will 13, Page 20, HARMON HILL -January 1772, (proved) March
Court 1777...to my son HENRY HILL and my daughter FANNY HILL
(each) Negroes etc... son HARMON HILL Negroes, Still, and
the lands and plantation whereon I now live. Daughters JEAN
HILL, MARTHA LEWIS, BETTA WEBB, NELLIE HART and SARAH SWEET,
5 shillings each, 5 shillings also to MARTHA WARDIN and
HARMON TARVER (?), to wife ELIZABETH HILL use and benifit of
Negroes and residue of my estate while HENRY HILL comes of
age, residue of estate to be divided between my two sons
HENRY & HARMON (HILL) at wife's death.

Extrs: beloved wife ELIZABETH HILL & son HENRY HILL, THOMAS
HART.

Wits: HARDY (H his mark) HART, JANUS---(x his mark)

Note: Probate indicates HENRY HILL qualified as Executor.

Comment by R. Hill: I believe that the son of this Harmon
Hill, who's name was Henry Hill, was the father of a Green
Hill who's will was dated 17th January 1831 in Northampton
County, N.C. I do not think he was the son of Robert Hill 3/
and wife Tabitha as has been expressed by some.
