## THE MOSES HILL FAMILY OF CHOWAN COUNTY, N.C.

There is a record of a Moses Hill 2/ (born ca. 1680, and suspected to be a son of a Samuel Hill 1/, probably in Nansemond County, Va.) having moved from Nansemond County, Va. to Chowan County, N.C. ca. 1717 with a wife named Dorothy. He left a Will in Chowan County in 1745 naming

#### sons:

- 1. Moses Hill Jr. 3/, b. 1705/12, d. 1762-63, of Bertie County, N.C., left no sons.
- 2. Guy Hill 3/, b. 1710-17, d. 1775 of Chowan County. Sons:
  - a. Kadar Hill 4/, d. 1790 Gates County.
  - b. Guy Hill Jr. 4/, d. 1787 Gates County.
  - c. John Hill 4/, d. 1776 unmarried.
- 3. Isaac Hill 3/, b. after 1716. Sold land and left Bertie County in 1754.
- 4. Abraham Hill 3/, b. after 1716, died Gates Co.,
  - N.C. in 1786. Sons:
    - a. Moses Hill 4/, d. 1797 Gates Co., N.C., no sons.
    - b. Aaron Hill 4/.
    - c. Henry Hill 4/.
    - d. Mills Hill 4/.

There is a Will of a William Hill 2/, probably a brother of the above Moses Hill 2/, that was married to Mary Spivey & who died in Chowan County, N.C. ca. 1750/51. Sons:

- 1. Moses Hill 3/, d. 1750 Chowan County, N.C., wife named Jean, Sons:
  - a. Aaron Hill 4/.
  - b. Micajah Hill 4/.
- 2. William Hill 3/.
- 3. Aaron Hill 3/.

- 5. Mary Hill 3/m. Thomas Nicholson.
- 6. Rachel Hill 3/.

Note: Based on information from Hinshaw's Quaker Records, this William Hill 2/ was the son of Samuel Hill 1/, a Quaker, who immigrated to Virginia from Perquimans County, N.C. It is thought that he was the brother of Moses Hill 2/ (above), who was thought to have been born in Nansemond County, Virginia, and later moved to Chowan County, N.C. If William Hill 2/ was a brother of Moses Hill 2/, then Samuel Hill 1/ was naturally their father.

It is known that a Sheriff John Hill (not related), of Lower Norfolk County, Virginia, which is adjacent to Nansemond County, persecuted the Quakers & since Nansemond County is adjacent to Norfolk County, it is possible that Samuel Hill 1/ moved up from N.C. into the area of Nansemond-Norfolk Counties, Virginia.

Later, his sons and their families may have again moved southward back into N.C. to escape the persecution that was being waged by the above sheriff John Hill. (No evidence has been found to prove this theory).
